#### EXECUTIVE SUMMARY

This report informs Members of an application for the grant of a Premises Licence for Northern Light, Cross York Street . The Licensing Authority is under a duty to determine this application.

#### 1.0 PURPOSE OF REPORT

1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a Premises Licence in respect of Northern Light, Cross York Street, Leeds, LS2 7EE.

#### 2.0 HISTORY OF PREMISES

The premises had the benefit of a Premises Licence issued under the Licensing Act 2003. The company who held the premise licence became insolvent and were wound up in the High Court of Justice Chancery Division Companies Court on the 10<sup>th</sup> January 2007 under the provisions of the Insolvency Act 1986.

As no application was made to transfer the licence by the 18<sup>th</sup> January 2007, the Premises Licence is deemed to be revoked.

The hours of operation for this licence were:

11.00hrs to 06.00hrs every day for entertainment. 11.00hrs to 04.00hrs every day for the sale of alcohol. 24hrs a day for recorded music.

> An application for a new premises licence was submitted on the 29<sup>th</sup> January 2007.

Whilst awaiting the decision for grant of a premises licence, the premise has operated under the provisions of a Temporary Event Notice.

#### 3.0 THE APPLICATION

- 3.1 The applicant is Northern Light Bar Limited. The premises are located at Cross York Street, Leeds, LS2 7EE. The location and the proximity to neighbouring premises can be seen on the map provided, members attention is drawn to **Appendix A.**
