97 **White Paper Motion - Living Wage**

It was moved by Councillor Wakefield seconded by Councillor D Blackburn

This Council believes that it is vitally important to narrow the gap between rich and poor in this city. To achieve this end this council believes that all people should be paid a “living wage” which will provide ‘adequate income’ to ensure social inclusion for an individual and their family.

This Council also notes that the Welsh Assembly, the London Assembly and many businesses including KPMG have already agreed to pay their employees a living wage.

Therefore, this Council resolves:

1. That Leeds City Council should commit to achieving Living Wage employer status, by paying a living wage to all staff (permanent, temporary, and all staff who work for the council but aren't employed by it).
2. That the Chief Executive prepare a report to Executive Board which will:
 - Outline how Leeds can become a ‘Living Wage City’ where every worker earns a living wage.
 - Explain what the financial commitment would be for Leeds City Council to achieving this aim
