This Council is also concerned that the SHLAA will raise false aspirations and may be misinterpreted by some that all land contained can be potentially built upon. Therefore the SHLAA for Leeds must state that its contents will not determine land allocated for housing development or undermine the Council's pre-approved policies.

1.0 INTRODUCTION

1.1 This report advises Council of the receipt of a report from the Independent Remuneration Panel and asks Council to make a number of changes to the Members' Allowances Scheme.

2.0 BACKGROUND

- 2.1 Council is required to determine a Members' Allowances Scheme, having regard to recommendations from an Independent Remuneration Panel.
- 2.2 In determining or varying its Members' Allowances Scheme, Council may modify, accept or reject any such recommendations from the Independent Remuneration Panel as it considers appropriate.
- 2.3 Council is advised that the Independent Remuneration Panel published a report in July 2008, a copy of which is attached at appendix A.
- 2.4 The Administration has indicated that it would wish to recommend to Council the following response to the recommendations made by the Panel in its July report.
 - "That the recommendations of the Independent Remuneration Panel Report dated July 2008 be approved and adopted subject to the following amendment:

- (i) In recommendation a) of the Independent Remuneration Panel report add following the wording "the two non-parish council independent members of the Standards Committee should receive a co-optees' allowance of £2,310" the words "all of which will be effective from the beginning of the 2008-09 municipal year;"
- (ii) In recommendations b d of the Independent Remuneration Panel report add at the end of the current sentence the words "with effect from the beginning of the 2008-09 municipal year"

2.5 The effect of the amendment is that Council would adopt the following:

"That the recommendations of the Independent Remuneration Panel dated July 2008, as amended above, be approved and adopted as follows:

- a) The Chair of the Standards Committee should receive a co-optees' allowance of £6,929; the two non-parish council independent members of the Standards Committee should receive a co-optees' allowance of £2,310; all of which will be effective from the beginning of the 2008-09 municipal year; and the Panel should review the allowances in twelve months time.
- b) The Chair of the Corporate Governance and Audit Committee should receive a special responsibility allowance of £6,929 with effect from the beginning of the 2008-09 municipal year.
- c) A special responsibility allowance should no longer attach to the Chair of the Overview and Scrutiny Committee but that the number of special responsibility allowances paid to the Chairs of the Scrutiny Boards be increased from six to seven with effect from the beginning of the 2008-09 municipal year.
- d) The number of special responsibility allowances attaching to an opposition group with more than 10% of membership of the Council be increased from four to five with effect from the beginning of the 2008-09 municipal year.
- e) No change be made to the Special Responsibility Allowance attaching to the Chair of the Development Plans Panel.
- f) Payment of a residents' parking fee should be regarded as covered by the Basic Allowance.

3.0 FINANCIAL IMPLICATIONS

The net effect of these proposals will be an increase of £12,536 in Members Allowances at current rates.

4.0 RECOMMENDATIONS

- 4.1 Council is asked to approve amendments to the Members' Allowances Scheme as detailed in paragraphs 2.4 and 2.5 of this report.
- 4.2 Council is asked to authorise the Assistant Chief Executive (Corporate Governance) to make any consequential changes to the Members' Allowances Scheme.

LEEDS CITY COUNCIL

Report of Panel on Members' Allowances

July 2008

Introduction

- 1. The Independent Panel on Members' Allowances was appointed by the Council to make recommendations on Members' Allowances in accordance with the relevant Regulations and the Government's statutory guidance. Until Spring 2008 the Panel comprised Sir Rodney Brooke CBE DL (Chair), Trevor Nuttall, Carolyn Stephenson (now Lord) and Gordon Tollefson. The term of office of Trevor Nuttall, a member of the original Panel, has come to an end and the remaining members of the Panel would like to express their appreciation of the participation of Mr Nuttall in the Panel's work. In his place the Council (after open advertisement and a competitive process) has appointed Mr Matthew Knight, Head of Human Relations at Leeds University.
- 2. The Panel issued its first report in May 1999. It updated its recommendations in October 2002 following new Government guidance. The Council adopted those recommendations with modifications. In subsequent reports the Panel has made further recommendations which again have been accepted, in some cases with modifications. A number of issues have now been referred to the Panel. They are set out below.

STANDARDS COMMITTEE

- 3. The Standards Committee has an independent chair and includes in its membership two further independent members (as well as two parish council independent members). Its chair currently receives a special responsibility allowance of £4,828 and the four independent members a co-optees' allowance of £557.
- 4. From 8 May 2008 local Standards Committees have been required to assume responsibility for the initial assessment of complaints

about councillors and determine whether such complaints should be investigated. This function was previously dealt with by the Standards Board for England. The local Standards Committee must now therefore:

- 1. review such complaints and determine if any should be investigated;
- 2. decide any appeals where a decision not to refer for investigation has been made; and, as now,
- 3. conduct hearings in appropriate cases;
- 5. Stages 1 and 2 must be dealt with by a sub committee drawn from the Standards Committee. Each of these sub committees must be chaired by an independent member who has not chaired an earlier stage of the same complaint. The Standards Committee has had to put in place appropriate procedures for the responsibility and members have undertaken appropriate training. While it is too soon to draw conclusions, it seems possible that the workload could be substantial.
- 6. The Panel fully accepts that the new responsibilities justify an increase in the allowances paid to the three independent members of the Standards Committee. Until a view can be established of the long-term workload, the Panel believes that for the Chair an allowance analogous to that of the Chair of the Licensing Committee would be appropriate. Given their new responsibilities for chairing stages of the complaint, the Panel believes that the two non-parish council independent members should receive 33% of the allowance paid to the chair of the Committee. Accordingly the Panel recommends that the Chair of the Standards Committee should receive a co-optees' allowance of £6,929; the two non-parish council independent members of the Standards Committee should receive a co-optees' allowance of £2,310; and the Panel should review the allowances in twelve months time when a better view can be formed of the long-term workload.

CHAIR OF CORPORATE GOVERNANCE AND AUDIT COMMITTEE

7. The Corporate Governance and Audit Committee has the major task of acting as the council's formal Audit Committee as well as its formal decision-taking body on issues of corporate governance. The formal audit requirements impose considerable responsibility on the Committee. After consideration, we believe that these justify a higher special responsibility allowance for the Chair of the Committee. Having regard to other comparators, such as the allowance paid to the Chair of the Licensing Committee, we recommend that the Chair of the Corporate Governance and Audit Committee should receive a special responsibility allowance of £6,929.

CHAIRS OF SCRUTINY BOARDS

8. The introduction into local authority management of the Cabinet system has greatly increased the need for scrutiny, a process to which the Government properly attaches considerable importance. The scrutiny function is the way in which councillors not participating in the Executive can question the decisions of that body and contribute to policy formation and review. During 2007-08 the council had six Scrutiny Boards and one Overview and Scrutiny Committee. The workloads and levels of responsibility of the seven bodies were considered to be equal and they attracted the same special responsibility allowance (£19,311). For 2008-09 the Overview and Scrutiny Committee has been discontinued but the number of Scrutiny Boards has been increased by one. In effect a new Scrutiny Board has assumed the workload left by the former Overview and Scrutiny Committee. There is a clear justification for increasing to seven the number of special responsibility allowances payable to the Chairs of Scrutiny Boards and removing from the Members' Allowances Scheme the Chair of the Overview and Scrutiny Committee. Accordingly we recommend that a special responsibility allowance should no longer attach to the Chair of the Overview and Scrutiny Committee but that the number of special responsibility allowances paid to the Chairs of the Scrutiny Boards be increased from six to seven.

OPPOSITION GROUP OFFICE HOLDERS

9. The Members' Allowances Scheme makes provision for a Special Responsibility Allowance (£4,619) to be paid to four members of an Opposition Group with more than 10% of membership of the Council. The only group to meet this criterion is the principal opposition group, which is the largest group on the City Council, though not having portfolio responsibilities on the Council's Executive Board. The principal opposition group proposes to appoint five shadow spokespersons for, respectively, resources; skills and adult education; children's services; adult social care; and the local environment. The Panel is very conscious of the national advice that not more than half the members of a Council should receive a special responsibility allowance and appreciates that the Council is on the cusp of failing that test. Nevertheless, in the current political situation in Leeds, it believes that the request (which is accepted by the other Group Whips) is reasonable in order to allow the principal opposition group to function effectively as an opposition, a function vital to the democratic process. Accordingly the Panel recommends that the number of special responsibility allowances attaching to an opposition group with more than 10% of membership of the Council be increased from four to five.

CHAIR OF THE LOCAL DEVELOPMENT PLANS PANEL

10. In our report of June 2007 we considered the appropriate Special Responsibility Allowance which should attach to the Chair of the Development Plans Panel. We considered that a Special Responsibility Allowance of £4,378 would be appropriate. Updated for inflation, that figure is now £4,619. We have re-considered the amount of the Special Responsibility Allowance for this post but see no reason to change the amount allocated to it.

RESIDENTS' CAR PARKING PERMITS

11. The Basic Allowance, payable to all councillors, includes an element for travel and subsistence within the City. There is no doubt that this has greatly simplified administration both for councillors and officers and has been generally welcomed. However, in a number of central area wards in the City, street parking is restricted to residents who pay an annual fee of £50.

Councillors who have to visit constituents in those wards have asked that the Council reimburses the annual fee. The panel rejects this request. The inclusion of travel and subsistence within the Basic Allowance relies on councillors taking the rough with the smooth. Those in outlying wards may not have to pay a £50 parking fee, but they must incur greater travel costs because of the greater distance to the Civic Hall. The Panel accepts that it may not always be possible for councillors to visit constituents by public transport, but believe that they should regard the payment of a residents' parking fee as being covered by the Basic Allowance.

SUMMARY OF RECOMMENDATIONS

- (a) the Chair of the Standards Committee should receive a co-optees' allowance of £6,929; the two non-parish council independent members of the Standards Committee should receive a co-optees' allowance of £2,310; and the Panel should review the allowances in twelve months time.
 - (b) the Chair of the Corporate Governance and Audit Committee should receive a special responsibility allowance of £6,929.
 - (c) a special responsibility allowance should no longer attach to the Chair of the Overview and Scrutiny Committee but that the number of special responsibility allowances paid to the Chairs of the Scrutiny Boards be increased from six to seven.
 - (d) the number of special responsibility allowances attaching to an opposition group with more than 10% of membership of the Council be increased from four to five.
 - (e) No change be made to the Special Responsibility Allowance attaching to the Chair of the Development Plans Panel.

1.00 PURPOSE OF REPORT

To inform the Executive Board of a Key Decision taken under 'Special Urgency' provisions contained in the Constitution and to recommend the Board to forward this report to Council as the quarterly report on such decisions in accordance with paragraph 16.3 of the Access to Information Procedure Rules

2.00 BACKGROUND

- 2.01 The general requirement of the Council Constitution is that notice of Key Decisions will be given in the Forward Plan of Key Decisions. There is also provision for the five day notification of the intention to take a decision by general exception where it has not been entered on the Forward Plan.
- 2.02 Paragraph 16 of the Access to Information Procedure Rules allows for 'Special Urgency' and states: "If by virtue of the date by which a decision must be taken Rule 15 (general exception) cannot be followed, then the decision can only be taken if the decision taker (if an individual) or the chair of the body making the decision, obtains the agreement of the chair of a relevant Scrutiny Board that the taking of the decision cannot be reasonably deferred and the decision is urgent. If there is no chair of a relevant Scrutiny Board, or if the chair of the relevant Scrutiny Board is unable to act, then the agreement of the Lord Mayor of the Council, or in his/her absence the Deputy Lord Mayor will suffice"

- 2.03 Paragraph 16.3 of the Access to Information Procedure Rules requires that reports on special urgency decisions should be made in the following terms: "In any event, the leader will submit quarterly reports to the Council on the executive decisions taken in the circumstances set out in Rule 15 (special urgency) in the preceding three months. The report will include the number of decisions so taken and a summary of the matters in respect of which those decisions were taken"
- 2.04 The last decision taken under the special urgency provisions was in 2003 and in view of this the view was taken that the quarterly report requirement was superfluous until such time as such a decision might be taken.
- 2.05 The decision subject to the Special Urgency provisions relates to the invocation of a 6 months contract extension for the continuation of supported independent living services for vulnerable people with learning disabilities provided by UBU.
- 2.06 UBU are a well established provider of care and supported independent living in the North of England with services in Harrogate, York, Sheffield, Scarborough and Selby. They are currently contracted to provide 7 supported living services in Leeds for 27 people with a range of learning and physical disabilities to live in the community, as opposed to residential care. UBU are registered with CSCI (Commission for Social Care Inspectorate) as a domiciliary care provider.
- 2.07 The supported independent living services in Leeds are jointly funded through Supporting People Programme grant and Adult Social Care through the pooled learning disability budget. As a result the services are jointly contract managed by officers from both departments and the contract has been subject to quarterly performance reviews. The services are performing well and the quality of the services is good and continually improving against the Supporting People quality standards. The staff are well trained and the services are very enabling. An inspection by CSCI (Commission for Social Care Inspectorate) in August 2006 found that the services in Leeds were good and delivering very good outcomes for service users.
- 2.08 The Leeds Supporting People Commissioning Body agreed at its meeting in June to commission the UBU services for a further period of 18 months, when the extension to the existing contract expires in December 2008. Approval for the Council to enter into an 18 month contract will be sought through the Council's Delegated Decision process in August.

3.00 DECISION TAKEN

3.01 A decision has recently been taken under the special urgency provisions as follows:

The Director of Environment and Neighbourhoods approved the invocation of a 6 month contract extension to an existing Supporting People contract with an organisation called UBU. The contract is to provide accommodation and support services for vulnerable people with a learning disability.

The value of the six month extension is £350,000. The recent change in definition of a Key Decision and the new financial threshold means that the decision had just become Key. At the time of publication of the forward plan the decision was classified as Major. A decision of Council on 22nd May gave effect to the designation of the decision as Key and recording as such on the forward plan was not possible

- 3.02 The Chair of the Scrutiny Board (Environment and Neighbourhoods) agreed the urgency and the decision was taken on 6th June and recorded, following the receipt of full documentation, on 12th June 2008.
- 3.03 The provisions have been invoked because of a failure of the service to commence the process of initiating a contract extension in a timely way. Consequently, the Environment and Neighbourhoods Directorate have reviewed and revised existing procedures relating to such work, so that this error does not occur again. This has involved the development of a database holding detail of all Supporting People contracts, including contract expiry dates. This will enable contract lead officers to process contract extension requests more effectively in future.

4.00 RECOMMENDATION

4.01 That the Executive Board approve this report for submission to Council as the quarterly report in accordance with Access to Information Procedure Rule 16.3
