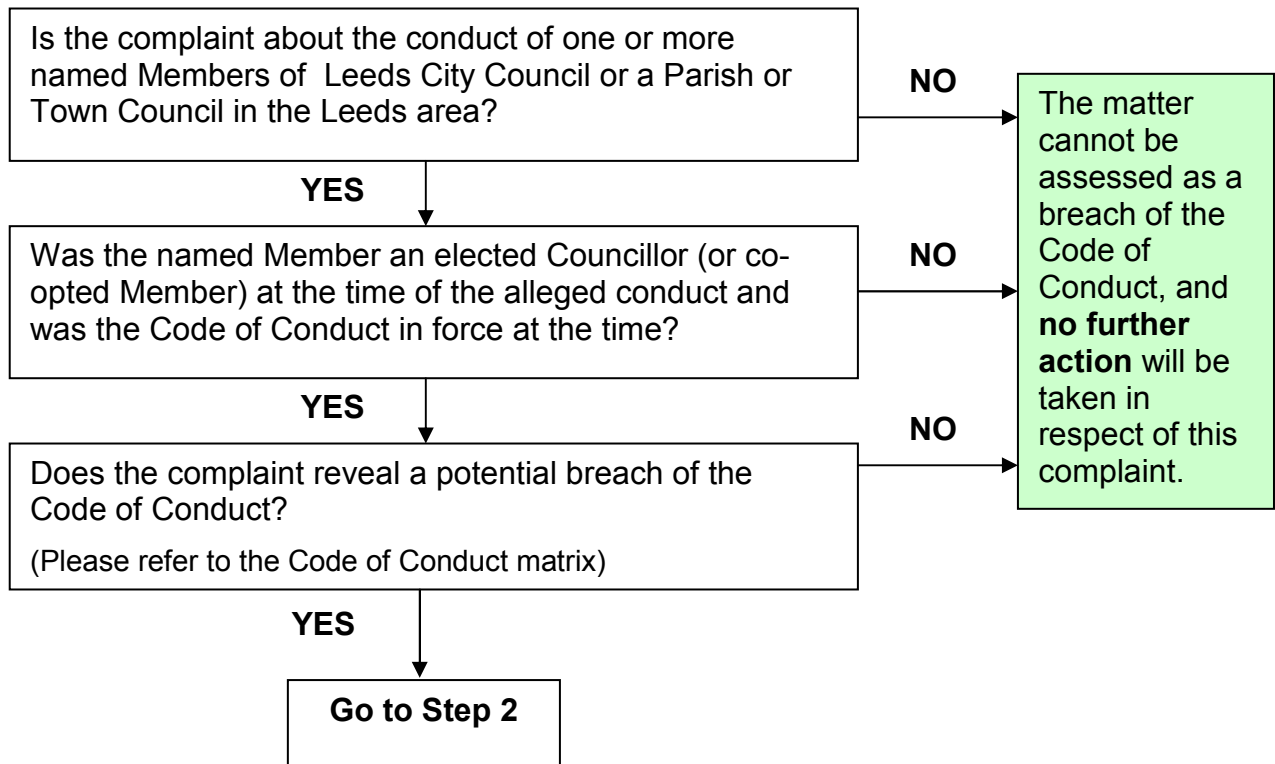

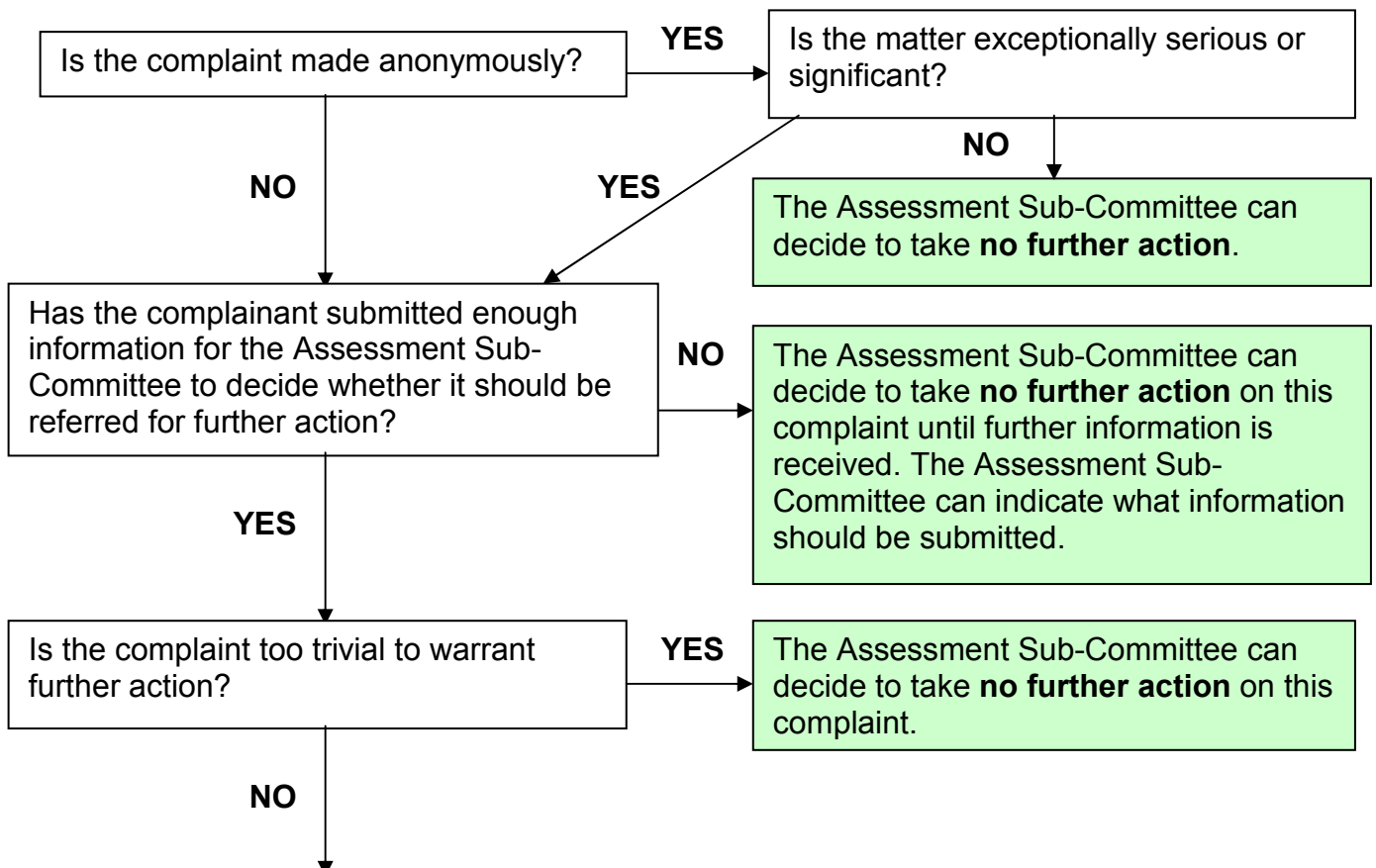

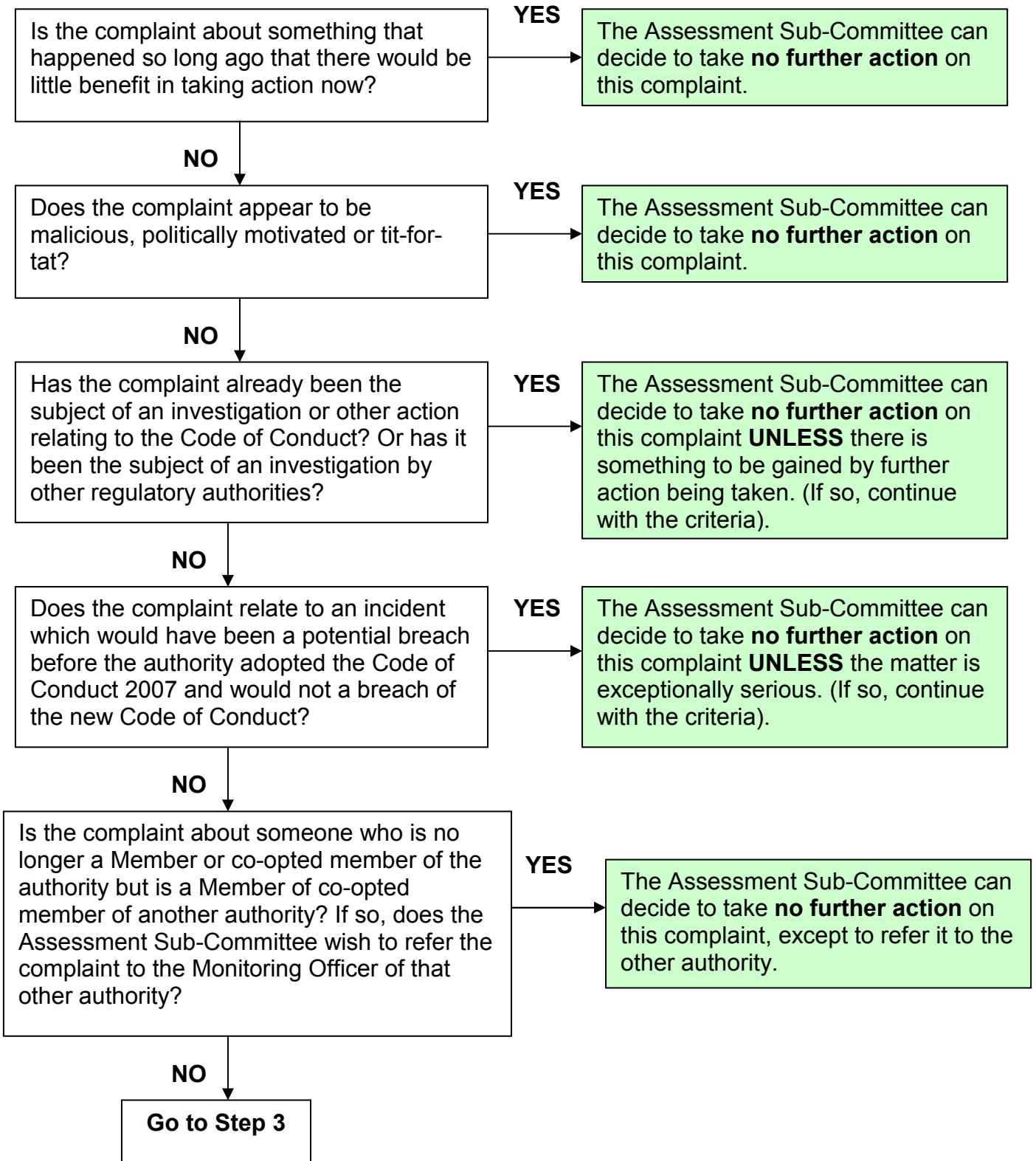
# Assessment Flowchart

## Step 1 - Initial Tests

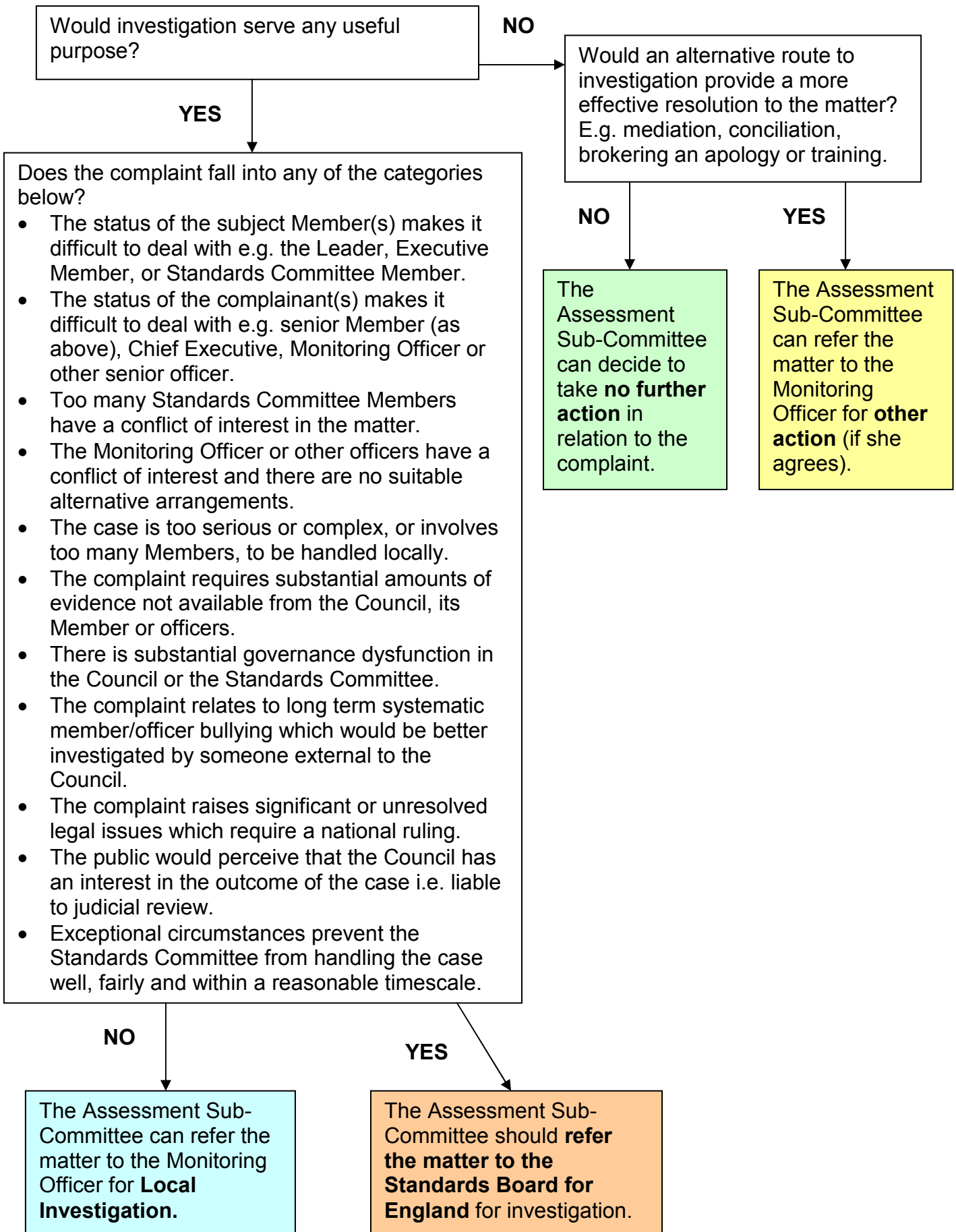


## Step 2 – Applying Assessment Criteria
