### 47 Chairs Opening Remarks

Councillor Armitage thanked all Members of the Committee for their hard work and support during the year and expressed her best wishes to all present for Christmas. The Chair reminded Members of the importance of attending the Member Learning Day sessions on Licensing and Governance and Conduct scheduled for January 2011

### 48 Declarations of Interest

There were no declarations of interest

### 49 Apologies for Absence

Apologies for absence were received from Councillors Dobson and Grayshon

### 50 Minutes

**RESOLVED** – That the minutes of the previous meeting held 16<sup>th</sup> November 2010 be agreed as a correct record

### 51 Proposed Designated Public Place Order (DPPO) Burmantofts

The Assistant Chief Executive (Corporate Governance) submitted a report setting out proposals for a Designated Public Places Order (DPPO) to be made to cover the Burmantofts area of East Leeds.

Mrs B Yearwood attended the meeting to provide the background to the proposals and the consultation process undertaken so far. Appendices 2 and 3 of the report detailed the boundary of the proposed DPPO area. Mrs Yearwood outlined the local community's concerns over alcohol related incidents of drunkenness and/or anti social behaviour which affected the area including the problems experienced around the Lincoln Green shops and Beckett Street and Harehills cemeteries.

It was noted that a review of recorded incidents throughout the Burmantofts & Richmond Hill area had been undertaken to assess the problems experienced across the ward; and the boundary of this proposed DPPO would abut the

adjacent Gipton & Harehills DPPO boundary as a result. Ward Councillors from both wards had been consulted on the proposals.

Inspector J Hawkes of WYP provided further detail on the particular hotspots for incidents and the types of alcohol related problems within the area. She stated that measures were already in place within the local community to spot and identify problems which included liaison with local shopkeepers and the Friends of Harehills Cemetery group; however these measures had not deterred people from congregating and consuming alcohol in those areas. Furthermore, local shopkeepers had been issued with direct telephone numbers for the Neighbourhood Policing Team. Those calls may have been responded to directly and those incidents may not appear within the statistics in the report.

It was noted that the Legal Notice advertising the description of the DPPO boundary at Appendix 2 had incorrectly referred to Cherry Row (not Cherry Road); however advice had been obtained that this would not prevent the implementation of the DPPO. Members noted that no objections to the proposed DPPO had been received during the consultation process and discussed the following

- The measures now in place to tackle the recent spate of vandalism at Harehills cemetery
- The source of alcohol whether it be local supermarkets, off-licences or public houses

Members considered the evidence before them and were satisfied that the statutory test had been met and that the implementation of a DPPO in this locality would provide a remedy to the problems outlined in the report

(Councillor Hanley joined the meeting at this point)

### **RESOLVED** -

- a) That approval be given for a Designated Public Places Order to be made in respect of the Burmantofts area as set out in Appendix 2 of the submitted report and detailed in the map attached at Appendix 3
- b) That the Director of Environment and Neighbourhoods be authorised to advertise the making of the Order, to procure the required signage and to carry out any further steps necessary to bring the Order into force

### 52 Sexual Entertainment Venues - Update

The minutes of the last Sexual Entertainment Venues Working Group meeting held on 26<sup>th</sup> November 2010 were submitted for information. The minutes provided an update on the proposed Statement of Licensing Policy for Sexual Entertainment Venues

### **Executive Summary**

The Taxi & Private Hire Licensing Section carries out statutory functions on behalf of the Council. It is guided and directed by a variety of policies, licensing conditions and Byelaws predominantly approved by the Council's Licensing Committee.

A full review is being undertaken of those policies, conditions and Byelaws and this report identifies the rolling program of review and the consultation process.

### 1.0 Purpose Of This Report

- 1.1 To identify to Members all the policies, conditions and Bye-laws relating to the Hackney Carriage and Private Hire trade considered necessary by the Council to fulfill its statutory functions under the Local Government (Miscellaneous Provisions) Act 1976.
- 1.2 To inform Members of the rolling program of review and consultation and how those matters reviewed will be brought to the Licensing Committee for consideration.

### 2.0 Background Information

- 2.1 This document at Appendix 1 identifies all of the Council's current conditions, policies and Byelaws and sets out the dates for initial consultation.
- 2.2 The Policies and Conditions have evolved since the Council adopted the Local Government (Miscellaneous Provisions) Act 1976 and it is a requirement that such policies are reviewed in appropriate time scales. The Byelaws have remained unchanged since being introduced in March 1975.

### 3.0 Main Issues

- 3.1 To meet its legal obligations the policies and conditions must be reviewed and consultation undertaken in a meaningful way with those people who may be affected.
- 3.2 The trade were initially informed of the review by email, where we hold an email address, on Friday 19 November 2010. In addition, the proposed program of review was published on the Council's website on the same date. The closing date for responses was Friday 19 December 2010 and the Section did not receive any feedback.
- 3.3 Additionally the process has been explained to the trades at forums with the following comments.

HACKNEY CARRIAGE:- A request that the period of initial consultation in respect of the vehicle conditions be extended by two months to enable vehicle manufacturers sufficient time to respond. This has been agreed to by the author of this report. The Hackney Carriage trade representatives undertook to consult with their members and provide feedback at each stage of the process.

PRIVATE HIRE OPERATORS: - There were no suggestions put forward at the Trade forum on 27 January 2011. Despite that, it is intended to post to Operators the policies, and conditions for consultation so that they can be placed in appropriate areas for drivers to view.

EXECUTIVE HIRE OPERATORS:- An initial concern was expressed that their policies and conditions were at the end of the consultation process and that they might be disadvantaged. Two areas of concern were raised and discussed and it was agreed that those two matters could be dealt with within the existing policy and conditions, thereby enabling the proposed program of review to remain as it is.

3.4 The program of review was placed on the Council's website for initial consultation for a two month period. Following this, the consultation feedback and the views of

Officers will lead to the preparation of revised documents, which will then be presented for further consultation. This will be for a period of up to 3 months and after this second consultation period an officer's final report will be prepared for the Licensing Committee to consider.

3.5 If the Licensing Committee agree to the timetable of review each of the issues will be consulted on in accordance with the timescale. Members should however note that the timescales for the presentation of reports to them may not be in the order that the consultation process has been undertaken because of different volumes of work potentially required. Also until the consultation has been completed it will not be possible to place the reviewed items on the licensing work plan.

### 4.0 Implications For Council Policy And Governance

4.1 Council policy in respect of this subject is mainly set by the Licensing Committee or in the case of administrative processes by Officers and changes to policy will be approved by the Licensing Committee in line with the Constitution.

### 5.0 Legal And Resource Implications

- 5.1 The Consultation process is a necessity and involves the key stages of information sharing in the first instance followed by consideration of objective feedback prior to the preparation of draft proposals which in turn will be further consulted on. Following this the final report will be submitted to Members for consideration.
- There are significant resource implications in terms of consultation background material research, document preparation and presentation to the Licensing Committee. There will be no additional resources to undertake this work and this significant process will have to be managed alongside other competing demands.
- 5.3 The program of documents has been grouped in a manner that enables Officers to deal with the issues in a more manageable way.

### 6.0 Conclusions

6.1 The work being undertaken is necessary and time consuming but it is an opportunity for genuine and constructive participation on the part of all those people who are affected by the policies, conditions and Byelaws to contribute to policies that reflect well on the city of Leeds and increase public safety.

### 7.0 Recommendations

7.1 That Members agree to the review timetable and return the program to Officers to undertake consultation and the preparation of final reports for the Licensing Committee.

### **Executive Summary**

The Gambling Act 2005 provided Leeds City Council with the opportunity to grant a Large Casino Premises Licence under a two stage process which will determine a licence on the greatest benefit to the City.

Officers are now starting the preliminary stages for this competition and are reporting to Licensing Committee on the next steps in the process.

### 1.0 Purpose Of This Report

1.1 This report is to inform the Licensing Committee of the progress of the Large Casino project and their delegated responsibilities during this process.

### 2.0 Background Information

- 2.1 The Gambling Act 2005 (the Act) changed the legislation governing the licensing of casinos significantly. Under the Act seventeen new casino licences were to be granted, each of which are to be significantly larger than existing casinos. The licences are broken down as follows: one regional casino, eight large casinos, and eight small casinos. The DCMS formed a special Casino Advisory Panel (CAP) to recommend where the new casinos should be located.
- 2.2 In April 2008 Parliament dropped the regional casino and approved the eight small and eight large casinos in line with the CAPs original recommendations. Leeds was awarded a large casino licence.

### 3.0 Main Issues

- 3.1 <u>Current Work</u> As previously advised officers from Development and Entertainment Licensing are working on the statement of principles and the application pack. The Project Board has authorized the appointment of external expertise to assist in developing the methodology for assessing Stage 2 applications. This provides expertise not available within the council.
- 3.2 The public consultation draft of the policy is due to be ready for external quality assurance by Counsel at the beginning of March. Once this assurance has been received, the policy will be brought to Licensing Committee for information in April 2011.
- 3.3 Public Consultation Once the public consultation documents are ready, officers will arrange a 12 week consultation. This will be advertised in libraries, one stop shops and leisure centres by way of a poster. A webpage will be created and a web form will be available for people to make comments online. A mail shot will be sent out to an extensive list of identified stakeholders. This will include existing licence holders, national trade associations, responsible authorities, organisations concerned with the social impact of gambling, ward members, MPs, parish councils, and faith groups to name just a few.
- 3.4 Timescales the current timescales being worked to are as follows:

April to June 2011 Public Consultation

November 2011 Adoption of policy by Council

December 2011 Advertise competition

Jan - April 12 Stage 1 process From May 12 Stage 2 process

3.5 <u>Training</u> – Full training for members will be given to provide Licensing Committee with background knowledge of the casino industry as well as specialist knowledge they will need to interpret the evaluation report provided by the Advisory Panel, and the Stage 2 bids received from the applicants.

### 4.0 Implications For Council Policy And Governance

4.1 The principles will need to be included in the Gambling Act 2005 Statement of Licensing Policy which will have to follow the normal approval process following the Budgetary and Policy Framework

### 5.0 Legal And Resource Implications

5.1 The contents of the application pack and the grant of the licence are Part 8 functions of the Act and are expressly a matter for the council's Licensing Committee, although the principles that the committee will use to inform its decision on greatest benefit will be contained within the council's statement of licensing policy subject to full Council approval.

### 6.0 Conclusions

The project is now proceeding, with the project board being formed and an Advisory Panel appointed in the near future.

### 7.0 Recommendations

7.1 That Licensing Committee note the contents of this report.

### **Executive Summary**

The Policing and Crime Act 2009 amends the Local Government (Miscellaneous Provisions) Act 1982 s2 and Sch 3 to introduce a new classification of sex establishment, namely sexual entertainment venues. Potentially, this brings to lap dancing, pole dancing and other "relevant entertainment" within a new licensing regime.

The Licensing Committee previously resolved to recommend adoption of the new powers to Council and set up a cross party working group to develop a policy and standard conditions.

This report updates members of the Licensing Committee about the progress the working group have made in developing a policy and standard conditions.

### 1.0 **Purpose Of This Report**

1.1 The purpose of this report is to provide an update to members of the Licensing Committee about the progress the working group have made in developing a policy and standard conditions

### 2.0 **Background Information**

- 2.2 On 22<sup>nd</sup> June 2010 Licensing and Regulatory Panel (now Licensing Committee) decided to recommend to Council to adopt the provisions of Sch 3 of the Local Government (Miscellaneous Provisions) Act 1982 as amended by the Policing and Crime Act 2009.
- 2.3 The Panel also decided to develop a policy and set of standard conditions relating to sexual establishments, in particular sexual entertainment venues, sex shops and sex cinemas.
- 2.4 The Panel formed a cross party Working Group to work with officers of Entertainment Licensing to develop the policy and conditions.

### 3.0 Main Issues

- In January 2011 the Council made a resolution to adopt the provisions of Sch 3 of 3.1 the Act. effective from 1st October.
- 3.2 The Working Group continues to meet monthly to progress development of the policy and conditions.
- 3.3 Since the last update to the Licensing Committee in November the working group have developed a first draft of the Policy.
- 3.4 The Working Group has met with existing lap dancing operators and their legal representative to pre-consult on the policy. This meeting was very productive.
- 3.5 The Working Group is arranging a site visit to a number of lap dancing establishments to gain understanding of the premises and the business to inform the next draft of the policy.
- 3.6 The Working Group is planning a review of the fee structure and to pre-consult with the sex shop operators and multi-agency partners prior to the public consultation.

### 4.0 Implications for Council Policy and Governance

- 4.1 This report is to advise members on the work undertaken to develop a policy, therefore any implications for Council Policy and governance will be identified and addressed during the presentation of the policy itself.
- 4.2 The development of a policy under the Local Government (Miscellaneous Provisions) Act 1982 is a responsibility delegated to the Licensing Committee under the Council's constitution.
- 4.3 After the public consultation, when the policy is ready for adoption it should be referred back to Council by Licensing Committee with a recommendation to adopt.

### 5.0 Legal and Resource Implications

- 5.1 Legal advice will be required to advise the council on the proposed policy.
- Once a policy has been developed the subsequent consultation is likely to attract a large number of responses, both from the trade, members of the public and interested action groups. This will have resource implications for Entertainment Licensing who will need to handle enquiries from the public and written responses to the consultation.
- 5.3 The transitional arrangements will also apply pressure on the council with a high number of representations expected for each of the applications.

### 6.0 Conclusions

- 6.1 The Government has provided local authorities with a way of controlling the number and location of lap dancing clubs in their area. It has also given the Council great latitude in deciding the policy relating to sex establishments in the Leeds area.
- 6.2 The Working Group formed by the Licensing Committee is currently developing a policy and standard conditions, and has sought advice from partners in relation to the contents of the policy.

### **EXECUTIVE SUMMARY**

This report informs Members of the outcome of an application to vary the Premises Licence for premises situated at Bramham Park, Bramham, Wetherby, Leeds, LS23 6ND trading as Leeds Festival.

The variation application was to increase the capacity of the site from 69,999 to 89,999.

The responsible authorities were served with copies of the application by the applicant. Ward Members were also notified of the application.

No adverse representations were received during the 28 day notice period and consequently the application was approved in accordance with the Licensing Act 2003.

### 1.0 Purpose of this Report

- 1.1 This report informs Members of the outcome of an application made under section 34 of the Licensing Act 2003 ("the Act") to vary a Premises Licence in respect of the above mentioned premises.
- 2.0 The Application
- 2.1 The application was to increase the capacity of the site from 69,999 to 89,999.
- 2.2 The applicant proposed that the increase be implemented at 5,000 a year subject to annual agreement from the relevant responsible authorities and the Licensing Authority. Any alterations to the infrastructure of the site, including on site facilities, management

- arrangements and the traffic management plan to accommodate the additional capacity will be detailed in the Event Management Plan.
- 2.3 The prospect of the additional capacity as applied for was discussed with all of the relevant responsible authorities prior to the submission of the application. None of the responsible authorities had any reservations concerning the proposal, provided that the Event Management Plan was addressed accordingly to take account of the additional capacity.
- 2.4 The application was made by Mr. Melvin Benn on the 13 December 2010. Notice of the application was advertised in the local press and blue notices were displayed at prime locations around the site.
- 2.5 No adverse representations were received from the responsible authorities or interested parties during the formal 28 day consultation period, which ended on the 10 January 2011.
- 2.6 Given the absence of representations, the Licensing Authority was obliged to approve the application in accordance with the Licensing Act 2003.

### 3.0 FUTURE ARRANGEMENTS

- The additional 5,000 capacity increase for 2011 will be addressed in the Event Management Plan and discussed in further detail at the Multi Agency meeting scheduled to be held on the 28 February 2011. The matter will then be reported back to the Members of the Licensing Committee at their meeting on the 17 May 2011.
- The multi-agency forum will continue to liaise on a regular basis and a report will be brought back to the Licensing Committee prior to the August Bank Holiday event.
- Following the 2011 event a de-brief meeting of the multi-agency forum will take place, and a report of that meeting will be brought back to the Licensing Committee in December 2011. It is proposed that at this stage Members will be advised whether the responsible authorities are comfortable with the additional 5,000 increase for 2012.
