Domestic Violence Discussion Report







Domestic violence and abuse is a significant issue across Leeds impacting on the lives of individuals, families and children. In the Inner West area Armley, Bramley and Kirkstall all feature as areas that have higher levels of domestic violence than the city wide average.

It affects communities regardless of geography, relative affluence and ethnicity. It is a factor behind a high proportion of children, especially those under 5, being taken into care. Recognising the significance of this issue, Leeds City Council has made Domestic Violence and Abuse one of its Breakthrough Projects in the Best Council Plan for 2015 – 20.

The aim of this Community Committee is to raise the profile and peoples knowledge about domestic violence and provide information on how more support can be found.

Citywide Data and Intelligence

In the 12 months to the end of June 2014, there were **14,128** incidents of domestic violence and abuse reported to the Police in Leeds, an increase of 858 on the previous 12 period. month It is recognised that domestic violence and abuse is underreported to the and other agencies. police therefore the actual number of incidents is estimated to be higher.



When domestic violence is reported to agencies in Leeds the majority of victims are female (79.5%).

Both victims and perpetrators of reported domestic violence and abuse are overwhelmingly white British However it is known there is under-reporting in some communities and the true picture is not known.

In 2012 there were **3,628** referrals to Children's Social Work service which related to domestic violence and abuse, which represented **31%** of the total number of referrals.

Nearly three quarters of children on the 'at risk' register live in households where domestic violence and abuse occurs.

Since April 2011 there have been **15** domestic violence homicides in Leeds, of which 11 have progressed to a Domestic Homicide Review.

Citywide ranking

Current Initiatives - City Wide

Safer Leeds Domestic Violence Team

This service provides a co-ordinating role in the city, organising a multi-agency training programme offering a range of courses to agencies and professionals. The team leads on delivering the city's statutory responsibility to carry out Domestic Homicide Reviews and is currently undertaking eight reviews. The team provides the Caring Dads service to men who are abusing in their families.

The team is funded to provide support for all NHS staff across the city, extensive work is undertaken with midwives, health visitors, A&E and GPs to implement good practice recommendations by the Department of Health and NICE.

Leeds Safeguarding Partnership

The Council's Executive Board gave approval in September 2014 to develop a new initiative in Leeds to address domestic violence and abuse called the Leeds Safeguarding Partnership. This will offer of a 'whole system' response including prevention, victim support, recovery and aftercare. It includes the following key elements:

- A multi-agency co-located team providing response to high and medium risk cases with crime;
- The development of a holistic approach to domestic violence and abuse from prevention to aftercare which sits within the domestic violence programme as a whole;
- To improve pathways for perpetrators to reduce reoffending.







Current Initiatives - City Wide

Improving the Outcome of Court Cases

The Crown Prosecution Services and West Yorkshire Police have been running a pilot in Leeds to try and decrease attrition in DV cases; this comprises of 2 key strands

- Monthly meetings between Police & CPS to scrutinise evidence and files for all DV cases going to the magistrates court and to try and find ways to reduce victim attrition.
- Bad character evidence: the Police are now routinely trying to gather bad character evidence by interview, listing history of Police call outs etc and the CPS is routinely making an early application to allow bad character evidence to be heard (again magistrates court).

This work has resulted in more early guilty pleas which means cases are dealt with more quickly and victims don't need to attend court. They now have a 70-80 % success rate in those cases that reach court.

Working with Perpetrators

A key aspect of the city's response to reducing incidents of domestic violence and the harm it causes is the work with perpetrators. Research indicates that men are much more likely to engage with services to address their abusive behaviours if they think it will benefit their relationships with their children.

The <u>Caring Dads</u> programme is an approach to addressing men's abusive behaviours within families. The aim overall is for men to be better fathers and, in so doing, better partners.

The <u>Drug Intervention Programme</u> (DIP) aims to reduce the offending behaviour of those suffering from substance misuse. Traditionally the programme has been targeted at Class-A drug users engaged in burglary, however plans are being developed to broaden this to include alcohol abuse.

Current Initiatives - City Wide

Front Door Safeguarding Hub

Tackling Domestic Violence and abuse is one of Leeds City Councils seven breakthrough Projects, and a key element of this is the development of the Front Door Safeguarding Hub. This is a new initiative to improve the safety and support for victims.

A daily partnership meeting is held before 9am where details of high risk cases reported to the Police are shared so that partners can check against their own information systems. Agencies then meet together at 10.30 to share information and agree clear plans of action relating to victims, perpetrators and children. Initial feedback from testing this process has been positive.

The Front Door Safeguarding Hub is currently prioritising high and medium risk cases reported to the Police. The intention is to expand this over time to develop a response to all reported incidents and include referrals from partner agencies.



Developing an Inner West Programme

Whilst the Front Door Safeguarding Hub is providing improved city wide partnership responses to high risk cases reported to the police, it has been identified that we now need to improve our responses to all other standard and medium cases and increase disclosures from individuals and communities that under report.

A proposal to develop a broad based community response in the Inner West is currently being considered by the WNW Area Leadership Team. The overall aim would be to reduce the extent and impact of domestic violence

Work would include:

- Developing a GP response in line with the GP DV pilot
- Improving **information sharing** and case working through developing locality based DV networking opportunities.
- Engaging private sector companies and employers
- Mapping of existing network and services
- Developing a locality based case discussion process for repeat cases or cases of concern to agencies.
- Undertaking training and capacity building in targeted local services.
- Undertaking community capacity building including developing mechanisms for peer support
- Piloting service interventions such as social prescribing and drop in sessions at the community hub and other community venues
- Developing targeted responses regarding drug and alcohol interventions
- Ensuring effective promotion of and referral to the Caring Dads programme/
 PACT and the new PCC perpetrator programme
- Developing opportunities to further engage and consult with local communities to develop targeted responses
- Raising awareness through targeted **marketing and advertising** in the community hub and other community venues such as GP surgeries.
- Developing engagement work with schools
- Effectively targeting **family support and interventions** through links with clusters, Families First and the Family Valued Innovation programme

- b) Approve the application process for the 2016/17 financial year
- c) Agree the Wellbeing fund priorities for 2016/17

Main issues

Current position

2. The Community Committee received a Wellbeing revenue allocation of £158,690. Including carry forward from 2014/15, the Committee had a total budget of £210,546 for 2015/16 which was split between the three wards as follows:

Armley: £80,220

Bramley & Stanningley: £67,269

Kirkstall: £63,062

- 3. Since March 2015, the Committee awarded grants totalling £182,510 to 37 projects following an open application round. The list of projects funded so far in 2015/16 is presented at Appendix 1.
- 4. Two projects approved in March were cancelled for operational reasons. These are the Burley student changeover patrols and the Bramley site based gardener. The funds allocated to the projects have been returned to the ward balances.

Wellbeing balances

5. The current Wellbeing balances available per ward for 2015/16 are as follows:

Deferred project

6. An application from Burley RUFC for £2,497 towards the cost of building a security fence was deferred at the March and June Committee meetings as Members were awaiting clarification on various aspects of the Kirkstall Forge development. It is understood that there continues to be a delay in confirming the details sought, and Members are asked whether they would like to take a decision on the application or defer until December.

Capital Wellbeing Balance

7. The Community Committee receives a Capital Receipts Incentive Scheme (CRIS) allocation. At the last Committee meeting, Members agreed to capitalise three revenue projects subject to approval by the capital finance team. £5,000 from each of the following grants is now being funded through the CRIS budget:

- Rodley Cricket Clubhouse build £5000
- Ley Lane CCTV (new fencing) £5000
- If I Had A Hammer HOPS (fencing to the rear of Hawksworth Wood Village Hall) -£5000
- 8. The balance of Inner West CRIS balance is currently £5,900.

Small grants and skips

9. There have been three small grants approved since the last meeting:

<u>Friday Night Project - PHAB Leeds - £83.11</u> Supporting a citywide club for people with disabilities

<u>West Leeds Junior Development Project – West Leeds Juniors - £250</u> Funding taster sessions in primary schools to encourage children to join the club

<u>Broadleas Bonanza – Housing Leeds - £500</u> Supporting the annual funday on Broadlea Hill

10. The balance of the small grants and skips budget at 12th August 2015 was £11,180.

Youth Activities Fund

- 11. The Inner West Community Committee had a Youth Activities Fund budget of £55,738 for 2015/16. Since April nine projects have been funded at a total cost of £33,732 and are listed at Appendix 2.
- 12. Initial feedback from the summer holiday projects has been extremely positive, with many activities fully booked. Mystery shoppers recruited through the engagement groups attended some sessions and other young people carried out more formal peer inspections of a variety of activities. Information from the inspections wasn't available at the time of publication but will be shared at the meeting or the Children and Young People's Sub Group on 14th September.
- 13. Since the last meeting, Kirkstall Members have allocated £1,716 towards a pilot youth project for the Woodbridges and Queenswood area delivered from the local cricket club supported by youth workers from the Cardigan Centre.
- 14. Following this approval, the Youth Activities Fund balances are as follows:

2016/17 Wellbeing Commissioning Round

- 15. Members are asked to approve the method by which Wellbeing grants are approved for 2016/17. In previous years, this has been done through an open application process synced with the Inner West and Outer West Community Committees.
- 16. Following discussions at the General Purposes Sub Group, Members recommended following the same process this year with applications invited between October and the beginning of January for approvals at the March Committee.
- 17. Members agreed that setting priorities for the funding would be a beneficial step, and the Community Committee is asked to consider the following proposed priorities and provide a final list for the application guidance notes
- 18. Proposed Inner West Wellbeing fund priorities
 - Addressing health inequalities
 - Community development & engagement
 - Children & young people
 - Achieving the priority neighbourhood action plans
 - Improving greenspaces and the local environment
 - Supporting town and district centres, jobs and economic enterprise
 - Supporting Community Committee workshop themes
- 19. The Area Support Team will consult with Members in ward groups before and during the process, bringing everyone together for a workshop to review all applications on Wednesday 10th February, 10am 12.30pm.
- 20. Members are asked to approve the process and indicate whether they would like to continue to split their Wellbeing allocation equally between wards as has been the preferred option for the last few years.

Corporate considerations

21. Consultation and engagement

Elected Members have been consulted on local priorities through the former Area Committee Business Plans. The 2015/16 commissioning round began with a communication to all Community Committee contacts and a press release.

Consultation with Young People will continue to identify potential projects and consult on applications for the Community Committee's Youth Activities Fund.

22. Equality and diversity / cohesion and integration

All Wellbeing funded projects are assessed in relation to equality, diversity, cohesion, and integration.

23. Resources and value for money

Aligning the distribution of Community Committee Wellbeing funding to local priorities will help to ensure that the maximum benefit can be achieved.

In order to meet the Area Committee's functions (see Council's Constitution Part 3, section 3C), funding is available via Well Being budgets.

24. Risk management

Risk implications are considered on all Wellbeing applications. Projects are assessed to ensure that applicants are able to deliver the intended benefits.

Conclusion

- 25. The Community Committee has invested its Wellbeing funding in a wide variety of projects within local communities from April 2015.
- 26. Early feedback indicates that the summer holiday projects funded through the Youth Activities Fund were a great success.

Community Committee Update Report

Purpose of report

- 1. This report updates the Community Committee on the work of the three sub groups of the Committee: General Purposes, Children and Young People and Environment.
- 2. This report updates the Committee on community events, local projects and partnership working that has taken place in the area since the last meeting.

Main issues

3. General Purpose Sub Group

The Inner West General Purposes Sub Group was held on 13th July. The meeting discussed the following issues:

Community Committee Themes:

Cllr Ritchie proposed that the March 2016 Committee should focus on social isolation across the Inner West. The meeting agreed this would be a useful and interesting theme.

Eastern European Community Work

Gill Hunter (Safer Leeds) and PC Sara Barrie outlined the partnership work to support new migrants from Eastern Europe access services and prevent exploitation. The main focus has been on engaging with families and working with the Roma community to increase attendance at school with a focus on the Armley area. The volunteer led POMOC advice service runs a weekly drop in at the Armley Hub. The volunteers are struggling to meet demand and are supporting clients with increasingly complex issues. Options are being investigated to support this project.

There was interest from across the three wards about new migrant populations and it was agreed that a paper from Migration Yorkshire be circulated. The Chair asked that the Committee be kept informed of the progress of this work.

Wellbeing Process for 2015/16

The Wellbeing process for 2015/16 was discussed and proposals for this are included in the Wellbeing report.

4. Children & Young People Sub Group

The Children & Young Peoples Sub Group met on 29th June and heard an update from providers on current youth activities and co-ordinated the summer holiday programme. Partners agreed to support a programme of peer inspections and mystery shopping by young people for the youth activity fund projects.

The youth engagement groups are running in Armley and Bramley, and it is hoped that the new provision on the Woodbridges in Kirkstall will recruit young people interested in participating in the area wide consultation group session planned for September.

5. Environment Sub Group

The Inner West Environment Sub Group met on the 4th September. A verbal update will be presented at the Committee.

6. Armley Forum - 21st July 2015

The forum continued to discuss approaches to combat street drinking and anti-social behaviour on Town Street, and a number of people came forward to provide evidence that will support the police's enforcement work.

A manager from Leeds City College attended to provide information on the closure of their Armley facility and plans to move some classes to other venues such as the library.

The local housing manager also attended to provide an update on new initiatives and continue the discussion from the Community Committee on tenant involvement and energy efficiency.

7. Bramley & Stanningley Forum - 30th July 2015

This meeting of the forum focused on Bramley Shopping Centre and upcoming health initiatives in the area. The following were discussed.

- A representative from Bramley Shopping Centre attended to talk through the planned changes at the centre. These include reconfiguring and resurfacing the main car park, updating the external appearance of existing units, the building of a new larger retail unit on the Lower Town Street edge of the main car park, and upgrades to the rear entrance of the centre. The proposals were well received by forum members.
- An officer from the Public Health team attended to talk about the proposals for a new Wellbeing Centre at Manor Park Surgery, and also about Best Start Bramley which is a new support service aimed at teenage parents.

8. Kirkstall Forum - 9th July 2015

The focus for this forum was on planning, development and Highways issues in central Kirkstall. The following key issues were discussed:

- It was recognised that there are a considerable number of development sites in the centre of Kirkstall. Updates were given on the major sites including Kirkstall Forge, Kirkstall Bridge Shopping Park (the old BHS site) Kirkstall District Centre and additional units at the Morrisons site along with George IV pub, the old Angels Halls of residence and Kirkstall Design Centre.
- Discussion was had on the significant Highways impact much of this development is likely to have. Andrew Hall, Chief Highways Officer, was asked about the volume of traffic in this area and around the Kirkstall gyratory and at what point it would be deemed as failing. He explained that the traffic, whilst often slow, did usually keep moving, and that the timings of the traffic lights were kept as tight as possible to allow this to happen.
- Neighbourhood Plan Cllr Illingworth provided an update on this and recognised that the whole process is very lengthy but that it would have significant long term benefits for the area.

9. Community Events

The Community Committee has supported a range of community events and activities for children and young people during the summer holidays.

Broadlea Bonanza

The fourth annual Broadlea fun day was held on Tuesday 18th August and was well attended despite the torrential rain. A range of partners were involved including Housing Leeds, Communities WNW, BARCA and the Police. Children and their families enjoyed donkey rides, circus skills, arts and crafts and a bouncy castle. Officers from the Communities Team West North West carried out a consultation and signed up fifteen

residents to a support programme to help them access the vacancies at the new shopping complex on Kirkstall Bridge. The event was funded by Housing Advisory Panel and a small grant from the Community Committee.

Breeze on Tour

Armley Park hosted the Breeze on Tour on Saturday 8th & Sunday 9th August and saw a great turn out thanks to the weather. There were a range of activities for 0 to 19 year olds, such as arts, crafts and multimedia workshops, sports activities, a performance tent and a large range of inflatables such as obstacle courses, rock climbers, challenge games and sporting inflatables as well as an under 5 play section. The activities were split in to 5 zones; Play, Sport, Challenge, Info, Art and Performance so there was something for everyone. The event was free to all 0 to 19 year olds and their families who had a Breezecard.

Mini Breeze

The Mini Breeze at Bramley Park was not hampered by wet weather and lots of local children enjoyed the activities. The event held on Queenswood Road in Kirkstall was a great success and warmly welcomed by local residents.

Charlie Cake Park

A range of activities for children and families has been run from the 'Playbox' at Charlie Cake Park in Armley including tile making, art classes and a music club as well as a weekly barbeque to bring the community together.

Minecraft

The 'Adventures in Minecraft' sessions at Armley, Bramley and Burley libraries were incredibly popular with young people who learnt about the game and tried programming techniques using Rasberry Pi computers funded by the Community Committee.

10. Hawksworth Wood Neighbourhood Improvement Board

The second meeting of the Board was held on Tuesday 11th August. A range of partners were in attendance at the meeting Chaired by Cllr Yeadon. Detailed discussions were held over the provision of activities for young people and it was agreed that all partners delivering activities for young people in the area should meet in September to map out provision and identify gaps. Discussions also took place on illegal money lending, hate crime and possible intergenerational work.

11. Community Led Local Development

Members may recall that in early 2014 they were briefed on a European funding initiative called Community Led Local Development (CLLD) which is part of the current ESIF programme. CLLD is not for general "community development" and its use is restricted to the development of the economy and to support people into employment. It cannot be used as "continuation funding" for existing projects or activities. Funding can come from both the ERDF and ESF funds within the programme. A number of Members subsequently attended early consultation meetings and other activities designed to help

consider what a local economic strategy would look like. There have, however, been significant delays at a national level in the published timetable; so although activity has continued at a local level to prepare for the eventual bidding process, these have mostly been confined to occasional meetings at a local level of people who indicated they wished to help frame the bid, and meetings of the city wide co-ordinating group which has "kept the pot boiling" by preparing the ground for the eventual implementation of CLLD bidding processes.

There are three proposed areas based on deprived communities in inner Leeds. Each will require a (separate) Local Action Group (LAG) which will be responsible for developing a Local Development Strategy and leading any resulting CLLD programme. A LAG is a partnership comprising the public, private and third sectors and must also have an Accountable Body, which may be the local authority, to manage/ oversee the expenditure in accordance with the ESIF regulations.

A CLLD area must have a population of between 10,000 and 150,000, falling within the top 20% most deprived LSOAs, and the programme area must form a cohesive geography. The programme must also have a minimum size of €3m public sector funding input, and there is an overall requirement for 50% matched funding for all activity.

The bidding process is expected to open at the beginning of September 2015, providing an opportunity for Leeds to apply for a 'preparatory stage' funding of up to £20k European funding, which must be equally matched by other funding, to identify and establish the local action group, the accountable body, refine the areas and produce a Local Development Strategy. By the end of November 2015, the preparatory bids will be submitted and it is anticipated that approvals for those areas which are invited to proceed to the next stage will be announced in January, with the actual final bid being developed over a six month period which will involve detailed local consultation. At this point in time, within the overarching criteria, no absolute commitments as to the exact geographical boundaries or activities to be delivered will be made. These decisions will be made as part of the process to create a local development strategy in 2016; and the earliest that we would expect to see any spend, should those later bids be accepted, with be Spring 2017.

Community Committees and individual Members will have the opportunity to fully participate in this development process if the preparatory bids are agreed at national level.

Corporate

- 12. **a. Consultation and engagement -** Local priorities were set through the Area Business Plan process.
- 13. **b. Equality and diversity / cohesion and integration -** The Business Planning process takes into account equality, diversity, cohesion and integration issues.

14. c. Council policies and city priorities - The themes in the Business Plan mirror the themes and priority outcomes at a city wide level and also reflect the delegated functions and priority advisory functions.

Conclusion

15. The work of the sub groups are essential in the delivery of the Community Committee priorities. The Communities Team continues to look at opportunities to develop projects and promote new ways of working to achieve the objectives outlined in the Business Plan.
