## **Executive Summary**

This report informs Members of an application for the review of a Premises Licence under Section 51 of the Licensing Act 2003, sought by in respect of , 48 & 50 Westgate, Otley, LS21 3AS, . The licensing authority is now under a duty to review the premises licence held by these premises.

## 1.0 **Purpose of this Report**

1.1 This report provides Members with the background and history to the making of the review application made by Leeds City Council Entertainment Licensing (Appendix A). The report sets out the relevant law when reviewing licences under the Licensing Act 2003 ("the Act"), and informs members of the options available to them when reviewing a premises licence.

## 2.0 Background Information

2.1 On the 1st February 2016, an application was received in the Licensing Office for the grant of a premises licence for the sale of late night refreshment up to 2 am on weekends. The application attracted representations from responsible authorities and other persons and a ward councilor and was scheduled for hearing before the Licensing Sub Committee where the decision was made to grant the licence, adding the agreed conditions and reducing the hours applied for to up to 00:30 on weekends. The licence was granted in March 2016.

Complaints from residents were received in May 2017, alleging that the premises were repeatedly exceeding their permitted hours up to 2 am on weekends.

Warning letters were sent to the premises and the licence holder's home address, the licence holder was advised that the premises would be monitored for compliance.

In July 2017, officers from Entertainment Licensing carried out a covert Test Purchase of hot food, this was 20 minutes after the last permitted sale of hot food. Warning letters were again sent to the Licence Holder at the shop and home address.

On the 5th November 2017, Police Officers attended a large disturbance outside the shop at 2 am, the officers reported that the shop was still open at that time, this is 90 minutes after the last permitted sale of hot food. A further warning letter was sent to the Licence Holder at the shop and his home address.

An enforcement officer visited the shop on 9th November 2017 and spoke to the Licence Holder. They discussed the recent incident and asked to view the CCTV system (conditions 1-3) on the premises licence. Mr Khan stated that he had not installed the CCTV system he had agreed to install at the Licensing Committee hearing on 29th March 2016. As a result, no footage was available to Police, to assist in identifying persons involved in the incident.

On the 15th November 2017, a Police Community Support Officer witnessed the shop operating at 00:40 hours, last sale permitted of hot food on that day was midnight.

On the 5th December 2017, Mr Khan rang Licensing advising that he had been unable to find anyone to install CCTV prior to Christmas. He was advised that he was continuing to breach CCTV conditions, he was also advised that police had witnessed breaches of hours on the 15th November 2017.

On the 12th December 2017, two x TEN (temporary event notice) applications were received from the licence holder. The first application was for the weekend before Christmas, the second was for the weekend before and including New Year's Day. As the first application was not received 10 working days before the date of the first TEN, it was classed as a Late TEN. A representation was received from West Yorkshire Police, this meant that the TEN had to be rejected and on 14th December 2017, a Counter Notice was issued to the Licence Holder.

The 2nd TEN for the weekend of New Year's Eve was also subject to a representation from West Yorkshire Police due to recent disorder at the premises and because the premises were still failing to comply with the conditions relating to CCTV.

As a result, Mr Khan emailed Licensing withdrawing this TEN. The email was received on 15th December 2017.

Entertainment Licensing were advised by West Yorkshire Police that the premises had exceeded their permitted hours and had chosen to disregard the Counter Notice on the 23rd and 24th December 2017.

Entertainment Licensing were advised by West Yorkshire Police that the premises had exceeded their hours up to 1:45 on New Year's Day, the normal hours for hot food being midnight on that day.

On 5th February 2018, the premises licence holder and his solicitor attended a meeting at Otley Police Station where Council and Police Licensing Officers advised Mr Khan of the breaches of his licence. The premises licence holder advised the meeting that he had installed the CCTV system.

On the 16th February 2018, an Enforcement Officer visited Best Kebab and requested to view the CCTV to check compliance with conditions 1-3 of the licence. The premises licence holder admitted that only the cameras were fitted and there was no hard drive or monitor to view footage.

The Licensing Authority did consider the option of prosecution via the Courts, however it was felt that due to the repeated breaches of licensed hours and conditions, a review was the preferred option with the recommendation to revoke the existing licence.

The review application was submitted on the 13th March 2018.

The decision notice is attached at **Appendix B**.

## 3.0 Premises Licence

- 3.1 The premises licence holder is Mr Sajid Khan.
- 3.2 A copy of the premises licence can be found at **Appendix C** of this report. In summary, the premises licence permits the following:

The provision of Late night refreshment

Sunday to Thursday - 23:00 to 00:00

Friday and Saturday - 23:00 to 00:30

There are no non-standard timings

## 5.0 Location

5.1 A map which identifies the location of the premises are attached at **Appendix D**.

## 6.0 Main Issues

6.1 The Licensing Authority is applying for the Review under the following Licensing Objectives:

## The prevention of crime and disorder

As well as the evidence of persistent breaches of the Licensing Act 2003, the evidence from Police of a large disorder at the premises in November indicates that operating later attracts persons who may be under the influence of alcohol. Evidence also produced that the premises has refused to provide the CCTV system that the licence holder agreed to install at the committee hearing in March 2016. As a result, this restricted the Police in investigating the disorder in November 2017, if

the CCTV system had been operating as per the conditions 1-3 on the licence, it would have assisted the Police and may have been a deterrent to persons who participate in acts of violence.

## The prevention of public nuisance

The Licensing Authority feels that any increase in the permitted hours for Late night refreshment would compromise the above objectives and subject properties in the area to nuisance over an extended period. The premises licence holder's inability to comply with the permitted hours on the existing licence is unlikely to result in them complying with the proposed extended hours.

## 7.0 Relevant Representations/Letters of Support

- 7.1 Under the Act representations/support can be received from responsible authorities and or other persons. Representations must be relevant and, in the case of other people, must not be frivolous or vexatious.
- 7.2 A letter in support of the review application has been received from the Ward Councillor. Member's attention is drawn to the background papers provided.

## 8.0 Matters Relevant to the Application

- 8.1 Members of the Licensing Sub Committee must make decisions which are appropriate to the promotion of the licensing objectives which are:
  - the prevention of crime and disorder;
  - public safety;
  - the prevention of public nuisance; and
  - the protection of children from harm.
- 8.2 In making their decision Members are obliged to have regard to guidance issued under Section 182 of the Act. A copy of the relevant section is attached at **Appendix E**. Members must also have regard to the Council's licensing policy, the relevant representations made and evidence they hear.

## 9.0 Implications for Council Policy and Government

9.1 It is the stated licensing policy of the Council that when considering a review the authority will take into account all relevant circumstances, but will view the matters listed in paragraph 13.15 of the policy with particular seriousness.

## 10.0 Legal and Resource Implications

- 10.1 There are no resource implications in determining the review.
- 10.2 The Act provides the right to appeal on any decision reached on review. The right of appeal is to the Magistrate's Court.

## 11.0 Recommendations

11.1 Members are requested to determine this review. The Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- to modify the conditions of the licence (which includes adding new conditions or any alteration or omission of an existing condition);
- exclude any licensable activities to which the application relates;
- to suspend the licence for a period not exceeding 3 months; and/or
- to revoke the licence.
- 11.2 Members may decide that no action is necessary and that the circumstance of the review does not require the Committee to take any steps to promote the licensing objectives.
- 11.3 Members should note the guidance also suggests it is open to Members to issue an informal warning to the licence holder or to recommend improvement within a particular time. However the Guidance further provides that where responsible authorities have already issued such warnings, the issuing of another warning should not be repeated.
- 11.4 Where the Committee decide that a modification of conditions or exclusion of licensable activities may be imposed, this can either be permanently or for a temporary period of up to three months.
- 11.5 Members are directed to paragraphs 11.25 to 11.31 of the Statutory Guidance which related to reviews arising in connection with crime.
- 11.6 Members of the Licensing Committee are asked to note that they may not take any of the steps outlined above merely because they consider it desirable to do so. It must be appropriate for the promotion of the licensing objectives.

Complaints from residents were received in May 2017 alleging that the premises was repeatedly exceeding their permitted hours up to 2am on weekends

Warning Letters were sent to the Premises and the Licence Holders home address the Licence Holder was advised the premises would be monitored for compliance

We believe that the premises has continually breached the permitted hours on the licence and that it has left us with no other option than to Review the Premises Licence

Since the 24<sup>th</sup> November 2005 the provision of late night refreshment between the hours of 11pm and 5am is a licensable activity under the Licensing Act 2003 This means that a premises carrying out a licensable activity requires a Premises Licence or Temporary Event Notice (T E N) authorising it

As part of my duties I am responsible for licensing compliance and enforcement activities in the LS21 postcode area

In May 2017 a complaint (complaint number GE/002714 refers) was received by Leeds City Council Entertainment Licensing The allegation was that Best Kebab of 48 – 50 Westgate, Otley LS21 3AS was operating beyond the permitted times of their premises licence The premises currently benefit from a Premises Licence, premises licence number PREM/03724 refers, authorising the provision of late night refreshment from 11 00 pm to 12 midnight, Sunday to Thursday and 11 00 pm to 00 30 am on Fridays and Saturdays

The holder of the Premises Licence, Mr Sajid Khan of 3 Boynton Street, Bradford BD5 7BS made an application in February 2016 for a Premises Licence for 48 – 50 Westgate Otley A copy of that application form I produce as my Exhibit MW1 There were a number of representations made against the application from members of the public, Councillors and Responsible Authorities—As required by the Licensing Authority a hearing of the Licensing Signed

Sub-committee was held on the 29<sup>th</sup> March 2016 After hearing submissions from the applicant, Mr Khan and hearing the representations against the application the Licensing Sub-committee made its decision. A copy of the decision letter I produce as my exhibit MW2. The Licensing Sub-committee resolved to grant the application with amended hours and with the conditions requested by the Police including the provision of a Closed-Circuit Television System (CCTV) and conditions regarding noise requested by Leeds City Council's Environmental Health Service.

A Premises Licence (Premises Licence number PREM/03724/001 refers) was then issued from 29<sup>th</sup> March 2016 A copy of the licence issued I produce as my Exhibit MW3

Following receipt of the complaint on 8<sup>th</sup> May 2017 alleging the premises were open and serving customers after 2am, I issued a warning letter to the premises addressed to the Premises Licence Holder 1 produce a copy of the warning letter as my Exhibit MW4. The warning letter (exhibit MW4) sent on 8<sup>th</sup> May 2017 advised Mr Khan that the premises would be monitored for compliance and included a reminder about the current permitted hours and days for the provision of late night refreshment.

On Sunday, 2<sup>nd</sup> July 2017 my colleague - a Senior Liaison & Enforcement Officer, undertook a covert test purchase at Best Kebab, Otley to check compliance of the Licensing Act The officer ordered and paid for hot food and was provided their hot food order at 00 50 hours, some 20 minutes after the last permitted sale of hot food The licence also states that the premises will be closed at 00 30 hours Following being advised of that breach of licence I prepared a further warning letter dated 5<sup>th</sup> July 2017 which was addressed to the Premises Licence Holder A copy of the letter I produce as my exhibit MW5

On the 19<sup>th</sup> July 2017 I received a further complaint from a member of the public (complaint number GE/002743 refers) The complainant alleged that the premises were operating up to 0230 am on weekends which resulted in noise from customers and vehicles using the shop affecting their sleep. Shortly after receipt of the complaint I prepared a further warning letter dated 21<sup>st</sup> July 2017 A copy of the letter I produce as my exhibit MW6

On Monday, 6<sup>th</sup> November 2017 my office was contacted by Police officers from Otley Police Station who advised that they had to deal with a large disturbance outside Bestarian

Kebab, Otley at 2am on 5<sup>th</sup> November 2017 They enquired whether the shop was licensed to be operating at that time As a result of this information I then prepared a warning letter addressed to the Premises Licence Holder which I produce as my exhibit MW7

I regarded the incident on 5<sup>th</sup> November 2017 as serious and needed to speak to the Premises Licence Holder, Sajid Khan On the 9<sup>th</sup> November 2017 I visited the Otley area and waited until Best Kebab opened I introduced myself to Sajid Khan as he arrived and we went inside the shop together to discuss the issue I gave Mr Khan a copy of my letter (exhibit MW7 refers) and explained the reason for my visit - 2 x complaints, a positive test purchase and an incident at 2am when the premises were still open and providing unauthorised late night refreshment. I asked to view the CCTV which is conditions 1-3 on the Premises Licence Mr Khan stated that the CCTV system had not been installed. He was advised that it was a serious breach of his licence. The shop was granted a licence on condition of a CCTV system being installed and had been operating in breach since March 2016.

The reason for this decision is as follows

The Licensing Sub-Committee considered an application for the grant of a Premises Licence made by Mr Sajid Khan for Best Kebab, 48 & 50 Westgate, Otley LS21 3AS The applicant had applied for late night refreshment from 23 00 to 01 00 am Sunday to Thursday and 23 00 pm to 2 00 am Friday and Saturday

Ms Cat Sanderson of West Yorkshire Police and Councillor Campbell attended the hearing to comment further upon their representations

At the outset of the hearing it was clarified to the Licensing Sub-Committee that the applicant had agreed measures with the Environmental Protection Team and a letter showing the agreement to the conditions sought by the EPT was circulated to all parties. The applicant had agreed to the measures listed and as such the agreed operating times were now as follows

- Sunday to Thursday 11 00 pm to midnight
- Friday and Saturday 11 00 pm to 12 30 am

Mr Khan stated he wanted his business to be open for longer so that he could take advantage of the later opening hours of pubs and clubs in Otley It would give him a bit more time and would help him run the business

Ms Sanderson of West Yorkshire Police stated that she had only become aware on the date of the hearing that the operating hours had been reduced. However, she maintained that CCTV was still required at the premises to prevent crime and disorder and protect against public nuisance. She noted that whilst the premises were not selling alcohol. CCTV would benefit both the premises and the owner.

Councillor Campbell stated that he was concerned that the location of the premises would add to public nuisance The premises were close to residential areas He acknowledged and supported the Police in their view that CCTV would be required, as he knew the applicant had operated previous premises on Kirkgate where a number of issues had arisen. He conceded, however, that that was a different site. Councillor Campbell said that if the applicant was prepared to agree the conditions sought by the Police and Planning Authority he would withdraw his objection. West Yorkshire Police also informed the Licensing Sub-Committee that if the applicant agreed to CCTV at the premises, they too would withdraw their objection.

The Applicant agreed to install CCTV as requested

### DECISION

The Licensing Sub-Committee considered the application and having heard from the applicant and those presenting representations the Committee resolved to grant the application on the basis of the reduced hours. The licence is to be conditioned in accordance with the additional measures proposed in relation to CCTV as set out at page 124 of the report and also those additional conditions relating to noise and vibration. Litter and transport and pedestrian movement as set out on pages 124 & 125 of the report. For the avoidance of any doubt, the operating hours for late night refreshment would be 11.00 pm to midnight Sunday to Thursday and 11.00 pm to 12.30 am Friday and Saturday.

### **General**

In these notes a person who gives a temporary event notice is called a "premises user"

The police and local authority exercising environmental health functions may intervene on the grounds of any of the four licensing objectives (the prevention of crime and disorder, public safety, the prevention of public nuisance and the protection of children from harm) to prevent the occurrence of an event at which permitted temporary activities are to take place or to agree a modification of the arrangements for such an event However the licensing authority may intervene of its own volition in the cases described below





The current Premises Licence PREM/03724/001 authorises Best Kebab to provide Late Night Refreshment on the following days Sunday to Thursday 23 00 to Midnight Friday & Saturday 23 00 to 00 30

Further to complaints received from members of the public and Elected Members, Licensing Enforcement Officers, through enquiries made, found the premises to be providing unauthorised late night refreshment beyond the current permitted licensed hours on a number of occasions Despite warning letters having being sent and meetings held with the operator, further licensing breaches have been witnessed

LCF Law One St James Business Park New Augustus Street Bradford BD1 511 Also, the premises operator failed to comply with the requirements of the Licensing Act in respect of two recent Temporary Event Notices (TEN) notified by them in that one of the TEN's, a 'late' TEN was issued a Counter Notice following a formal representation made by the West Yorkshire Police Despite the Counter Notice being issued the premises exceeded their permitted licensed hours on both 23<sup>rd</sup> & 24<sup>th</sup> December 2017 by providing late night refreshment after 0030 on the 23<sup>rd</sup> December 2017 and after Midnight on 24<sup>th</sup> December 2017

They again exceeded their permitted licensed hours on 1<sup>st</sup> January 2018 by providing late night refreshment after midnight on 1<sup>st</sup> January 2018 after withdrawing a TEN for that day

In addition, the Premises Licence Holder, Sajid Khan has failed to comply with conditions 1-3 (CCTV) of their existing Premises Licence Mr Khan had agreed to install a Closed Circuit Television System (CCTV) in accordance with West Yorkshire Police Guidelines at the hearing in March 2016 Following an incident of disorder outside the premises at 2am on 5<sup>th</sup> November 2017 it was found that the CCTV system had not been installed The system was to be provided for the protection of customers and staff The effect of not having the CCTV system meant that persons involved in the incident could not be quickly identified

The premises were last visited by Licensing Enforcement Officers on 16<sup>th</sup> February 2018 and the CCTV system that was initially agreed in March 2016 was still not operational

The Licensing Authority feels that any increase in the permitted hours for Late Night Refreshment would compromise the above objectives and subject properties in the area to nuisance over an extended period. The Premises Licence Holder's inability to comply with the permitted hours on the existing licence is unlikely to result in them complying with the proposed extended hours.

We respectively request that the Licensing Sub-Committee considers our representation prior to coming to a decision on the application





I am a Police Sergeant 6910 of the West Yorkshire Police currently stationed at Otley police station

At approximately 02 05 hrs on Sunday 5<sup>th</sup> November 2017 whilst in company with PC 3483 King I was walking along Westgate, Otley in the direction of Waitrose supermarket. As we were approaching the "Best Kebab & Pizza takeaway on Westgate I saw a large group of males and females who were inside and outside the shop. I estimate there were around 20 people both inside and outside the shop. Most of whom looked as though they had either just bought something or were about to buy something.

I am now aware that the takeaways trading hours were until 00 30 hrs Friday and Saturday evenings but I could clearly see that the staff were still serving hot food and business appeared to be booming

At this time as we were passing an apparent fight broke out between two males both of whom had been inside the takeaway. The violence spilled out onto the street and PC King and I detained the two males involved one of whom was bleeding heavily from his nose.

The result of us detaining the males was difficult to say the least. Some of the crowd were trying to get us to release one suspect and at the same time another part of the crowd were trying to get to the other male who turned out to be the victim

Virtually everyone I spoke to was noisy argumentative obstructive and drunk I would describe the behaviour of at least half of the crowd to be too loud and beyond anti-social I would describe the behaviour of the suspect in the assault as both intimidating and aggressive. He was jumping up and down and swearing and shouting whilst trying to get at the male who he had assaulted presumably to assault him again. I have absolutely no doubt in my mind that this scene of violence and drunken aggression could have been avoided if the Best Kebab & Pizza shop had ceased trading at the time when they were supposed to

I was also in the area at 0145hrs on 01/01/18 and I passed by the Best Kebab & Pizza shop I made a point of checking if it was open or closed and when I passed I could clearly see that the business was still open and serving food I would estimate that there were around 10 customers in the business at this time

I am police constable 3483 of the West Yorkshire Police currently stationed at Otley police station within the Leeds Outer North West neighbourhood policing team as the ward manager for Guiseley

At approximately 02 05 hrs on Sunday 5<sup>th</sup> November 2017 whilst in company with PS 6910 HESSE I was walking along Westgate Otley towards Waitrose supermarket when as I approached one of the takeaways called Best Kebab and Pizza Shop 48 – 50 Westgate Otley Leeds In which I was on the opposite side off the road to I saw a large group of males and females who were inside and outside the takeaway The takeaway appeared quite full of customers inside and outside including a number sat on the wall opposite whom were also eating pizzas etc. I would say there was approximately 20 or so persons in total

I am aware that the takeaways trading hours were until 00 30 hrs Friday and Saturday evenings but I could clearly see a number of customers inside the premises still be served food and customers outside consuming what they had purchased

At this time as we were passing I saw what looked like a fight braking out between two males, both of whom had just come from inside the takeaway. The fight continued onto the street and PS Hesse and I detained the two males involved one of whom was bleeding heavily from his nose.

It was clear from the males demeanour that they were also in drink and would not listen to any reasoning. Some of the crowd were trying to get us to release one suspect and at the same time another part of the crowd were trying to get to the other male who turned out to be the victim.

The majority of people that I spoke to were noisy argumentative obstructive and drunk The nature of their conduct was certainly anti-social which was not only outside the takeaway but also outside a number of residential properties Both males displayed unacceptable behaviour in terms of the assault and their overall conduct which I would describe as being both intimidating and aggressive. One of the males was extremely agitated swearing and shouting whilst trying to get at the male whom he d had assaulted goading him presumably to try and assault him again. This incident could have been avoided if the Best Kebab and Pizza shop had ceased trading at the time it should have done. As a late night establishment they should have a duty of care to the community to try and avoid scenes of violence and drunken aggression by conforming to the licensing times attached to their conditions.

- 1. A suitable Closed-Circuit Television (CCTV) system will be operational at the premises at all times when licensable activities are being carried out and at any other times where members of the public are present on the premises.
- 2. The CCTV system will contain the correct time and date stamp information.
- 3. The CCTV system will have sufficient storage retention capacity for a minimum of 31 days continuous footage which will be of good quality.

4. Members of the public will be prevented from accessing hot food and drink preparation areas to prevent risk of scald or burns.

- 8. Bottles will not be placed in any external receptacle between 11 pm and 7 am the following day to minimise noise disturbance to neighbouring properties.
- 9. Noise from plant or machinery shall not be audible at the nearest noise sensitive premises during the operation of the plant or machinery. Plant and machinery shall be regularly serviced and maintained to meet this level.
- 10. The activities of persons using the external areas shall be monitored after 11 pm and they shall be reminded to have regard to the needs of local residents and to refrain from shouting and anti-social behaviour etc. when necessary.

- 11. The PLH/DPS shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.
- 12. Clear and legible notices will be displayed at exits, car parks and other circulatory areas requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour.



## 11. Reviews

#### THE REVIEW PROCESS

- 11.1 The proceedings set out in the 2003 Act for reviewing premises licences and club premises certificates represent a key protection for the community where problems associated with the licensing objectives occur after the grant or variation of a premises licence or club premises certificate.
- 11.2 At any stage, following the grant of a premises licence or club premises certificate, a responsible authority, or any other person, may ask the licensing authority to review the licence or certificate because of a matter arising at the premises in connection with any of the four licensing objectives.
- 11.3 An application for review may be made electronically, provided the licensing authority agrees and the applicant submits a subsequent written application. The licensing authority may also agree in advance that the application need not be given in writing. However, these applications are outside the formal electronic application process and may not be submitted via Business Link or the licensing authority's electronic facility.
- 11.4 In addition, the licensing authority must review a licence if the premises to which it relates was made the subject of a closure order by the police based on nuisance or disorder and the magistrates' court has sent the authority the relevant notice of its determination, or if the police have made an application for summary review on the basis that premises are associated with serious crime and/or disorder.
- 11.5 Any responsible authority under the 2003 Act may apply for a review of a premises licence or club premises certificate. Therefore, the relevant licensing authority may apply for a review if it is concerned about licensed activities at a premises and wants to intervene early without waiting for representations from other parties. However, it is not expected that licensing authorities should normally act as responsible authorities in applying for reviews on behalf of other persons, such as local residents or community groups. These individuals or groups are entitled to apply for a review for a licence or certificate in their own right if they have grounds to do so. It is also reasonable for licensing authorities to expect other responsible authorities to intervene where the basis for the intervention falls within the remit of that other authority. For example, the police should take appropriate steps where the basis for the review is concern about crime and disorder. Likewise, where there are concerns about noise nuisance, it is reasonable to expect the local authority exercising environmental health functions for the area in which the premises are situated to make the application for review.
- 11.6 Where the relevant licensing authority does act as a responsible authority and applies for a review, it is important that a separation of responsibilities is still achieved in this process to ensure procedural fairness and eliminate conflicts of interest. As outlined previously in Chapter 9 of this Guidance, the distinct functions of acting as licensing authority and responsible authority should be exercised by different officials to ensure a separation of responsibilities. Further information on how licensing authorities should achieve this

separation of responsibilities can be found in Chapter 9, paragraphs 9.13 to 9.19 of this Guidance.

- 11.7 Any application for a review received by the licensing authority from responsible authorities and any other persons should be given due consideration and treated by the authority in precisely the same way, regardless of the body or individual which made it. This includes an application made by the local authority acting in a separate capacity (for example, environmental health or child protection).
- 11.8 In every case, any application for a review must relate to particular premises in respect of which there is a premises licence or club premises certificate and must be relevant to the promotion of one or more of the licensing objectives. Following the grant or variation of a licence or certificate, a complaint regarding a general issue in the local area relating to the licensing objectives, such as a general (crime and disorder) situation in a town centre, should generally not be regarded as a relevant representation unless it can be positively tied or linked by a causal connection to particular premises, which would allow for a proper review of the licence or certificate. For instance, a geographic cluster of complaints, including along transport routes related to an individual public house and its closing time, could give grounds for a review of an existing licence as well as direct incidents of crime and disorder around a particular public house.
- 11.9 Where a licensing authority receives a geographic cluster of complaints, the authority may consider whether these issues are the result of the cumulative impact of licensed premises within the area concerned. In such circumstances, the authority may also consider whether it would be appropriate to include a special policy relating to cumulative impact within its licensing policy statement. Further guidance on cumulative impact policies can be found in Chapter 13 of this Guidance.
- 11.10 Representations must be made in writing and may be amplified at the subsequent hearing or may stand in their own right. Additional representations which do not amount to an amplification of the original representation may not be made at the hearing. Representations may be made electronically, provided the licensing authority agrees and the applicant submits a subsequent written representation. The licensing authority may also agree in advance that the representation need not be given in writing.
- 11.11 It is important to recognise that the promotion of the licensing objectives relies heavily on a partnership between licence holders, authorised persons, responsible authorities and any other persons in pursuit of common aims. Where authorised persons and responsible authorities have concerns about problems identified at premises, it is good practice for them to give licence holders early warning of their concerns and the need for improvement, and where possible they should advise the licence or certificate holder of the steps they need to take to address those concerns. A failure by the holder to respond to such warnings is expected to lead to a decision to apply for a review. Co-operation at a local level in promoting the licensing objectives should be encouraged and reviews should not be used to undermine this co-operation.

11.12 If the application for a review has been made by a person other than a responsible authority (for example, a local resident, residents' association, local business or trade association), before taking action the licensing authority must first consider whether the complaint being made is relevant, frivolous, vexatious or repetitious. Further guidance on determining whether a representation is frivolous or vexatious can be found in Chapter 9 of this Guidance (paragraphs 9.4 to 9.10).

#### **REPETITIOUS GROUNDS OF REVIEW**

11.13 A repetitious ground is one that is identical or substantially similar to:

- a ground for review specified in an earlier application for review made in relation to the same premises licence or certificate which has already been determined; or
- representations considered by the licensing authority when the premises licence or certificate was granted; or
- representations which would have been made when the application for the premises licence was first made and which were excluded then by reason of the prior issue of a provisional statement; and, in addition to the above grounds, a reasonable interval has not elapsed since that earlier review or grant.
- 11.14 Licensing authorities are expected to be aware of the need to prevent attempts to review licences merely as a further means of challenging the grant of the licence following the failure of representations to persuade the licensing authority on an earlier occasion. It is for licensing authorities themselves to judge what should be regarded as a reasonable interval in these circumstances. However, it is recommended that more than one review originating from a person other than a responsible authority in relation to a particular premises should not be permitted within a 12 month period on similar grounds save in compelling circumstances or where it arises following a closure order.
- 11.15 The exclusion of a complaint on the grounds that it is repetitious does not apply to responsible authorities which may make more than one application for a review of a licence or certificate within a 12 month period.
- 11.16 When a licensing authority receives an application for a review from a responsible authority or any other person, or in accordance with the closure procedures described in Part 8 of the 2003 Act (for example, closure orders), it must arrange a hearing. The arrangements for the hearing must follow the provisions set out in regulations. These regulations are published on the Government's legislation website (www.legislation.gov.uk). It is particularly important that the premises licence holder is made fully aware of any representations made in respect of the premises, any evidence supporting the representations and that the holder or the holder's legal representative has therefore been able to prepare a response.

## POWERS OF A LICENSING AUTHORITY ON THE DETERMINATION OF A REVIEW

- 11.17 The 2003 Act provides a range of powers for the licensing authority which it may exercise on determining a review where it considers them appropriate for the promotion of the licensing objectives.
- 11.18 The licensing authority may decide that the review does not require it to take any further steps appropriate to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular period of time. It is expected that licensing authorities will regard such informal warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the licence holder.
- 11.19 However, where responsible authorities like the police or environmental health officers have already issued warnings requiring improvement either orally or in writing that have failed as part of their own stepped approach to address concerns, licensing authorities should not merely repeat that approach and should take this into account when considering what further action is appropriate.
- 11.20 Where the licensing authority considers that action under its statutory powers is appropriate, it may take any of the following steps:
  - to modify the conditions of the premises licence (which includes adding new conditions or any alteration or omission of an existing condition), for example, by reducing the hours of opening or by requiring door supervisors at particular times;
  - to exclude a licensable activity from the scope of the licence, for example, to exclude the performance of live music or playing of recorded music (where it is not within the incidental live and recorded music exemption);
  - to remove the designated premises supervisor, for example, because they consider that the problems are the result of poor management;
  - to suspend the licence for a period not exceeding three months;
  - to revoke the licence.
- 11.21 In deciding which of these powers to invoke, it is expected that licensing authorities should so far as possible seek to establish the cause or causes of the concerns that the representations identify. The remedial action taken should generally be directed at these causes and should always be no more than an appropriate and proportionate response.

- 11.22 For example, licensing authorities should be alive to the possibility that the removal and replacement of the designated premises supervisor may be sufficient to remedy a problem where the cause of the identified problem directly relates to poor management decisions made by that individual.
- 11.23 Equally, it may emerge that poor management is a direct reflection of poor company practice or policy and the mere removal of the designated premises supervisor may be an inadequate response to the problems presented. Indeed, where subsequent review hearings are generated by representations, it should be rare merely to remove a succession of designated premises supervisors as this would be a clear indication of deeper problems that impact upon the licensing objectives.
- 11.24 Licensing authorities should also note that modifications of conditions and exclusions of licensable activities may be imposed either permanently or for a temporary period of up to three months. Temporary changes or suspension of the licence for up to three months could impact on the business holding the licence financially and would only be expected to be pursued as an appropriate means of promoting the licensing objectives. So, for instance, a licence could be suspended for a weekend as a means of deterring the holder from allowing the problems that gave rise to the review to happen again. However, it will always be important that any detrimental financial impact that may result from a licensing objectives. But where premises are found to be trading irresponsibly, the licensing authority should not hesitate, where appropriate to do so, to take tough action to tackle the problems at the premises and, where other measures are deemed insufficient, to revoke the licence.

## **REVIEWS ARISING IN CONNECTION WITH CRIME**

- 11.25 A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises; money laundering by criminal gangs, the sale of contraband or stolen goods, or the sale of firearms. Licensing authorities do not have the power to judge the criminality or otherwise of any issue. This is a matter for the courts of law. The licensing authority's role when determining such a review is not therefore to establish the guilt or innocence of any individual but to ensure the promotion of the crime prevention objective.
- 11.26 Reviews are part of the regulatory process introduced by the 2003 Act and they are not part of criminal law and procedure. Some reviews will arise after the conviction in the criminal courts of certain individuals, but not all. In any case, it is for the licensing authority to determine whether the problems associated with the alleged crimes are taking place on the premises and affecting the promotion of the licensing objectives. Where a review follows a conviction, it would also not be for the licensing authority to attempt to go beyond any finding by the courts, which should be treated as a matter of undisputed evidence before them.

- 11.27 Where the licensing authority is conducting a review on the grounds that the premises have been used for criminal purposes, its role is solely to determine what steps should be taken in connection with the premises licence, for the promotion of the crime prevention objective. It is important to recognise that certain criminal activity or associated problems may be taking place or have taken place despite the best efforts of the licence holder and the staff working at the premises and despite full compliance with the conditions attached to the licence. In such circumstances, the licensing authority is still empowered to take any appropriate steps to remedy the problems. The licensing authority's duty is to take steps with a view to the promotion of the licence holder.
- 11.28 As explained above, it is not the role of a licensing authority to determine the guilt or innocence of individuals charged with licensing or other offences committed on licensed premises. There is therefore no reason why representations giving rise to a review of a premises licence need be delayed pending the outcome of any criminal proceedings. As stated above, at the conclusion of a review, it will be for the licensing authority to determine on the basis of the application for the review and any relevant representations made, what action needs to be taken for the promotion of the licensing objectives in respect of the licence in question, regardless of any subsequent judgment in the courts about the behaviour of individuals.
- 11.29 There is certain criminal activity that may arise in connection with licensed premises which should be treated particularly seriously. These are the use of the licensed premises:
  - for the sale and distribution of Class A drugs and the laundering of the proceeds of drugs crime;
  - for the sale and distribution of illegal firearms;
  - for the evasion of copyright in respect of pirated or unlicensed films and music, which does considerable damage to the industries affected;
  - for the illegal purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people;
  - for prostitution or the sale of unlawful pornography;
  - · by organised groups of paedophiles to groom children;
  - as the base for the organisation of criminal activity, particularly by gangs;
  - for the organisation of racist activity or the promotion of racist attacks;
  - for knowingly employing a person who is unlawfully in the UK or who cannot lawfully be employed as a result of a condition on that person's leave to enter;

- for unlawful gambling; and
- for the sale of smuggled tobacco and alcohol.
- 11.30 It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities, will use the review procedures effectively to deter such activities and crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence even in the first instance should be seriously considered. We would also encourage liaison with the local Community Safety Partnership.
- 11.31 As noted below (Chapter 13, paragraph 13.59), it is unlawful to discriminate or to refuse service on grounds of race, disability, gender reassignment, pregnancy and maternity, religion and belief, sex and sexual orientation or by displaying discriminatory signs on the premises. Representations made about such activity from responsible authorities or other persons would be relevant to the promotion of the crime prevention objective and justifiably give rise to a review.

#### **REVIEW OF A PREMISES LICENCE FOLLOWING CLOSURE ORDER**

- 11.32 Licensing authorities are subject to certain timescales, set out in the legislation, for the review of a premises licence following a closure order. The relevant time periods run concurrently and are as follows:
  - when the licensing authority receives notice that a magistrates' court has made a closure order it has 28 days to determine the licence review the determination must be made before the expiry of the 28th day after the day on which the notice is received;
  - the hearing must be held within 10 working days, the first of which is the day after the day the notice from the magistrates' court is received;
  - notice of the hearing must be given no later than 5 working days before the first hearing day (there must be five clear working days between the giving of the notice and the start of the hearing).

## **REVIEW OF A PREMISES LICENCE FOLLOWING PERSISTENT SALES OF ALCOHOL TO CHILDREN**

11.33 Where persistent sales of alcohol to children have occurred at premises, responsible authorities should consider applying for a review of the licence, whether there has been a prosecution for the offence under section 147A or a closure notice has been given under section 169A of the 2003 Act. In determining the review, the licensing authority should consider revoking the licence if it considers this outcome is appropriate. Responsible authorities should consider taking steps to ensure that a review of the licence is routine in these circumstances.

## Summary of main issues

This is an application to vary a premises licence, made by Mr Sajid Khan, for Best Kebab 48 & 50 Westgate, Otley, LS21 3AS.

The application was originally scheduled for hearing on the 17<sup>th</sup> April 2018, but was adjourned at the request of the applicant until the 8<sup>th</sup> May 2018.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from responsible authorities.

## 1 Purpose of this report

- 1.1 To advise Members of an application made under section 34 of the Licensing Act 2003 ("the Act") to vary a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

## 2 History of premises

2.1 On the 1<sup>st</sup> February 2016, an application was received in the Licensing Office for the grant of a premises licence for the sale of late night refreshment up to 2 am on weekends. The application attracted representations from responsible authorities and other persons and a ward councilor and was scheduled for hearing before the Licensing Sub Committee where the decision was made to grant the licence, adding the agreed conditions and reducing the hours applied for to up to 00:30 on weekends. The licence was granted in March 2016.

Complaints from residents were received in May 2017 alleging that the premises were repeatedly exceeding their permitted hours up to 2am on weekends.

Warning letters were sent to the premises and the licence holder's home address, the licence holder was advised that the premises would be monitored for compliance.

In July 2017, officers from Entertainment Licensing carried out a covert Test Purchase of hot food, this was 20 minutes after the last permitted sale of hot food. Warning letters were again sent to the licence holder at the premises and his home address.

On the 5<sup>th</sup> November 2017 Police officers attended a large disturbance outside the shop at 2 am. The officers reported that the shop was still open at that time, this is 90 minutes after the last permitted sale of hot food.

A further warning letter was sent to the licence holder at the premises and his home address.

An enforcement officer visited the premises on 9<sup>th</sup> November 2017 and spoke to the licence holder. They discussed the recent incident and the officer requested to view the CCTV system (conditions 1-3) on the premises licence. Mr Khan stated that he had not installed the CCTV system that he had agreed to install at the Licensing Sub Committee hearing on the 29<sup>th</sup> March 2016, as a result no footage was available to assist police in identifying persons involved in the incident.

On the 15<sup>th</sup> November 2017, a Police Community Support Officer witnessed the shop operating at 00:40 hours, last permitted sale of hot food that day is midnight.

On the 5<sup>th</sup> December 2017, Mr Khan telephoned licensing advising that he had been unable to find anyone to install CCTV prior to Christmas. He was advised that he was continuing to breach CCTV conditions, he was also advised that Police had witnessed breaches of hours on the 15<sup>th</sup> November 2017.

On the 12<sup>th</sup> December 2017, two x TEN (temporary event notice) applications were received from the licence holder. The first application was for the weekend before Christmas and the second was for the weekend before and including New Year's Day. As the first application was not received 10 working days before the date of the event, the first ten was deemed a late ten. A representation was received from West Yorkshire Police, which meant that the Ten had to be rejected and on 14<sup>th</sup> December 2017, a Counter Notice was issued to the licence holder.

The 2<sup>nd</sup> Ten for the weekend of New Year's Eve was also subject to a representation from West Yorkshire Police, due to the recent disorder at the premises and because the premises were still failing to comply with the conditions relating to CCTV. As a result, Mr Khan emailed Licensing withdrawing this Ten, the email was received on the 15<sup>th</sup> December 2017.

Entertainment Licensing were advised by West Yorkshire Police that the premises had exceeded their permitted hour's and had chosen to disregard the Counter Notice on the 23<sup>rd</sup> and 24<sup>th</sup> December 2017. Entertainment Licensing were also advised by West Yorkshire Police that the premises had exceeded their hours up to 01:45 on New Year's Day, the normal hours for4 hot food is midnight on that day.

On the 5<sup>th</sup> February 2018, the premises licence holder and his solicitor attended a meeting at Otley Police Station, where Council and Police Licensing Officers advised Mr Khan of his breaches of licence. The premises licence holder advised the meeting that he had installed the CCTV system.

On the 16<sup>th</sup> February 2018, a LCC enforcement officer visited Best Kebab and requested to view the CCTV to check compliance with conditions 1-3 of the licence. The premises licence holder admitted that only the cameras were fitted and there was no hard drive or monitor to view footage.

The Licensing Authority did consider the option of prosecution via the courts, but it was felt that due to the repeated breaches of licensed hours and conditions, a review was the preferred option with the recommendation to revoke the existing licence.

A review was submitted on the 13<sup>th</sup> March 2018.

2.2 A copy of the existing licence is attached at Appendix A.

## 3 The application

- 3.1 The applicant is Mr Sajid Khan
- 3.2 Briefly the application is to:
  - Add an additional half hour onto the hours for sale of late night refreshment on a Friday and Saturday night.

## 4 The operating schedule

4.1 The applicant considers that the existing measures are sufficient to promote the licensing objectives and no further measures have been offered.

## 5 Location

5.1 A map which identifies the location of this premises is attached at Appendix B.

## 6 Representations

6.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.

## Representations from Responsible Authorities

6.2 Representations have been received from The Licensing Authority, West Yorkshire Police and The Environmental Protection Team in their capacity as responsible authorities. A copy of all the representation may be found at Appendix C.

## Other representations

- 6.3 There are no other representations.
- 6.4 Members are directed to paragraphs 7.51 to 7.54 of the Statement of Licensing Policy which provides examples of how an application may be considered exceptional and the matters that the council would not normally take into consideration.

## 7 Licensing hours

- 7.1 Members are directed to paragraphs 6.8 to 6.15 for the Statement of Licensing Policy which states the criteria that will be applied to any decision for new applications or variations which include extending hours.
- 7.2 In brief the Policy states at 6.14 that restrictions may be made to the proposed hours of use where, after receiving relevant representations, the council considers it appropriate for the promotion of the licensing objectives to do so. The council will take into account the existing pattern of licensed premises in an area when considering what is appropriate to promote the objectives. Applications which are significantly out of character for a locality will need to demonstrate that granting the hours sought will not impact on the licensing objectives.
- 7.3 A list of premises in the local area and their licensed hours and activities is provided at appendix D.

## 8 Equality and diversity implications

10.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the licensing subcommittee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

#### 9 Options available to Members

- 9.1 The licensing subcommittee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
  - Grant the variation as requested.
  - Grant the variation whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
  - Exclude any licensable activities to which the application relates.
  - Reject the whole or part of the application.
- 9.2 Members of the licensing subcommittee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.





- 8. Bottles will not be placed in any external receptacle between 11 pm and 7 am the following day to minimise noise disturbance to neighbouring properties.
- 9. Noise from plant or machinery shall not be audible at the nearest noise sensitive premises during the operation of the plant or machinery. Plant and machinery shall be regularly serviced and maintained to meet this level.
- 10. The activities of persons using the external areas shall be monitored after 11 pm and they shall be reminded to have regard to the needs of local residents and to refrain from shouting and anti-social behaviour etc. when necessary.

- 11. The PLH/DPS shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.
- 12. Clear and legible notices will be displayed at exits, car parks and other circulatory areas requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour.





Consistent notifications for current license breaches, previous complaint nuisance history lead the department to conclude that the application to extend opening hours has the potential to create noise nuisance to the area affecting local amenity into the early morning hours

We recommend that the Sub-Committee refuse the application

We do not believe that further conditions will resolve the application as it stands

The Licensing Authority is of the opinion that your application contains insufficient information about how you intend to meet the licensing objectives. We therefore confirm that we are submitting a formal representation against your application on the grounds of:

1.The prevention of crime and disorder 2.The prevention of public nuisance

<u>3 Public Safety</u>

The current Premises Licence PREM/03724/001 authorises Best Kebab to provide Late Night Refreshment on the following days: Sunday to Thursday: 23:00 to Midnight Friday & Saturday: 23:00 to 00:30

Further to complaints received from members of the public and Elected Members, Licensing Enforcement Officers, through enquiries made, found the premises to be providing unauthorised late night refreshment beyond the current permitted licensed hours on a number of occasions. Despite warning letters having being sent and meetings held with the operator, further licensing breaches have been witnessed. Also, the premises operator failed to comply with the requirements of the Licensing Act in respect of two recent Temporary Event Notices (TEN) notified by them in that one of the TEN's, a 'late' TEN was issued a Counter Notice following a formal representation made by the West Yorkshire Police. Despite the Counter Notice being issued the premises exceeded their permitted licensed hours on both 23<sup>rd</sup> & 24<sup>th</sup> December 2017 by providing late night refreshment after 0030 on the 23<sup>rd</sup> December 2017 and after Midnight on 24<sup>th</sup> December 2017.

They again exceeded their permitted licensed hours on 1<sup>st</sup> January 2018 by providing late night refreshment after midnight on 1<sup>st</sup> January 2018 after withdrawing a TEN for that day.

In addition, the Premises Licence Holder, Sajid Khan has failed to comply with conditions 1-3 (CCTV) of their existing Premises Licence. Mr Khan had agreed to install a Closed Circuit Television System (CCTV) in accordance with West Yorkshire Police Guidelines at the hearing in March 2016. Following an incident of disorder outside the premises at 2am on 5<sup>th</sup> November 2017 it was found that the CCTV system had not been installed. The system was to be provided for the protection of customers and staff. The effect of not having the CCTV system meant that persons involved in the incident could not be quickly identified.

The premises were last visited by Licensing Enforcement Officers on 16<sup>th</sup> February 2018 and the CCTV system that was initially agreed in March 2016 was still not operational.

The Licensing Authority feels that any increase in the permitted hours for Late Night Refreshment would compromise the above objectives and subject properties in the area to nuisance over an extended period. The Premises Licence Holder's inability to comply with the permitted hours on the existing licence is unlikely to result in them complying with the proposed extended hours.

We respectively request that the Licensing Sub-Committee considers our representation prior to coming to a decision on the application.

The premises has been found operating on numerous occasions beyond their licensed hours. West Yorkshire Police responded to a violent incident outside the shop at 0200 hours on Sunday 5<sup>th</sup> November 2017. The premises was open at the time, the incident involved customers from Best Kebabs and this was 1 hour and a half after the shop should have ceased trading.

Alongside this, a T.E.N was served for the 23<sup>rd</sup> 24<sup>th</sup> and 25<sup>th</sup> December 2017 and was objected to by West Yorkshire Police, yet there is evidence stated below, that this was ignored and it was seen that the premises continued to serve past their licensed hours.

On 23<sup>rd</sup> December 2017 into the 24<sup>th</sup> December 2017, at 0130 hours, police witnessed a member of staff passing food to a customer and there was another customer waiting to be served, this took place 1 hour past licensed hours.

On 24<sup>th</sup> December 2017 into the 25<sup>th</sup> December 2017, again, police witnessed an individual being served on the premises at 0115 hours, 1 hour 15 minutes past licensed hours.

We were served a T.E.N for the 30<sup>th</sup>/31<sup>st</sup> December 2017 and the 1<sup>st</sup> January 2018, which was later withdrawn by Best Kebab. On the 31<sup>st</sup> the premises was due to stop serving at 2300 hours. However, the police witnessed around 10 customers being served in the shop at 0145 hours on the 1<sup>st</sup> of January 2018, which is 2 hours 45 minutes past the licensed time.

The hours that have been requested in the current application to vary the premises licence involve extending the closing hours from 0030 hours to 0100 hours on Saturday and Sundays. In the examples I have already listed where police have witnessed the premises operating outside its licensed hours, the hours in which they were operating exceed those that are currently being sought. We therefore have no confidence that the extra half hour applied for on a weekend will address the applicant's apparent disregard for his current authorised hours.

On the back of these breaches of the licence, a meeting was held on the 5<sup>th</sup> February 2018 with West Yorkshire Police, Leeds City Council and the licence holder in which these occurrences were highlighted and discussed. Another meeting occurred on the 19<sup>th</sup> March 2018 to check the new CCTV system the licence holder had fitted which was in working order but had not yet attained the required 31 days retention.

Given the above occurrences, the repeated breaches of the licence and the lack of measures offered, West Yorkshire Police object to this application and invite the licensing authority to refuse the application outright at any future hearing.
