57 Leeds Health and Care Plan - Continuing the conversation

The Chief Officer Health and Partnerships submitted a report that provided an update on the progress made in actions contained within the Leeds Health and Care Plan following the previous engagement with the committees in autumn 2017.

The following were in attendance:

- o Dayle Lynch, Estates Programme Manager, Adults & Health
- o Georgia Blaney, Project Officer, Adults & Health
- o Dr John Keene

Dayle Lynch presented the report and provided the Committee with a presentation. The following was highlighted:

- The strategies and pathways of moving towards a social model of health care:
- Leeds Health and Wellbeing Strategy 2016-2021;
- The Leeds Health and Care Plan;
- Video providing people with services designed around needs' and techniques on how people can build on strengths to live independently;
- Outer West health statistics and information.

Commenting on the Health and Care Plan boundaries, Members pointed out that they did not reflect ward boundaries nor area committees. Members requested that officers take away the concerns, and address at a future committee meeting.

Members identified mental health had become more prevalent and that reporting figures had become more accurate.

In relation to the Local Care Partnership (LCP) appointments set out in the report, Members felt that they needed more time to have discussions and receive further information before agreeing LCP appointment.

58 Crime Reduction

Chris Joyce, Crime Prevention Officer, was in attendance and provided the Committee with a presentation updating Members on the work carried out by West Yorkshire Police. The following was highlighted:

- Home Office Modern Crime Prevention Strategy 2016
- National Policing Crime Prevention Strategy

- Shaping crime prevention by working in schools and educating in a learning environment
- Visions, values and purposes of what the service wants to achieve
- Prevention and Problem Solving Strategy 2018/19 and the five strategic areas of the plan including:
 - Places
 - Products
 - Partnerships
 - People
 - Problem Solving

A copy of the Prevention and Problem Solving presentation was appended to the covering report.

Members queried the methods of reporting, and raised concern that numerous residents had complained. In response, Members noted the offer from the Crime Prevention Officer, to ask a call centre manager colleagues to attend a future committee date. Members requested that further information be provided regarding methods of reporting and contact points to Committee Members.

Members expressed the view that relationships which had been built up with Members and the police, had been broken down, specifically in regard to involvement in tasking meetings. In response, Members were informed this was due to GDPR changes, and that this matter had previously been identified by the Scrutiny Board (Environment, Housing and Communities). In summary, the Crime Prevention Officer explained he would report back on this matter, and raise Members concerns.

59 Outer West Community Youth Summit

The Community Voice and Influence Officer submitted a report which updated Members with feedback, information and recommendations of the Outer West Community Youth Summit held 22nd October 2018. The purpose of the event was for discussions between young people and elected members, Young people to have a greater understanding of local democracy and consultation with young people in the Outer West wards to prioritise spend of the Outer West Youth Activity Fund 2019/2020.

The following was appended to the report:

- Photos from the day Appendix 3

The following were in attendance:

- Victoria Marsden, Play Strategy Officer
- Satbinder Soor, Youth Service Manager Localities
- o Andrew Derra, Advanced Youth Work Practitioner

The officers in attendance highlighted:

- Six primary schools, two high schools and one college booked attended the event held 22nd October 2018, with 54 children and young people;
- The event included an opportunity for young people to learn about democracy;
- The event provided lunch for the attendees at the Rose Bowl Café in the Leeds Beckett Campus;
- The Youth Activity Fund consultation activity highlighted the types of activity in order of preference that young people would like to take part in across the area;
- The Leeds Youth Service are keen to bring students who find it difficult in engaging and it was intended to increase numbers of those students for the Youth Summit:
- Invites have been sent out to schools for the upcoming Youth Summit and in September, a reminder will be sent to schools.

Members discussed a number of matters including:

- Members raised some concern around event attendance and the difficulties of aiming at those specific children who struggle to engage, and further addressing the balance of male and females.
- The lack of engagement from schools and receiving responses.
- Members requested the Youth Summit invite is sent to Committee Members, to enable Members to liaise and contact head teachers to target key schools.
- Members sought clarity on the feedback schools had received after the event, and were informed each school is provided with a poster of what young people had highlighted during the session and the activities children could get involved in.
- Members suggested that in order to receive additional engagement from schools, it was of the view that teachers could potentially attend in an early evening, when cover would only need to be provided for an hour. Members further added that it would be worth re-promoting to schools the benefits previous schools had received out of these sessions.

Outer West Community Committee - Climate Emergency and Air Quality

Purpose of report

1. This report provides an overview of the presentation that will be given to the Community Committee, to provide background on the Climate Emergency and on-going work on air quality. It will explain both the climate emergency and the air quality agenda.

Main issues

- 2. In March 2019 the Council declared a climate emergency with the target to work towards net zero by 2030 for the whole city.
- 3. Alongside the climate emergency, the Council is also focused on increasing biodiversity across the city.
- As part of the climate emergency declaration the council committed to undertake a city conversation that included residents, Trade Unions, public sector organisations, businesses and third sector.
- 5. As well as the introduction of the Clean Air Zone, there is also on-going work to improve the air quality of the city, including various measures such as a scoot to school scheme, anti-idling campaign, roll out of charge points, an electric van and electric bike scheme for businesses and continual communications work to promote behavioural change.

- 6. It is estimated that if we are to have a good chance of avoiding dangerous climate change that is average warming above 1.5°C, the world can emit no more than 420 giga-tonnes of greenhouse gases by 2050. Leeds' share of this on a per capita basis is estimated at 42 mega-tonnes this is in effect our city's carbon budget to 2050. If we were to carry on at our current rate of emissions, we would have used our total budget for the period to 2050 within just 9 years.
- 7. This is clearly not an issue that the Council can tackle on its own. Securing public, investor and business support for carbon reduction is essential. The Council, working in partnership with the Leeds Climate Commission, is holding a 'city conversation' on climate change and the local action required before returning to Executive Board with final recommendations by the end of the year. Beyond what organisations and individuals can do in the city, the report will also seek to articulate the support, both regulatory and financial, which will be required from Government to enable the targets to be met.
- 8. A presentation will be provided to the Community Committee to provide the following information:
 - Outline of the climate emergency, biodiversity and air quality challenges;
 - Key actions that individuals can take;
 - Overview of the climate conversation;
 - Feedback on response rate from area;
 - Direct engagement undertaken/ planned with area;
 - Local involvement in anti-idling campaign;
 - Community car free day roll out.

Options

- 9. Members are asked to:
 - Receive the presentation and to offer any feedback;
 - Provide feedback on the best way to engage with the local community, including potential to link in with the youth summit;
 - Highlight any locations in the area where there is scope to increase biodiversity;
 - Highlight any areas where idling is an issue and where the promotional banners could be used to best effect:
 - Identify any schools that may be interested in hosting car free days;
 - Identify any areas that may be interested in participating in a rolling programme of car free days in 2020.

13. In March 2019, Full Council passed a resolution declaring a Climate Emergency and committing to hold a city conversation. The presentation outlined in the report provides detail on the approach.

Purpose of report

- 1. To provide the Community Committee with an update on the progress made in relation to "Making Leeds a More Active City".
- 2. To update on the development of the Physical Activity Social Movement and Ambition for Leeds.
- 3. Provide an overview of "Get Set Leeds" and starting the city wide conversation.
- 4. To outline next steps and recommendations.
- 5. To provide information to enable Community Committee members to support and champion the conversation.

1 Summary

- 1.1 Physical activity can be a catalyst for improving a person's health, wellbeing and happiness.
- 1.2 The Leeds Health and Wellbeing Strategy has a clear priority to 'get more people, more physically active, more often'; and a bold ambition to make Leeds the best city for health and wellbeing. We believe that making Leeds the most active city in England is a key part of achieving that ambition. Increasing physical activity will also help to achieve our city's vision of being a healthy and caring city for all ages, where people who are the poorest improve their health the fastest.
- 1.3 To realise our ambition of being the most active city in England, we aim to inspire a "Social Movement and Ambition" that will encourage everyone in Leeds to move more every day. In order to achieve this, a new bold approach is needed which requires cross-service and cross-agency collaboration that is driven by the needs of the most deprived communities in Leeds where health inequalities are highest and participation levels in physical activity the lowest.
- 1.4 We want to engage the people of Leeds in co-designing our ambition. The start of that process is the "Get Set Leeds" campaign, which is a city-wide conversation with the people of Leeds about how we can all make Leeds a more active city.

2 Background

- 2.1 As part of the Best Council Plan, Health & Wellbeing Strategy and the Healthy Weight Declaration we are committed to co-producing a physical activity ambition with the city.
- 2.2 The development of a new Physical Activity Ambition will set a long term agenda for change. It is founded on the basis that a more physically active city will help to deliver many of the city's outcomes and priorities as well as reflecting both the NHS 10 Year Plan and Prevention Green paper.
- 2.3 Physical activity is cross cutting given its contribution to so many outcomes across council priorities. In particular the new Ambition will support the Health and Wellbeing Strategy, Leeds Health and Care Plan, Inclusive Growth, Climate Emergency outcomes and address findings of the Joint Strategic Assessment.
- 2.4 Increasing physical activity has the potential to improve the physical and mental health and wellbeing of individuals, families, communities and the city as a whole. As well as being physically active, it is important that all adults and children minimise the time spent being sedentary (sitting) for extended periods.
- 2.5 There is strong evidence to suggest that an active lifestyle is essential for physical and mental health and wellbeing. Figure 1 below illustrates the benefits that can be produced from physical activity.



Figure 1: The health benefits of physical activity

- 2.6 Looking specifically at Leeds, we know that 238,900 adults are not active enough for good health and that 20.6% are inactive (taking 30mins or less physical activity a week). Only 28% of children in Leeds Primary and Secondary schools achieve the recommended one hour of physical activity a day (My Health, My School, 2017/18). Based on national trends, we also know that a majority of people aged over-65 are also inactive.




Figure 2: Diabetes rate per 100,000 population (all ages) as recorded by Leeds GPs for Outer West. Rates are age standardised allowing comparison of areas of different size and population age structure

- 2.7 There is also a clear link between inactivity and deprivation; our most deprived communities, have the greatest health inequalities and are the least active. Inactivity is a major contributor to obesity and associated long-term conditions, such as diabetes. As shown in figure 2 below, the rates of people recorded as having Diabetes is rising slowly in the Outer West and is lower than the Leeds average and the most deprived fifth of Leeds. Being active can reduce the risk of developing diabetes by 30-40%. People with diabetes can reduce their need for medication and the risk of complications by being more active.




Figure 3: Common Mental Health rates per 100,000 population (all ages) as recorded by Leeds GPs for Outer West. Rates are age standardised allowing comparison of areas of different size and population age structure

2.8 We also know, that being more active can help to prevent and reduce common mental health conditions and improve personal wellbeing. As shown in figure 3, the rates of common mental health conditions is increasing across Leeds and has risen steeper in recent years in the Outer West. People who are inactive have three times the rate of moderate to severe depression of active

3 Progress made to date

Big Leeds Chat

- 3.1 Last year, the health and care system in Leeds came together to host a conversation with local people, known as the Big Leeds Chat. This listening event focused on three questions: what do you love about Leeds, what do you do to keep yourself healthy and lastly what can we do to make Leeds the best city for health and wellbeing? This was followed, where appropriate, by detailed conversations between people and decision makers on the topics that mattered to people related to health and care in the city.
- 3.2 We managed to talk to around 500 people as part of the event, and one of the biggest themes that people wanted to talk about was physical activity. People told us that they know what they need to do to be active, eat well and stay healthy but that personal capacity, cost, and availability were major barriers. The findings of the Big Leeds Chat can be found in Appendix
- 3.3 It is a clear from people that there are many barriers to being more active, as seen from the Big Leeds Chat. We now want to have a more focused discussion with local people about physical activity so that we can understand what would make them more active and work in partnership with local people to co-design a city-wide physical activity ambition.

Social Marketing Gateway (SMG) Engagement

- In June 2018, Active Leeds commissioned The Social Marketing Gateway (SMG), via funds 3.4 from Sport England, to deliver insight into local needs with regard to physical activity in priority localities.
- 3.5 The purpose of the SMG research was to have a 'physical activity conversation' in priority neighbourhoods to better understand, from a systems perspective, the local priorities, outcomes and the motivations, behaviours and aspirations of people who live within these communities in relation to physical activity. We also wanted to be in a better position to understand the capability and capacity of local organisations, groups and volunteers and how this supports the co-production, promotion and provision of physical activity opportunities within these communities.
- 3.6 The process itself has helped to build stronger relationships within localities and has provided resource and capacity to have conversations that might not otherwise have taken place so quickly. We have also been able to utilise resources provided by SMG in the development of the city-wide conversations. The approach and learning has provided a strong base to have more detailed / meaningful conversations going forward.
- 3.7 In addition, the information gathered through the process is already being used by the Active Leeds localities team to work with the communities and other professionals to deliver solutions to some of the identified challenges / issues that were shared.

Get Set Leeds

- Get Set Leeds is our new engagement campaign, which encourages a city-wide conversation 3.8 about physical activity. It is a chance for people to share ideas on what getting active means to them and what might support them to move more.
- We will listen to residents, professionals, community groups, organisations, partners and 3.9 stakeholders and create a shared vision for the city and shape a "social movement" campaign: To get everybody moving more, we need to shift how we think and change what we do, together.
- 3.10 Whist this is a city-wide conversation that all local people can take part in, we are primarily targeting communities and population groups that we know are the most inactive, including:
 - People living in our priority communities
 - Older people
 - Children and families
 - Pathways within health and care such as diabetes, MSK, cancer and mental health
 - People with Learning disabilities/disabilities
 - Settings such as workplaces and schools
- 3.11 We have already started our engagement through a variety of targeted engagement

- approaches, including: face-to-face, stakeholder and community events, existing groups, boards and networks, online surveys, social media and through other partner networks.
- 3.12 We have also launched a campaign website, where people can find out more about the campaign, and can provide feedback through the online survey. To access the survey and information go to: getsetleeds.co.uk
- 3.13 As of Monday 12 August 2019 the current online survey response was 329 individuals. Appendix 2 illustrates the breakdown of this data in the early stages. Although it is too early to analyse the findings within this data, the information will continue to inform the engagement plan as it allows us to identify gaps or low responses from certain demographics.
- 3.14 The project is being delivered by a project team (established in September 2018) and brings together colleagues from Pubic Health, Health Partnerships Team, Active Leeds and Leeds City Council Corporate Communications Team. We also have academic support from Leeds Beckett University, providing valuable input on research and on systems leadership and change.
- 3.15 The Project Team are currently working to the following timescales / phases;
 - Phase 1: September 2018 June 2019: pre-conversation preparation
 - Phase 2: June 2019 November 2019: city-wide conversations (to become an ongoing process)
 - Phase 3: November 2019 January 2020: development of a draft shared vision / ambition for physical activity
 - Phase 4: Feb 2020 May 2020: physical activity ambition action planning
 - Phase 5: June 2020 onwards: physical activity ambition implementation
- 3.16 Active Leeds and Public Health Localities teams work very closely day-to-day with the 1% and 10% priority communities in Leeds. Teams have built strong relationships with residents alongside key local assets including community organisations, groups, and leaders. We are working with other locality structures that exist, for example, the Communities team, Children Services team, Housing, and emerging Local Care Partnerships.

4 Next Steps

- 4.1 We have a number of conversations and events arranged across the city over the next few months.
- 4.2 We will continue to promote the campaign through various Communication channels, with the support of our partner organisations.
- 4.3 Identification of influencers and Champions at a community level who can support with coproduction

Appendix 1 – Big Leeds Chat Key Themes

| Theme | Key Points |
|-----------------------|--|
| Diet | People told us that their diet is an important part of keeping healthy. Almost a third of the people we spoke to told us that they keep themselves healthy by eating well. For some people this was about cooking fresh food at home, for others it was about eating less and reducing the amount of alcohol they drink. |
| Exercise | Keeping fit and active was identified by many people as important. Walking, running and gardening are seen by many people as an easy and cheap way to keep fit and healthy. People also told us that activities such as going to the gym, cycling and yoga help them to keep themselves healthy. |
| No time for self-care | Some people also told us that a lack of time and motivation makes it difficult to take part in healthy activities. Poor health was another reason why people find it harder to get involved in healthy activities. |
| Cost | 45 people told us that leisure facilities are too expensive and that free or affordable activities would encourage more people to stay fit and active. Some people also said that it was too expensive to buy healthy food and that public transport was not affordable. |
| Transport | 21 people told us that they would like to see public transport improved by providing better bus routes, cheaper fares and a more reliable service. |
| | Many people also raised concerns about congestion in the city and suggested that less cars in the city centre and more pedestrian areas would make Leeds a better city for health and wellbeing. |
| Information | Some people told us that information about healthy activities in the city should be easier to find. People also want more information about how to self-care and stay healthy. |
| Environment | People told us that the environment they lived in was important to them and that they want more green spaces nearby. Some people raised concerns about smoking and asked for more smoke free areas in Leeds. |
| Healthcare | Many people are happy with the health services they receive in Leeds, but some people are unhappy with access to specialist services and waiting times (especially for GP surgery appointments). Many people told us that they want better mental health services in the city with improved access to counselling and shorter waiting lists. |
| Education | Some people told us that they would like to see local schools being more involved in promoting health and wellbeing with young people and parents. |
| Employment | Some people told us that they feel that there are not enough jobs in Leeds and that more should be done to create employment opportunities. |
| Housing | Some people told us that they want better housing in Leeds, especially for deprived communities and the homeless. |

Outer West Community Committee - Finance Report

Purpose of report

1. This report provides the Community Committee with an update on the budget position for the Wellbeing Fund, Youth Activity Fund, Capital Budget, as well as the Community Infrastructure Levy Budget for 2019/20.

Main issues

- 2. Each Community Committee has been allocated a wellbeing budget (revenue and capital) and Youth Activities Fund which it is responsible for administering. The aim of these budgets is to support the social, economic and environmental wellbeing of the area and provide a range of activities for children and young people, by using the funding to support projects that contribute towards the delivery of local priorities.
- 3. A group applying to the Wellbeing Fund must fulfil various eligibility criteria, including evidencing appropriate management arrangements and financial controls are in place; have relevant policies to comply with legislation and best practice e.g. safeguarding and equal opportunities and be unable to cover the costs of the project from other funds.
- 4. Wellbeing funding cannot be paid retrospectively. An application form must be submitted and approved by the Community Committee before activities or items being purchased through wellbeing funding are completed or purchased.
- 5. The amount of wellbeing funding provided to each committee is calculated using a formula agreed by Council, taking into consideration both population and deprivation of an area.

- 6. Capital (CRIS) injections are provided as a result of council assets being sold. 5% of the sale price (up to a maximum of £100k) of a council asset is pooled city-wide and redistributed to the Community Committee areas on the basis of deprivation. The Community Committee will receive a new capital injection every 6 months.
- 7. Each Community Committee has also been allocated a Community Infrastructure Levy budget. For each CIL contribution, Leeds City Council retains up to 70-80% centrally, 5% is needed for administration and 15-25% goes to be spent locally. The money will be vested with the local Town or Parish Council if applicable, or with the local Community Committee and spend decided upon by that body. This local money is known as the 'Neighbourhood Fund' and should be spent on similar projects to the Wellbeing Fund (capital).
- 8. In the Outer West Community Committee this means that the money for the Calverley & Farsley, Pudsey, Farnley & Wortley will be administered by the Outer West Community Committee.
- 9. It was agreed at Outer West Community Committee on the 22nd November 2017 that CIL monies for Calverley & Farsley, Pudsey, Farnley & Wortley would be spent in the ward it was generated in.
- 10. Projects eligible for funding by the Community Committee could be community events; environmental improvements; crime prevention initiatives, or opportunities for sport and healthy activities for all ages. In line with the Equality Act 2010, projects funded at public expense should provide services to citizens irrespective of their religion, gender, marital status, race, ethnic origin, age, sexual orientation or disability; the fund cannot be used to support an organisation's regular business running costs; it cannot fund projects promoting political or religious viewpoints to the exclusion of others; projects must represent good value for money and follow Leeds City Council Financial Regulations and the Council's Spending Money Wisely policy; applications should provide, where possible, three quotes for any works planned and demonstrate how the cost of the project is relative to the scale of beneficiaries; the fund cannot support projects which directly result in the business interests of any members of the organisation making a profit.
- 11. Any request for funding would involve discussions with appropriate ward members. Where projects do not have support from the Community Committee and are not approved, applicants are offered further discussions and feedback if this is requested.
- 12. In order to provide further assurance and transparency of all decisions made by the Community Committee, any projects that are not approved will be reported to a subsequent Community Committee meeting.
- 13. Sometimes urgent decisions may need to be made in between formal Community Committee meetings regarding the administration of wellbeing and youth activity budgets and also regarding the use of the Community Infrastructure Levy (CIL) Neighbourhood Fund which has been allocated to the Community Committee. Alongside the Committee, designated officers have delegated authority from the Director of Communities and Environment to take such decisions.

- 14. The Community Committee has previously approved the following 'minimum conditions' in order to reassure Members that all delegated decisions would be taken within an appropriate governance framework, with appropriate Member consultation and only when the following 'minimum conditions' have been satisfied:
 - a. consultation must be undertaken with all committee/relevant ward members prior to a delegated decision being taken;
 - b. a delegated decision must have support from a majority of the Community Committee elected members represented on the committee (or in the case of funds delegated by a Community Committee to individual wards, a majority of the ward councillors), and;
 - c. details of any decisions taken under such delegated authority will be reported to the next available Community Committee meeting for members' information.
- 15. Members are reminded that the necessary scrutiny of applications to satisfy our own processes, financial regulations and audit requires the deadline for receipt of completed applications to be at least five weeks prior to any Community Committee. Some applications will be approved via Delegated Decision Notice (DDN) following consultation with Members outside of the Community Committee meeting cycle.

Wellbeing Budget Position 2019/20

- 16. The total revenue budget approved by Executive Board for 2019/20 was £112,390. Table 1 shows a carry forward figure of £47,334 which includes underspends from projects completed in 2018/19. £28,150 represents wellbeing allocated to projects in 2018/19 and not yet completed. The total revenue funding available to the Community Committee for 2019/20 is therefore £131,574. A full breakdown of the projects approved or ring-fenced is available on request.
- 17. It is possible that some of the projects may not use their allocated spend. This could be for several reasons, including the project no longer going ahead, the project not taking place within the dates specified in the funding agreement, or failure to submit monitoring reports. Due to this the final revenue balance may be greater than the amount specified in Table 1.
- 18. The Community Committee is asked to note that there is currently a remaining balance of £12,837. A full breakdown of the projects is listed in Table 1 and is available on request.

20. Project Title: Drugs: The Truth

Name of Group or Organisation: Drug Watch Foundation
Amount proposed from Wellbeing Budget: £10,000

Project Description: Drug Watch Foundation (DWF) provides drug and alcohol awareness information packs and workshops to children up to 19 years in schools and colleges, across England and Wales, educating them about the dangers, laws, health and social implications of drug and alcohol abuse. DWF offers this service within the context of promoting active lifestyles, positive behaviours and building self-esteem amongst young people, with the aim of mitigating anti-social behaviour and the onset of health and well-being problems, including mental health. The number of beneficiaries that they can reach via this project is 16,500 and they aim to provide workshops to children in the above named wards via schools and colleges.

- 22. As part of their funding agreements, all projects which have had funding approved by the Community Committee are required to provide update reports on the progress of their project. These reports are so that the Community Committee can measure the impact the project has had on the community and the value for money achieved.
- 23. Detailed below is a project update that the Communities Team has received since the last meeting of the Community Committee in July 2019.

Name of project: Pudsey Carnival 2019

24. The Carnival was again extremely well attended, with a successful parade with floats based on the theme of 'SPACE' celebrating the 50th anniversary of the moon landing, followed by activities ,shows etc, on the field, which had a record number of stalls, many of them run by local community groups.

- 25. The weather was quite good and stayed dry, which helped to provide good audiences for the events running on the field, such as a Punch & Judy show, a dog show, free circus skills classes etc. as well as attractions such as the Raymond Eddy funfair and activities provided by Breeze from the localcouncil.
- 26. As usual many local organisations such as schools, youth groups and local charities were involved in the parade and on the field afterwards.

Youth Activities Fund Position 2019/20

- 27. The total available for spend in Outer West Community Committee in 2019/20, including carry forward from previous year, was £65,257.
- 28. The Community Committee is asked to note that so far, a total of £64,503 has been allocated to projects, as listed in **Table 2**.
- 29. The Community Committee is also asked to note that there is a remaining balance of £754 in the Youth Activity Fund. A full breakdown of the projects is available on request.

Outer West Community Committee - Update Report

Purpose of report

- To bring to members' attention an update of the work which the Communities Team is engaged in, based on priorities identified by the Community Committee. It also provides opportunities for further questioning, or to request a more detailed report on a particular issue.
- 2. This report provides regular updates on some of the key activities between Community Committee meetings and functions delegated to Community Committees, Community Champions roles, community engagement, partnership and locality working.

Main issues

Updates by theme:

Environment: Champion Cllr Amanda Carter – Update from Baz Ali & Lee Hayward

3. Farnley & Wortley

We have been utilising CCTV in areas in order to try to capture Fly Tipping within the wards throughout Farnley & Wortley. At present we haven't been successful with this and it would appear that a lot of people have become wise to NOT discarding items with personal details on them when bags of waste are deposited.

The team have helped all ward Councillors with regards individual service requests as well as requests for bins to be placed in certain areas which they have identified.

We continue to help residents/community groups who have been carrying out community litter picks by loaning litter picking tongs and also issuing refuse bags which we have then removed and disposed of once filled.

Our crews who are trained in the use of mechanical cutting equipment continue to proactively and reactively maintain ginnels and public areas around the farnley and Wortley ward cutting these and clearing the waste away to help open up these areas and hopefully help residents feel safe.

The new permanent crew for Farnley/wortley continuing to work at getting on top of what were problem areas and we seem to have seen a reduction in calls for service around Butterbowls etc. as we are able to get to jobs sooner.

We still work closely with housing and have been cutting and clearing many void properties so that tenants can move in and have a manageable garden to attend to.

Pudsey, Calverley & Farsley

We continue working to a seven day schedule as agreed with ward members. We proactively remove fly tips and have a few fly tipping cases moving forward to prosecution. We are exploring ways to deter fly tippers. We are working with ward members to promote proper disposal of waste to the residents of Leeds.

We have been working with a lot of volunteer groups when they wanted to carry out community litter pick. We have loaned them litter pickers. provided gloves, litter bags and arrange to dispose the collected waste.

Worked with the Pudsey Pacers before and after the race on the clean-up.

We worked with Highways to carry out edging in the Harley estate. Very good feedback from residents on how well it looks.

We have de-littered the side grass verges on the Stanningley bypass and Ring Road Dowson's corner to Rodley.

We work closely with the in bloom groups to combine resource to ensure we have a very thorough presentation when the judging takes place.

Community Safety: Champion Cllr Amanda Carter – Update from Insp Sarah Towers

4. West Neighbourhood Policing Team Staffing

1 x Insp 5 x Sergeants 16 x PC's 45 x PCSO's

5. Between 1st April and 30th June - this includes West Inner and Outer areas

West NPT attended **3,325** calls for service. This does not include the requests which come to us via email or from other partner agencies, or which officer may come across whilst on patrol. Submitted 630 pieces of Intelligence. Arrested 107 people and interviewed another 31 who attended voluntarily. Seized 82 vehicles. Stopped over 450 vehicles in traffic operations including for Speeding/ Seatbelt offences/ Mobile Phone/ No insurance. Executed in excess of 30 Warrants for a variety of offences

6. Youth ASB/ Criminal Damage/ Assaults - Pudsey Town Centre

Since the middle of last year, young people causing ASB and committing offences of Criminal Damage and Assault in the Town Centre area of Pudsey, has been an issue. In autumn last year, in conjunction with local Councillors, Metro, Youth Services, LASBT and Housing, we looked at different ideas about how to try and deter these young people from committing offences. A letter was sent out to the Parents of all children at the local High Schools, warning them about ASB and Youth Services gained some Council funding to run extra youth sessions. Overall there appeared to be a reduction in the reported issues.

However, in the last 2 months, the issues have arisen again. The intensity of the problem has increased, the level of offending has increased and the way of tackling the issues has had to change.

In July/August so far, 4 x Dispersal Orders have been signed, covering the Pudsey Town Centre Area; this gives Police to power to prevent people entering a certain area because we believe there will be anti-social behaviour in that area. If the Dispersal is breached, the person in breach can be arrested.

On one occasion, 2 x Police Community Support Officers have been assaulted. However, we have made significant progress, in arresting the main offenders on numerous occasions and working with Partners to look at longer term solutions to the issue.

7. Residential Location Farsley

We have received numerous calls for service to a residential area in Farsley, and had frequent contact with local Councillor's, Housing and LASBT to try and address the issues.

The issues appear to be are 2-fold. There are certain residents within this locality, who are committing offences and ASB. They are also encouraging the attendance of a group or groups of young people, who are then also committing ASB and offences in and around the area. Reported crimes of Criminal Damage, Assault, Possession of Offensive weapons; which have resulted in arrests.

2 male juveniles were arrested for assault, and we are currently assessing all the relevant calls and information, to ascertain if further work is needed. We are working with both Housing and the Anti-Social Behaviour Team to look at a longer term solution to the problems.

8. ASB/ Criminal Offences - Heights and Bawns

Although there has been vast improvements in the level of offending and a reduction in calls for Service to the Police; there are still a core group of mainly young people who

have continued to commit offences despite being dealt with by the Police and LASBT over a pro-longed period of time.

Many offenders now have Injunctions in place; these injunctions are designed to prevent the person to whom it applies from associating with certain other people or entering certain locations.

We have also become aware recently, of a new group of young people in the area of the Bawns, who are responsible for an increase in ASB. There have been large organised fights between some groups and officers were assaulted last weekend when arresting 3 females in the area.

Again, the details of all people involved have been acquired and Police action has been taken where appropriate. Details of young people locally have been passed to the Youth Service, and alternative provisions such as LED Sports – with the intention of diverting these young people away from offending.

Health and Wellbeing & Adult Social Care: Champion Cllr A Forsaith – Update from Jon Hindley

9. One You Leeds Summer Nutrition campaign 2019 – 22nd July – 22nd August

The aim of the summer nutrition campaign is to raise awareness of healthier meal options for adults in Leeds by delivering a local level campaign. There are 500 copies of OYL Recipes Cards as well as outreach activity on offer to support people to engage and consider healthier options.

OYL will be offering free Eat well and Cook well support, guidance on ways to cook more and eat better through outreach activity and opportunities on the One You Leeds website and links to the NHS guidance and apps.

Key Messages: How will YOU eat well this summer? The lengthening days and warmer weather provides a great opportunity to cook and eat well with friends and family. How will you eat well this summer?

Facilitated by Reed Momenta, a range of campaign materials will be available through these key channels:

Web advertising: Paid and organic content promoting easy ways to cook and eat well and a One You Leeds homepage campaign takeover.

Marketing Materials: Free recipe cards to support the campaign

Smoke Free Side-lines

Public Health have been working alongside Active Leeds and West Riding FA to introduce a smoke free side-lines initiative across the city. The initiative aims to create better health promoting environments, protect children and young people from tobacco smoke and provide them with a smoke-free environment at sport facilities.

Smoking is a significant cause of preventable deaths in Leeds and contributes to increasing health inequalities. Smoking is understood to often be a childhood addiction with evidence showing most adult smokers start smoking at a young age with 66% of smokers starting before they are 18. Young people are most at risk of becoming smokers themselves if they grow up in communities where smoking is the norm.

Smoke-free Side-lines is aimed at sports clubs and leagues and looks to support adults involved in sport and physical activity to understand their responsibility as positive role models. It is about promoting a sports club as a healthy and inclusive place, where the wellbeing of all, but particularly children and young people, is a priority.

It is planned to launch the Smoke-free side-lines initiative in Leeds (and other West Yorkshire areas) in September 2019, coinciding with the new football season and school year. Bespoke digital infographic posters are currently being developed for each local authority in West Yorkshire to support and promote the initiative.

Update on projects

Youth Project.

The Tenant Engagement Officer worked in partnership with Youth services who were successful in securing funding from Community Committee NIP fund. In order to run a yearlong youth project from Hillside Community Hall. The aim of the Youth Project is to provide a safe place for all young people to enjoy social and leisure activity that is stimulating, diverse and engaging for youth aged 11- 17yrs.

The take up of these sessions has been successful and there are 15 to 20 young people attending each session.

Outdoor Emergency First Aid Course.

Outer West Housing Advisory Panel funded a Outdoor Emergency First Aid Course for young people. The first aid course was successful and ran at full capacity with 12 young people aged 14 plus participating. This has now been completed and was very successful discussions are taking place with Youth service to mirror the same project in the Heights area.

Bawn's & Heights Fun Day -Due to the success of last year's first ever fun day in the area. The Community Committee and Outer West HAP each part funded the community fun day for this year. The Community fun day was held on Tuesday 13th

August 12 to 4pm it turned out that it was the only dry day that week and was well attended by partners and community.

Local residents came along took part in some fun activities and the talent completion also getting information from service providers ie Debt Forum, Forward Leeds, Children's Centre, Police, LASBAT, Housing Leeds and many more.

Digital Inclusion project Tenant Engagement Officer worked in partnership with Armley Helping Hands to secure funding for this project from Community Committee funding set aside for the Neighbourhood Improvement Area.

The proposal is to work with local residents to help improve their IT skills using the Learn My Way platform. Also the project will support local residents to apply for employment using online job sites which will also entail developing a comprehensive CV and the end of the project 4 computers will be donated to the community centre. The first session started Tuesday 3rd September 2019 at Hillside Community Hall.

BARCA voluntary sector organisation

BARCA are looking to deliver services in the Heights & Bawns area under their umbrella of the Better Together Programme re Health & Wellbeing activities. This is in the early stages of discussion and progress will be reported at later stage.

Your Back yard – Voluntary Sector Organisation

Tenant Engagement Officer had discussion with the organisation to do some work in the area. Carried out a site visit of the Bawns & Heights with the Director of Your Back Yard and highlighted the issues in the area. .

Your Back Yard was successful in securing funding from the monies set aside for NIP by Community Committee.

Supported Your Back Yard to apply for funding from the NIP pot to deliver a programme of activities and interventions aimed at improving people's physical health, and wellbeing, across the Heights and Bawns area, for all ages and sectors of the community, drawing together and building on existing provision. Your Back Yard has successfully secured the funding for this project. Tenant Engagement Officer will work in partnership and they will be invited to the NIP to provide update on the work carried out in the area.

Premises - Challenges

One of the major concerns is that there are no appropriate venues to run activities from in the area especially on the Heights estate. At present the Hillside Community Hall is used for the Bawns estate.

Updates from Key Services

- 16. Council services have weekly room bookings to accommodate the community so that they do not have to travel into Leeds.eg Register, Leeds Housing Options, Money Buddies, MABS, Credit Union, Welfare rights, One You Leeds.

Jet2.


Having said that, all posts can be read without any further interaction!!

The following are screenshots of the most popular three posts since the 26th June. Alongside it are the figures for how many people were 'reached' and how many people 'engaged' with the post.


1st Place – 13,284 people had this post delivered to them and it had 209 post clicks, with **84** likes, comments and shares.


