11 White Paper Motion (in the name of Councillor Andrew 109 - 110 Carter) - Transport in the City

This Council is concerned by recent and repeated examples of gridlock and heavy congestion in the City Centre, leading to significant disruption to commuters as they travel in and out of Leeds.

Council notes the investment being made through Connecting Leeds, including the £173.5m granted by Government, but believes that to get the city moving and to encourage greater growth and productivity a new approach to public transport, not wholly reliant on the bus, is required.

This Council therefore welcomes the Government commitment to spend \pounds 4.2bn on public transport projects outside of London and notes that some of this funding is planned for the Leeds district.

Council believes this offers a new opportunity to deliver a mass transit scheme for the city which will deliver obvious economic benefits as well as significantly reducing the city's carbon emissions in line with the declared Climate Emergency.

Council further believes that all areas of the city should be considered for mass transit infrastructure and is concerned that existing WYCA proposals seem to omit North Leeds, and the potential links to Harrogate, York and Wetherby, from any new transport infrastructure plans.

In light of this announcement made during the election campaign, this Council calls for a report to be brought to the March Executive Board meeting setting out detailed plans as to how a new mass transit scheme can be delivered to all communities in the city and to include analysis of the potential benefits such a scheme would deliver in terms of reducing the carbon footprint in Leeds.

12 White Paper Motion (in the name of Councillor D Blackburn) - Public Transport

Council notes the current uncertain situation with regard to First Bus and other bus operators in West Yorkshire, and believes that the way forward is for West Yorkshire Combined Authority to take over the running of these operations.

Council also believes that appropriate funding should be made available to bring back into operation disused rail infrastructure, such as unused track, and the re-opening of many of the former local railway stations closed many years ago, such as the one in Wortley and the two in Armley.

It is Council's view that only with vibrant publicly owned bus services, running in the interest of the passenger, and expanded local rail services can Leeds (or for that matter, West Yorkshire) achieve a 21st Century public transport system that delivers for its citizens, helps to reduce congestion and is consistent with the aims of the Climate Emergency.

Council also notes that Prime Minister Boris Johnson has stated that he will transform transport in the North. Bearing this in mind Council, therefore, calls on the Chief Executive to write to the Prime Minister asking for the Government to support these aspirations, both in actions and funding.

13 White Paper Motion (in the name of Councillor Charlwood) - 113 - 114 Funding for Services

Council is proud of its record delivering high quality social care services for adults and children in Leeds, as well as delivering more affordable housing for Leeds residents and providing more school places.

Council believes it is held back from making further improvements in these areas by a lack of action from central Government. Council was disappointed that the Government failed to use the recent Queen's Speech to put forward plans to address the national social care, school buildings or housing crises.

Council therefore requests the Prime Minister use his upcoming budget to provide funding to tackle the social care, school buildings and housing crises, and to thereby enable the council to make further improvements to these services for the people of Leeds.

It was moved by Councillor Andrew Carter, seconded by Councillor Wadsworth that this Council is concerned at the administration's proposals to close Temple Newsam golf course.

Temple Newsam and its wider estate is a key asset for the city. Council is disappointed at the limited scope of the report considered by the Executive Board in October containing, as it did, only one option in relation to the development of facilities at Temple Newsam. Council is also concerned that the final decision on this important issue would have been left to council officers, via delegated decision, had it not been for the intervention of the Leader of the Opposition.

Council notes reports from golf club members that all but essential maintenance works on the golf courses have ceased. Council believes that this seriously undermines the consultation process as it suggests that a decision has already been taken about the future of golf at Temple Newsam.

This Council believes that that there is sufficient scope for both golf and other facilities, including cycling, to be developed at Temple Newsam and calls for the proposals to close the golf facilities to be reversed with immediate effect.

Council believes this is a direct result of the ruling administration's Treasury Management policy and notes with alarm the projections contained in the Medium Term Financial Strategy presented to Executive Board in July 2019 that 22% of the net revenue charge will be used on debt repayments, based on the 2019/20 revenue budget this amounts to £113m per year.

Council therefore calls on the ruling administration, through a communication in forthcoming bills, to be open and transparent with Leeds Council Tax and Business Rate payers by clearly explaining that in under three years' time 22% of the local tax they pay will be spent on servicing debt.'

Summary

1. Main issues

- Each year, under the Local Government Finance Act 1992, Leeds City Council is required to calculate a council tax base for Leeds and for each parish or town council within the Council's area. These tax bases are used to calculate the council tax to be levied in Leeds and in each parish/town council for the year.
- There is also a requirement for the Council to prepare an estimate of business rates income it will collect in the coming year.
- The detailed figures are set out in the main body of the report, but the headline amounts for 2020/21 are as follows:

Leeds Council Tax Base:	231,377.6
Business Rates ¹ :	
Amount to be retained by Leeds under the Rates Retention scheme:	£184,690,000
Amount to be paid to Central Government:	£188,460,000
Amount to be passed to West Yorkshire Fire and Rescue Authority	£3,770,000

¹ Note: these amounts are indicative at this stage, they will finalised when the NNDR1 return is completed – see Section 3.4.

- The Council is required to finalise the council tax bases (for Leeds and the parish/town councils) and the business rates estimates by 31st January 2020.
- 2. Best Council Plan Implications (click here for the latest version of the Best Council Plan)
 - The Best Council Plan is the Council's strategic plan which sets out its ambitions, outcomes and priorities for the City of Leeds and the Local Authority.
 - This report will inform the development of the budget for 2020/21. The budget process seeks to ensure that financial resources are used to support the Council's policies and priorities.

3. Resource Implications

- This report requests that Council approve the 2020/21 council tax base for Leeds and the parish/town councils set out in the report. This report also provides an indicative business rates share for 2020/21. These items are used to identify the Council's Net Revenue Budget for 2020/21.
- This is a financial report and the financial and resource implications are detailed in the main body of the report.

Recommendations

Members are requested to:

- a) Agree that, in accordance with the Local Authorities (Calculation of Tax Base) (England) Regulations 2012, the amount calculated by the Council as its council tax base for the year 2020/21 shall be 231,377.6 for Leeds and for each parish as listed in Section 3.3, and detailed in Appendix 1;
- b) Agree to the increase of the empty homes premium on long term empty properties which have been unoccupied for over five years from 100% to 200%, as detailed in **Section 3.2**;
- c) Note the indicative business rates shares set out in **Section 3.4**, and delegate authority to the Chief Officer Financial Services to make the detailed calculations and to submit the final figures to the Ministry of Housing, Communities and Local Government on or before 31st January 2020.

1. Purpose of this report

- 1.1 The purpose of this report is to:
- 1.1.1 Seek agreement to the 2020/21 council tax bases for Leeds and the parish/town councils set out in the report;
- 1.1.2 Provide indicative business rates shares for 2020/21 and to request Council to give delegated authority to the Chief Officer Financial Services to finalise the shares and to submit them in the National Non-Domestic Rates 1 Return 2020/21 on or before 31st January 2020.

2. Background information

- 2.1 From 2013/14 the Government made major changes to the funding regime for local government. The long-established formula grant system, where funding depended upon local needs and resources, was replaced by a system based upon the capacity to deliver housing and business growth.
- 2.2 At the same time a number of council tax exemptions were removed and council tax benefit was replaced by the Council Tax Support scheme (CTS). In 2013/14 government funding for CTS was reduced by 10% compared to the previous year, and for 2014/15 onwards funding from Government has no longer been separately identifiable.

3. Main issues

3.1 Council Tax Support Scheme

- 3.1.1 The council tax support scheme operates as a discount on the same basis as other discounts currently in place, with protected groups currently receiving a 100% discount. At its December 2016 meeting, Executive Board agreed to recommend to Full Council the replacement of the previous Council Tax Support Scheme with a scheme aligned with Universal Credit. Full Council supported the adoption of the proposed scheme at its January 2017 meeting, with it taking effect from 1st April 2017. Customers now move on to this new scheme when they transfer to Universal Credit, at which time eligible customers will move off the scheme of automatic protections. Non-protected recipients of council tax benefit continue to be required to pay 25% of their council tax bills.
- 3.1.2 The localisation of CTS has the effect of reducing the overall tax base for Leeds. Based on the current scheme, as outlined in **Section 3.1.1**, the tax base will be reduced by 30,399.4 Band D equivalent properties for 2020/21.

3.2 Empty Homes Premium

- 3.2.1 Under section 11B of the Local Government Finance Act 1992, from 1st April 2013 to 31st March 2019 Leeds City Council charged a 50% council tax premium on empty dwellings that have been unoccupied for more than two years. The Rating (Property in Common Occupation) and Council Tax (Empty Dwellings) Act 2018, which received Royal Assent on 1st November 2018, permitted councils to increase this premium on dwellings unoccupied for more than two years to 100% from 1st April 2019.
- 3.2.2 In respect of the financial year 2020/21, from 1st April 2020 the Act permitted that from this date the maximum premium is 200% in respect of any dwelling where the empty period is at least 5 years. Additionally, from 2021 the maximum premium is 300% in respect of any dwelling where the empty period is at least 10 years. The estimated change in the Council Tax base for these initial budget proposals assumes that this additional premium in 2020/21 will be implemented.
- 3.2.3 Full Council are requested to agree to implement the changes in respect of 2020/21, specifically, to charge a 200% premium on any dwelling where the empty period is at least 5 years.

3.3 Calculation of Council Tax Base

3.3.1 Under the Local Government Finance Act 1992 and accompanying regulations, detailed procedures are laid down for calculating the tax base which will be used for

calculating council tax. The tax base for the Leeds area is expressed as the number of Band D equivalent properties and will be used both to calculate Leeds City Council's element of council tax and to notify to the West Yorkshire Police and Crime Commissioner and the West Yorkshire Fire & Rescue Authority for them to calculate their own elements of council tax. The Police and Crime Commissioner and the Fire & Rescue Authority have to be notified of the tax base by 31st January 2020.

- 3.3.2 In addition to calculating the tax base for the Leeds area as a whole, a separate tax base has to be calculated for each part of the Council's areas to which a "special item" of expenditure relates. In Leeds, it is considered that only parish precepts should be treated as special items for these purposes and a tax base is therefore also calculated for each parish/town council.
- 3.3.3 In calculating the parish tax bases for 2020/21, it emerged that a housing development had been incorrectly recorded in Boston Spa Parish. In the 2020/21 parish tax base this has now been moved to Clifford Parish and Council Tax records updated accordingly. The two parishes have been notified of this change.
- 3.3.4 Details of the calculations for Leeds as a whole and for each individual parish are given in **Appendix 1**. In summary, the council tax base for Leeds is calculated at 231,377.6 Band D equivalent properties. This is calculated estimating changes from the Valuation Office Agency's Valuation List that will take place during 2020/21 by reference to the following:
 - provision for successful appeals,
 - provision for exempt properties,
 - changes in number of properties (demolitions and new additions),
 - estimated single person and other discounts,
 - and estimated collection rate.
- 3.3.5 The equivalent amount for each of the parishes are:

3.3.6 The council tax requirement for 2020/21, which will be decided by Council in February 2020, will be divided by the calculated council tax base to arrive at the council tax for a Band D property, from which the council taxes for other valuation bands will be calculated.

3.4 Business Rates

3.4.1 Under the current Business Rates Retention Scheme, introduced by the Local Government Finance Act 2012, the Council has to calculate the amounts of business rates it will collect in 2020/21. Under this scheme, the Business Rates

collected have to be shared between Leeds itself, Central Government and the West Yorkshire Fire and Rescue Authority in the following proportions:

- 50% passed to Central Government;
- 49% retained by Leeds;
- 1% passed to West Yorkshire Fire and Rescue Authority
- 3.4.2 The headline amounts are currently estimated as follows:

•	Total Business Rates collected	£376,920,000
	Of which:	

- To be paid to Central Government £188,460,000
- To be retained by Leeds £184,690,000
- To be passed to West Yorkshire Fire and Rescue Authority £3,770,000
- 3.4.3 In 2019/20 Leeds City Council are part of the North and West Yorkshire Business Rates Pool Pilot. This pilot and others like it, were intended to foreshadow the introduction of 75% business rates retention nationally in 2020/21. After the one year Spending Review, announced by the Chancellor of the Exchequer on 4th September 2019, it became clear that 75% retention nationally would be delayed by another year to 2021/22. As a result these pools would return to the rules governing 50% retention.
- 3.4.4 The Ministry of Housing Communities and Local Government (MHCLG) then invited authorities to indicate their preferred pooling arrangements for the financial year 2020/21. Following discussions with NWY Pool member authorities, 13 of the 14 original member authorities agreed to submit an application for a business rates pool. Due to the legislation surrounding the designation of business rates pools, this process included requesting the revocation of the existing 2019/20 North and West Yorkshire Pool and the designation of a new North and West Yorkshire Pool for 2020/21. This application was submitted on the 25th October 2019 and we were informed that it was successful on 19th December.
- 3.4.5 Under the 50% scheme the advantage of forming a business rate pool will only be the retention of levy payments within the region that would otherwise have to be made to central government. Whilst this is significantly below the financial gain from 75% retention, we estimate the gains to the region could be around £9.6 million. Leeds City Council's financial commitment will be in the region of £2.0 million, whether to a levy pool or to central government. The headline business rates amount in this report include this financial commitment.
- 3.4.6 Whilst the business rates income presented at **Section 3.4.2** takes into account the estimated business rates retention at 50%, the actual amounts for 2020/21 will differ as they will be calculated using MHCLG's *National Non Domestic Rate Return 1* (NNDR1) which has to be completed and sent back to DCLG by 31st January 2020. The return has only just been received and the updated data required to complete it will not be available until the middle of January.
- 3.4.7 The final estimated amount to be retained for Leeds will be used in the development of the 2020/21 budget which is to be considered by Executive Board on 12th February and agreed by Council on 26th February.

4. Corporate considerations

4.1 Consultation and engagement

4.1.1 The matters set out in this report are purely factual and arise from calculations made using internal council tax and business rates records. As such, they are not subject to consultation or engagement.

4.2 Equality and diversity / cohesion and integration

4.2.1 The information contained in this report will inform the development of the 2020/21 budget which will be considered by Executive Board on 12th February, and agreed by Council on 26th February. The report itself has no specific implications for equality, diversity, cohesion or integration. A screening assessment has been carried out and is appended to this report at **Appendix 2**.

4.3 Council policies and the Best Council Plan

4.3.1 As outlined above, this report will inform the development of the budget for 2020/21. The budget process seeks to ensure that financial resources are used to support the Council's policies and priorities.

Climate Emergency

4.3.2 There are no implications for the climate emergency resulting from this report.

4.4 Resources, procurement and value for money

4.4.1 This is a financial report and the financial and resource implications are detailed in the main body of the report.

4.5 Legal implications, access to information, and call-in

4.5.1 The decisions requested in this report will enable the City Council to fulfil its responsibilities under the Local Government Finance Act 1992 and the Local Government Finance Act 2012 in relation to council tax discounts and exemptions. The decisions relating to council tax bases and business rates estimates will enable the Council to finalise its budget and set a legal council tax for 2020/21.

4.6 Risk management

4.6.1 The risks associated with the council tax base and the business rates estimates will be assessed as part of the budget-setting process and will be included in the budget proposals to be considered by Executive Board and Council in February.

5. Conclusions

- 5.1 The Council Tax Base for Leeds has been calculated in accordance with the Local Authorities (Calculation of Tax Base) (England) Regulations 2012.
- 5.2 The calculation includes estimated changes from the Valuation Office Agency's Valuation List that will take place during 2020/21.

- 5.3 As detailed in **Appendix 1** the amount calculated by the Council as its council tax base for the year 2020/21 shall be 231,377.6 for Leeds and for each parish as listed in **Section 3.3** above.
- 5.4 The headline amounts for Business Rates included in this report are estimated pending completion of the NNDR1 form on 31st January 2020.

6. Recommendations

- 6.1 Members are requested to:
- 6.1.1 Agree that, in accordance with the Local Authorities (Calculation of Tax Base) (England) Regulations 2012, the amount calculated by the Council as its council tax base for the year 2020/21 shall be 231,377.6 for Leeds and for each parish as listed in Section 3.3, and detailed in Appendix 1;
- 6.1.2 Agree to the increase of the empty homes premium on long term empty properties which have been unoccupied for over five years from 100% to 200%, as detailed in **Section 3.2**;
- 6.1.3 Note the indicative business rates shares set out in **Section 3.4**, and delegate authority to the Chief Officer Financial Services to make the detailed calculations and to submit the final figures to the Ministry of Housing, Communities and Local Government on or before 31st January 2020.

Further to Minute No. 89, 16th October 2019, the Chief Executive submitted a report which provided a further update on the preparations being made by Leeds City Council regarding the UK's exit from the European Union.

Responding to a previous request, the inclusion within the submitted report of a section regarding the agricultural sector was acknowledged, whilst a comment regarding the appropriateness, or otherwise of submitting a report on the UK's exit from the European Union for Member's consideration during the purdah period was noted.

RESOLVED -

- (a) That the continued work being undertaken to prepare the Council and the city for the UK's exit from the European Union, together with the ongoing concerns which exist regarding the lack of clarity about the nature of the exit from the EU, be noted;
- (b) That the contents of the strategic response plan, as attached at Appendix A to the submitted report, together with the updates provided in the submitted cover report, be noted, with it being recognised that assumptions and planning will continue to develop as new information becomes available.

HEALTH, WELLBEING AND ADULTS

104 Enhancing Access to Community Public Access Defibrillators in Leeds The Director of Adults and Health submitted a report which outlined the benefits associated with Community Public Access Defibrillators (CPADs) and provided details of the current provision of them across the city. The report also sought a number of approvals including the proposed approach towards the allocation of CPADs, the raising of community awareness and the training of communities on Basic Life Support and the use of the CPADs.

The Chair welcomed Councillor Khan to the meeting. Councillor Khan had been invited to attend the Board on behalf of Councillor R Charlwood, who had submitted her apologies for absence from the meeting. Councillor Khan introduced the submitted report to the Board. Responding to a Member's enquiry regarding the recommended distances between defibrillator locations, the Board was advised that the relevant guidance had been taken into account when considering the location of CPADs within Wards, and that the identification of Wards had been based upon ensuring that each Ward had a minimum of 4, with additional allocation to those Wards judged to have a higher need based upon the criteria used. It was also noted that the location of CPADs within Wards would be determined in collaboration with the Yorkshire Ambulance Service and Ward Members.

The Board also acknowledged the importance of the work which continued to take place across the city via a range of organisations and sectors to enhance the provision of defibrillators in their local area, which complemented the CPAD programme. A Member highlighted their hope that in addition to the CPAD initiative, liaison would take place with organisations who were putting defibrillators in place in the future so that the public accessibility of those units was maximised.

The importance of the awareness raising and training proposed as part of the CPAD programme was also emphasised.

RESOLVED –

- (a) That the contents of the submitted report, be noted;
- (b) That the proposed allocation of 54 Community Public Access Defibrillators to ensure that every Ward has a minimum of 4, with additional allocation to Wards with highest cardiac arrest and low bystander cardiopulmonary resuscitation rates and highest early deaths from circulatory disease, be agreed;
- (c) That the approach to allocate a short term project support worker, working with the Communities and Environment directorate to support: the allocation of the Community Public Access Defibrillators, community awareness raising and training through the Yorkshire Ambulance Service, be agreed;
- (d) That it be noted that the Communities and Environment directorate will lead the implementation of the programme, working closely with Ward Members and with advice and guidance from the Adults and Health directorate.

CHILDREN AND FAMILIES

105 Thriving: The Child Poverty Strategy for Leeds

The Director of Children and Families submitted a report presenting for the purposes of approval the Child Poverty Strategy for Leeds, entitled, 'Thriving'. In addition, the report provided an overview of the range of ongoing work being undertaken across the city aimed at mitigating the impact of poverty for children and young people.

By way of introduction to the report, Members received a detailed introduction to the range of initiatives being undertaken in this area, with a proposal that further reports would be submitted in due course providing an update on the progress being made.

Members commended the work of the 'A Different Take' Leeds Panel comprising young people, young adults and parents, specifically with respect to the production of their 'More Snakes than Ladders' report.

In response to an enquiry, it was proposed and agreed that update reports would be submitted to the Board on a quarterly basis providing quantifiable information on the progress being made by the work streams undertaken as part of the strategy, with it being noted that some of the data, by its very nature, would only be available on a periodic basis.

Responding to a comment regarding the timeframes associated with the implementation of some initiatives, emphasis was placed upon the importance of ensuring that such schemes were sustainable and fully met the needs of the community. Providing further response, it was acknowledged that although academic data was sought in some instances when establishing initiatives to ensure an evidence based approach, it was highlighted that the delivery of such initiatives was also informed by those living in poverty.

A Member's comment regarding the need for local Ward Councillors to be kept informed of the related activities taking place in their respective areas was acknowledged, with an undertaking that greater communication with Ward Members would take place in future.

Emphasis was also placed upon the need for the correct balance to be found between a quantitative and qualitative approach, with the ability to be able to provide overarching citywide data on the progress being made, whilst at the same time still maintaining the ability for initiatives to be delivered in a child focussed and localised way.

The importance of striking the correct balance was further highlighted, as it was seen as key to successfully delivering schemes, when tackling hunger for example, by providing food to those young people who needed it without any of the associated stigma, whilst at the same time also looking to provide them with an opportunity to have fun and improve their wider wellbeing.

RESOLVED –

- (a) That the Child Poverty Strategy for Leeds (2019-2022) entitled, 'Thriving', as appended to the covering report, be approved;
- (b) That the strategic framework which is in place to tackle child poverty, together with the work being undertaken by the Council and its partners in the key areas of activity, be noted;

(c) That it be noted that the officer responsible for the implementation of the strategy is the Chief Officer, Partnerships and Health by December 2022.

106 Children and Families - Strengthening Families, Protecting Children Programme

The Director of Resources and Housing submitted a report regarding proposals which would enable the Council to take a lead role in national improvement programmes and at the same time ensure that there was sufficient leadership capacity to maintain the Council's own position whilst supporting other Authorities.

Members welcomed the submitted report and the recognition that Leeds had received in this area. The Board also welcomed the framework in the submitted report which looked to meet the challenge of ensuring that the Council continued to successfully support the children and young people of Leeds in addition to those in other designated Authorities.

RESOLVED -

- (a) That the proposals, as set out within the submitted report, be approved, specifically with the following being agreed:-
 - To formally accept the Department for Education's 'Strengthening Families, Protecting Children' funding offer;
 - (2) The establishment of a 'Strengthening Families, Protecting Children' team including a Programme Director post, which will operate at Director level;
 - (3) The flexible deployment of the current Director of Children and Families to the post of Programme Director;
 - (4) The appointment of a temporary Director of Children and Families, subject to the decisions of the Employment Committee;
 - (5) To review these arrangements in 12 months' time.
- (b) That as a result of the resolutions (above), it be noted that the Chief Officer HR will, during December 2019 make the necessary arrangements to implement resolutions (a)(2) (a)(4), with it also being noted that the Chief Officer HR will undertake a review of these arrangements in December 2020.

LEARNING, SKILLS AND EMPLOYMENT

107 Proposal to acquire the Rose Court site for additional Special Educational Needs (SEN) places from September 2021

The Director of Children and Families and the Director of City Development submitted a joint report which set out details of a proposal brought forward to meet the local authority's duty to ensure a sufficiency of learning places including provision for children and young people with Special Educational Needs and Disabilities (SEND). Specifically, the report detailed the proposal to purchase Rose Court (the former Girls Grammar School site) to deliver a new special free school from September 2021. A Member enquired whether this proposal for the Rose Court site together with other actions being taken regarding SEND provision would mean that the proposal for the Elmete Wood site (Minute No. 108 refers) would not be required. In response, the rising demand for Education Health and Care Plans and SEND provision was highlighted, and it was confirmed that the capacity which would be provided by both proposals was deemed to be necessary, and that it would enable the Authority to keep pace with demand and would look to provide parents and young people with an element of choice.

Following the consideration of Appendix 1 to the submitted report, designated as being exempt from publication under the provisions of Access to Information Procedure Rule 10.4(3), which was considered in private at the conclusion of the meeting, it was

RESOLVED –

- (a) That the proposal for the Council to enter into draft Heads of Terms for the purchase of Rose Court from The Grammar School at Leeds, as set out in exempt Appendix 1 to the submitted report, be approved;
- (b) That the necessary authority be delegated to the Director of City Development, to enable the Director, with the concurrence of the Executive Member for Resources and the Executive Member Learning, Skills and Employment to agree the final terms of the purchase;
- (c) That it be noted that a public consultation exercise on the proposal to open a new special free school on the Rose Court site through the free school presumption route, will be required, which will be delivered by the Sufficiency and Participation Team, with it also being noted that a report will be submitted to a future Executive Board detailing the outcome of that consultation process.
- **108 Proposal to establish a new special free school on the Elmete Wood Site** The Director of Children and Families submitted a report regarding a proposal brought forward to meet the Local Authority's duty to ensure a sufficiency of learning places including provision for children and young people with Special Educational Needs and Disabilities (SEND). Specifically, the report presented the outcome of a consultation exercise regarding a proposal to establish a new 200 place special free school on the Elmete Wood site following Leeds City Council successfully securing funding through Wave 2 of the Special Educational Needs / Alternative Provision free schools funding provision.

It was confirmed that correspondence had been received by Board Members from a member of the public in advance of the meeting with regard to this proposal, with it being undertaken that an appropriate response would be provided to that individual.

A Member enquired whether the proposal for the Rose Court site (Minute No. 107 refers) together with other actions being taken regarding SEND provision would mean that this proposal for the Elmete Wood site would not be required. In response, the rising demand for Education Health and Care Plans

and SEND provision was highlighted, and it was confirmed that the capacity which would be provided by both proposals was deemed to be necessary, and that it would enable the Authority to keep pace with demand and would look to provide parents and young people with an element of choice.

Responding to a Member's enquiry, it was confirmed that although the proposed scheme would be delivered and funded by the Department for Education, the Council would be responsible for providing funding to deliver the access solution designed to address highways planning conditions relating to the scheme.

RESOLVED –

- (a) That the outcome of the consultation exercise on the proposal to establish a new 200 place special free school on the Elmete Wood site, as detailed within the submitted report, be noted;
- (b) That it be noted that the Department for Education is delivering and funding the capital costs of the scheme under the provisions of Wave 2 – Special Educational Needs/Alternative Provision (SEN/AP) free schools funding;
- (c) That under the specific conditions of the funding bid, approval be given to the transfer of the Elmete Wood site under a 125 year peppercorn lease without premium to the successful sponsor identified through the free school presumption process;
- (d) That it be noted that within the related funding conditions Leeds City Council must meet any associated highways costs required under planning, in addition the Local Authority must meet any ground abnormal costs where remediation is required under planning, with it also being noted that once these costs are determined, 'authority to spend' will be sought through a design and cost report;
- (e) That it be noted that the successful sponsor will be determined by the Secretary of State following an assessment and interview process, with the announcement on the successful sponsor expected to be made in February 2020;
- (f) That it be noted that the responsible officer for the implementation of such matters is the Head of Learning Systems.

RESOURCES

109 Capital Programme 2019/20 - 2022/23: Quarter 2 Update

The Chief Officer (Financial Services) submitted a report providing an update on the Capital Programme position as at Quarter 2 of the financial year. In addition, the report also sought some specific approvals in relation to funding injections.

RESOLVED –

- (a) That the latest position on the General Fund and Housing Revenue Account (HRA) Capital Programmes, as at quarter 2 of the financial year and as detailed within the submitted report, be noted;
- (b) That the net increase in the General Fund and HRA Capital Programme 2019-2023 of £115.2m since the Capital Programme setting in February 2019, be noted, with it also being noted that these injections and movements are listed in Appendix D to the submitted report and that £21.3m of schemes require injection approval as part of this report;
- (c) That it be noted that the borrowing required to fund the Capital Programme in 2019-20 has reduced by £52.6m since the Capital Programme setting in February 2019, with it also being noted that the Capital Programme remains affordable within the approved debt budget for 2019-20, and that further work is underway through regular Capital Programme reviews to ensure that future debt costs are maintained within the overall medium term financial strategy;
- (d) That the following £21.3m worth of injections into the Capital Programme, as set out below and as detailed within Appendix D to the submitted report, be approved:-
 - £7.347m East Leeds Orbital Road additional grant from WYCA
 - £2.814m Devolved Formula Capital (DFC) additional grant from govt
 - £2.376m NE Leeds Junction Improvements, grant from WY+TF
 - £2.062m HRA net revenue contributions

110 Treasury Management Strategy Update 2019/20

The Chief Officer, Financial Services submitted a report providing a review of, and update on the Council's 2019/20 Treasury Management Strategy.

RESOLVED – That the update on the Treasury Management borrowing and investment strategy for 2019/20, as detailed within the submitted report, be noted.

111 Financial Health Monitoring 2019/20 - Month 6

The Chief Officer, Financial Services submitted a report which set out the Council's projected financial health position for the 2019/20, as at Month 6 of the financial year.

Responding to a Member's enquiry regarding the compensation to be paid by Veolia to the Council for not meeting contracted recycling targets, it was noted that this projected sum had been incorporated into the Council's budget assumptions. Also, it was highlighted that discussions were ongoing with Veolia regarding the level of compensation to be received and with DEFRA (Department for Environment, Food and Rural Affairs) regarding how such compensation could be invested to assist with the future achievement of recycling and waste management targets, with it being undertaken that when an agreement had been reached with DEFRA, the matter would be reported to Members of Executive Board.

Regarding the Children and Families directorate, a Member highlighted the current position in terms of External Residential (ER) placements and enquired whether it would assist the position if the Council further invested in its own accommodation provision. In response, it was highlighted that investment had taken place in children's homes in Leeds through an extensive refurbishment programme which had meant the temporary closure of some homes whilst works took place. It was noted however that newly refurbished homes were beginning to come back on stream and it was hoped that this would further reduce the need for ER placements. As such, it was believed that extra capacity in this area was not currently needed, a position that would continue to be reviewed as appropriate.

Also, responding to an enquiry regarding the loss of fee income from Children's Centres, it was highlighted that there was a plan in place to address this, which included a rebranding and marketing exercise for the centres, a review of the infrastructure with the aim of making the buildings more appealing as venues and work which was being undertaken to ensure that the correct balance of staffing was achieved at each centre.

RESOLVED -

- (a) That the projected financial position of the Authority as at Month 6 (September 2019) of the financial year, be noted;
- (b) That with regard to the risk that the budgeted level of capital receipts may not be receivable in 2019/20, the progress made to date on such matters, together with the fact that work is ongoing to identify budget

savings proposals that will contribute towards the delivery of a balanced budget position in 2019/20, be noted.

112 Disposal of land located on Seacroft Crescent, Killingbeck and Seacroft, for Extra Care Housing delivery and final terms of Development Agreement

Further to Minute No. 131, 19th December 2018, the Director of Adults and Health, the Director of City Development and the Director of Resources and Housing submitted a joint report which sought approval to dispose of a Council owned site on Seacroft Crescent in Killingbeck and Seacroft Ward to facilitate the development of new Extra Care housing provision in support of the Better Lives Programme.

RESOLVED –

- (a) That it be noted that the Director of City Development, in consultation with the Executive Member for Resources, will progress with the disposal of the subject land;
- (b) That approval be granted to enter into the Development Agreement with the consortium;
- (c) That approval be granted for any subsequent amendments to the terms of the disposal being delegated to the Director of City Development for his consideration and approval under the scheme of officer delegation, in consultation with the Executive Member for Resources.

CLIMATE CHANGE, TRANSPORT AND SUSTAINABLE DEVELOPMENT

113 City Connect 3 Leeds Package - Segregated Cycleways at Dewsbury Road (Phase 3), Elland Road and Clay Pit Lane

The Director of City Development submitted a report which sought approval for the design and delivery of a package of 3 schemes to provide segregated cycleways linking to Leeds City Centre. Specifically, the proposed cycleways were to run along Clay Pit Lane, Dewsbury Road and Elland Road. The schemes form part of the Combined Authority's 'City Connect 3' package of improvement to cycle infrastructure in West Yorkshire.

In noting that the proposals within the submitted report were to be fully funded by the West Yorkshire Combined Authority's (WYCA) City Connect programme, a Member sought an update on the current position regarding the outstanding WYCA funding in respect of phase 1 of the scheme, and given that outstanding sum, a further enquiry was made as to whether guarantees could be provided that the proposals in respect of phase 3 would be fully funded by the Combined Authority. The Member also requested to see a copy of WYCA's letter to the Council in 2016 regarding the Combined Authority's commitment in respect of funding phase 1 of the project.

In response, the Board noted that this proposed scheme would be governed by a funding agreement which phase 1 was not, and would include appropriate contingency provision. It was also noted that this scheme had the advantage of the experience gained from the delivery of earlier phases. With regard to the commitment that WYCA had provided regarding the funding of phase 1, it was noted that the Director of City Development was scheduled to meet with the Combined Authority tomorrow with a view to raising the issue of the outstanding sum. The Director undertook to update Board Members as appropriate.

RESOLVED –

- (a) That the success to date of the City Connect programme within Leeds, be noted;
- (b) That the proposed Phase 3 projects which will provide segregated cycleways on Dewsbury Road, Elland Road and Clay Pit Lane, as detailed within the submitted report, be approved; and that the submission of the projects to the West Yorkshire Combined Authority as part of a full business case for the purposes of final approval, be approved;
- (c) That the authority to incur expenditure of £6.14m to design and construct the cycleways, to be fully funded from the West Yorkshire Combined Authority's City Connect programme, be approved;
- (d) That the following be noted:(i) The construction of the scheme is programmed to commence in the Spring of 2020 for completion by Spring 2021; and
 (ii) The Chief Officer (Highways and Transportation) will be responsible for the implementation of such matters.

(Under the provisions of Council Procedure Rule 16.5, Councillor A Carter required it to be recorded that he abstained from voting on the decisions referred to within this minute)

COMMUNITIES

114 The Leeds Pledge to Strengthen Civil Society

The Director of Communities and Environment submitted a report which presented for the purposes of endorsement the 'Leeds Pledge to Strengthen Civil Society' which was the result of a cross sector co-production exercise, initiated and led by Leeds Third Sector Partnership.

By way of introduction to the submitted report, the Executive Member for Communities paid tribute to Pat Fairfax, Policy and Performance Manager – Third Sector, for the longstanding work she had undertaken with the Leeds Third Sector Partnership and the wider support which she had provided across the sector, as Pat was due to retire from the Council in the near future.

In addition, Chris Hollins, Chair of Third Sector Leeds and Deputy Chair of the Leeds Third Sector Partnership, was welcomed to the meeting, and he provided an overview of the collaborative work which had been undertaken across a range of partners throughout the development of the Pledge. In response, Members welcomed the proposals detailed within the submitted report.

RESOLVED -

- (a) That the 'Leeds Pledge to Strengthen Civil Society' as detailed at Appendix 1, together with the submitted covering report, be endorsed;
- (b) That the Executive Member for Communities, as Chair of the Third Sector Partnership be requested to invite the NHS, University and Third Sector colleagues to take the Pledge into their sectors and institutions and to seek their support and commitment to partnership working on this agenda;
- (c) That it be noted that the Director of Communities and Environment and the Chief Officer, Communities are the senior officers responsible for the Council's oversight of the Pledge and its promotion and roll out.

115 Tackling Poverty and Inequality through Digital Inclusion

The Director of Communities and Environment submitted a report which provided an update on the approach being taken on the promotion of digital inclusion in Leeds through the '100% Digital Leeds' programme.

In presenting the submitted report, the Executive Member for Communities provided the Board with an overview of the range of work being undertaken as part of the promotion of the digital inclusion agenda.

RESOLVED -

- (a) That the ongoing work, together with the progress achieved to date, on the 100% Digital Leeds programme in mitigating the impact of poverty and inequality in the city through a focus on greater digital inclusion, be noted;
- (b) That the suggested areas for further work, as outlined in Section 5 of the submitted report, be agreed;
- (c) That the positive approach being adopted to co-produce the future programme with citizens and communities who have 'lived experience' of poverty and inequality, be acknowledged.

The Governance Officer informed members that Councillor R Charlwood had sent her apologies due to recovering from a recent operation. Councillor F Venner was elected as Chair for the duration of the meeting. The Chair wished Councillor Charlwood a speedy recovery.

30 Welcome and introductions

The Chair welcomed all present and brief introductions were made. Members were reminded of the implications of purdah, due to the upcoming General Election.

Matt, from Slung Low, was invited to speak to the Board. Matt provided members with the history of the meeting venue, as one of the oldest working men's clubs in the country and a hub for the local community. Members were also informed that Slung Low, a theatre company funded by the Arts Council, took over the day-to-day running of the Holbeck in 2016 and regularly hold workshops and other events for the local community. The Chair thanked Matt for his hospitality and the work of Slung Low.

The Chair also provided a brief overview of the Big Leeds Chat that took place on 7th November 2019, along with a number of smaller engagement events across the city.

31 Appeals against refusal of inspection of documents

There were no appeals.

32 Exempt Information - Possible Exclusion of the Press and Public

There were no exempt items.

33 Late Items

There were no late items.

34 Declarations of Disclosable Pecuniary Interests

There were no declarations of disclosable pecuniary interests.

35 Apologies for Absence

Apologies for absence were received from Councillor R Charlwood, Councillor S Golton, Cath Roff, Paul Money, Supt. Jackie Marsh, Tim Ryley, Steve Walker and Jim Barwick.

Councillor S Arif, Sabrina Armstrong, Simon Boycott, Sal Tariq and Sue Rumbold were in attendance at the meeting as substitutes.

36 Open Forum

Dr John Puntis, Leeds Keep our NHS Public, raised some concerns regarding the implications of the West Yorkshire and Harrogate (WY&H) Health and Care Partnership's 'Improving Planned Care' programme for patient access, particularly in relation to the evidence base behind the programme and the level of input from clinicians. The Director of Public Health advised Dr Puntis that a well-represented clinical senate in Leeds had thoroughly assessed the thresholds set out in the 'Improving Planned Care' programme.

Dr Puntis also stated that the NHS Long Term Plan is reliant upon private companies to develop Integrated Care Systems (ICS), and sought the Board's views in relation to global collaboration. The Chief Officer (Health Partnerships) informed Dr Puntis that there was a clear consensus in Leeds that negotiations would not be open to private companies in the United States. Mr Mike Shaw, a support worker for people living with HIV, raised concerns with living conditions for vulnerable people in the private rented sector in Leeds, and referred to a number of cases of rat infestations that private landlords had refused to resolve. Mr Shaw felt that in the absence of legislation to force landlords to see to such issues, there was a requirement for the Council to embed a joined-up approach to ensure that cases of vermin infestation are resolved as quickly as possible. Members recognised the challenge with engaging with the private rented sector, and advised that the matter would be passed on to Council teams.

37 Minutes

38 Priority 3: Strong, engaged and well-connected communities -Developing our Local Care Partnerships

The Chief Executive of Leeds Community Healthcare submitted a report that provided an overview of Local Care Partnerships (LCPs) to Health and Wellbeing Board. The paper described why Leeds health and care system is developing Local Care Partnerships, how they fit with other activity in Leeds, and the current stage of development.

Kim Adams, Head of Local Care Partnership Development, introduced the report and provided members with a PowerPoint presentation, including examples of successful community engagement projects undertaken by wellestablished LCPs. Members were advised that the LCPs across the city were at varied levels of progress, and of the importance of recognising that culture change and relationship building takes time.

Members discussed a number of matters, including:

- Population Health Management. Members were keen to understand how the LCPs will contribute to improving the health of the most deprived communities the fastest, and were informed that the Population Health Management approach was designed to ensure that LCP plans and projects are tailored to the strengths and challenges of individual communities. There was support for this approach, however, members noted that the wider health inequalities that are true for Leeds as a whole should still be considered.
- Representative membership. There were a number of comments around the make-up of LCPs, and the need for wider health partners such as pharmacists and dentists to be included. There was also some discussion around ensuring that successful models for 'Children and Family Hubs' were shared between LCPs to encourage the family first approach within the health and social care setting. Additionally, Members sought reassurance that licensing and planning teams were engaged in relevant work streams.

RESOLVED -

- a) To note the work being undertaken to develop Local Care Partnerships;
- b) To note the Board's understanding that success is dependent on strong relationships fostered through working together on shared priorities with appropriate support;
- c) To note the Board's support for the principle of prioritising time to foster the right culture to make lasting change happen.

39 Leeds System Resilience Plan 2019/20

The System Resilience Assurance Board (SRAB) submitted a report that provided assurance to the Leeds Health and Wellbeing Board that the Leeds health and care system continue to work together to improve the resilience of service delivery.

The Leeds System Resilience Terms of Reference 2019/21 were appended to the report.

Sue Robins, Director of Operational Delivery at NHS Leeds CCG, introduced the report and provided a PowerPoint presentation, highlighting some of the key projected areas of challenge throughout the winter months and other peak times, along with the preventative measures in place to ensure resilience.

Members discussed a number of matters, including:

- Engagement with children and young people. There was a suggestion that the 'How does it feel for me?' group be replicated with children and young people, to gain an understanding of their experiences of health and social care services. Members requested an update on the project at a future Board meeting.
- Affordable warmth. In response to a query around affordable warmth schemes, Members were advised that the Council were leading on a project to address fuel poverty.

The Chair noted the Board's thanks to Sue Robins ahead of her retirement in the New Year.

RESOLVED -

- a) To note the positive work across the Leeds system over the last year to improve Leeds system resilience;
- b) To note the Board's assurance that comprehensive plans for escalation are in place based upon good governance and communication between system partners.

40 Developing our approach to improving health and wellbeing across Leeds and West Yorkshire and Harrogate Health and Care Partnership

11.1 Draft Leeds Health and Care Plan

The Head of the Leeds Health and Care Plan submitted a report that provided the final draft Leeds Plan summary on a page for approval as well as outlining the progress to date.

Paul Bollom, Head of Leeds Plan, introduced the report and provided members with a PowerPoint presentation. All members also gave a brief update on the commitments of actions on behalf of their individual organisations as set out in the presentation slides.

RESOLVED -

- a) To note the progress and successes of the Leeds Plan to date (section 3.1);
- b) To note that the Leeds Plan summary reflects the priorities that the Board previously agreed (16 September 2019) should be given additional focus (section 3.2.2);

Members discussed a number of matters, including:

- *Big ambitions.* Members queried the inconsistency between, and in some cases absence of, completion dates of the 'big ambitions' as set out in the report. Members suggested that the dates should echo the five year period, but were informed that some projects were reflective of wider national priorities.
- Strategy presentation. Members queried whether the strategy could be presented in a more succinct ad easy to digest format for the public and wider workforce. Members were advised that the strategy included

1. Purpose of this report

1.1 This report is intended to update Members on matters related to the progress of Devolution and matters regarding the Leeds City Region LEP and the West Yorkshire Combined Authority.

2. Background information

2.1 Following cross party agreement, this is the twenty-fourth report to Full Council to provide an update to Members on the progress related to Devolution and the work of the WYCA and Leeds City Region LEP.

3. Main Issues

Devolution

- 3.1 Members have previously been updated on developments regarding Devolution including at the most recent Full Council meeting on 13 November 2019.
- 3.2 Following constructive discussions between West Yorkshire Leaders, West Yorkshire Chief Executives, MHCLG and HMT officials with the then HMT Minister, Robert Jenrick MP, One Yorkshire Leaders wrote to the Prime Minister at the end of July 2019, outlining new devolution proposals. On 29th July 2019, the proposals were published. These included that a series of interim devolution deals would be agreed across Yorkshire to run in parallel with the existing SCR agreement. Negotiations would continue with Government to have a One Yorkshire devolution agreement completed by 2022, the end of the current SCR Mayor's term. At this point, any SCR authorities wishing to be part of the wider Yorkshire deal would be allowed to do so. The proposals outline how a One Yorkshire devolution deal could deliver economic benefits worth £30bn a year, or £5,400 per person.
- 3.3 The letter further states that proposals also outline how devolution in Yorkshire is critical to delivering shared objectives, which cross political divides and are about growth in a post-Brexit world. It aligns to the Government's priorities of more investment in much needed transport and full fibre digital infrastructure; increased inward investment and help for companies to export; the delivery of more houses to meet the acute national shortage; speed up of the progress being made in sustainable energy generation and carbon capture; better

address the skills shortages in workforce; and help tackle deprivation within communities.

- 3.4 At his speech at the Convention of the North in Rotherham on 13 September 2019, the Prime Minister made the following statement: "And I know there is real enthusiasm for devolution in Yorkshire and I welcome the establishment of a Yorkshire Committee as a practical step for facilitating greater collaboration on a Yorkshire-wide basis...In the meantime, we are committed to getting the Sheffield City Region done and I also want to open up negotiations with Leeds and West Yorkshire so we can make a mayor work there too, whatever the nature of any longer term arrangements in Yorkshire."
- 3.5 The Secretary of State, for Housing, Communities and Local Government, Robert Jenrick MP also committed to working with Leaders to bring forward plans for a devolution deal.
- 3.6 On 26 September 2019, West Yorkshire Leaders met with Government Ministers to discuss proposals for devolution.
- 3.7 On 19 December 2019, the Leaders of West Yorkshire and York councils and the Chair of the Leeds City Region Enterprise Partnership wrote to the Prime Minister highlighting the opportunities and challenges for the region across key areas with specific requests for Government support on devolution, skills, transport, tackling the climate emergency and development of mass transit proposals. (Letter attached at Appendix A).
- 3.8 The letter to the Prime Minister also identifies reaching a devolution settlement as an "urgent priority" and sets the goal of making significant progress, "with a view to agreeing a way forward" which can be announced in the Government's first budget. The letter states,

"Our urgent priority is to secure the benefits of devolution for all our communities. This is a vital part of completing the devolution map across the country and will enable us to drive economic growth, tackle the climate emergency and regenerate, strengthen and level up our towns.

"We seek to build on the progress made following your speech in Rotherham supporting Yorkshire-wide collaboration and opening up negotiations on a possible Leeds City Region agreement, alongside making progress towards devolution for all parts of Yorkshire. We ask that these productive discussions continue, with a view to agreeing a way forward that can be announced in your Government's first budget."

3.9 Discussions continue to progress with Ministers and officials to explore a potential devolution deal.

Dear Prime Minister,

Congratulations on your recent election - we look forward to working with you and your Government to take forward our shared ambitions. We write publicly to outline our key priorities, and to urge your newly-returned Government to support our ambition to create a region delivering clean growth which benefits all our communities. Following your recent commitment to the devolution agenda, we also ask that powers and funding are provided that allow us to make progress.

Our priority areas are devolution, the climate emergency, skills, transport in the north, and mass transit in West Yorkshire. We have attached high level notes on these topics to this letter.

Our urgent priority is to secure the benefits of devolution for all our communities. This is a vital part of completing the devolution map across the country and will enable us to drive economic growth, tackle the climate emergency and regenerate, strengthen and level up our towns. We seek to build on the progress made following your speech in Rotherham supporting Yorkshire-wide collaboration and opening up negotiations on a possible Leeds City Region agreement, alongside making progress towards devolution for all parts of Yorkshire. We ask that these productive discussions continue, with a view to agreeing a way forward that can be announced in your Government's first budget.

We have a City Region commitment to becoming a net zero carbon region by 2038, with significant progress made by the end of 2030. We are also strengthening our region's resilience in the face of our changing climate, and in particular the threat of flooding which had catastrophic consequences for our communities four years ago, as well as more recently for our neighbours in South Yorkshire. We seek your commitment to supporting our pipeline of flood defence and alleviation interventions to ensure the safety of our communities and our businesses.

We welcome your promise to make urban transport in regions such as ours as good as London. There is an opportunity to demonstrate this by responding quickly and positively to our Transforming Cities Fund submission, as well as providing vital development funding for our mass transit scheme, something we know you strongly supported during the election campaign.

We are clear in our approach that urban transport investment must be integrated with upgrading the North's strategic transport network. Your manifesto promise to build Northern Powerhouse Rail between Leeds and Manchester is welcome, but it must be via Bradford city centre and must sit alongside a funding commitment to support our broader investment pipeline. The prompt conclusion of the Oakervee Review must also be the moment when Government fully commits to the delivery of HS2 to Leeds and linking to the East Coast Mainline near York.

We also welcome your commitment to improving skills, including urgently needed reform of the Apprenticeship Levy, and ask that your Government adopts the recommendations of our Future Ready Skills Commission as you consider the implementation of the £3 billion National Skills Fund.

Above all, we ask your Government to recognise the role local government plays in supporting inclusive communities with a funding settlement which reflects the scale of the challenges and opportunities our district authorities face, particularly in terms of protecting children and adult social care.

We look forward to working with you to deliver transformational benefits across our towns, cities and communities, and would welcome meetings at the earliest opportunity in order to progress these ambitions at pace.

Devolution



Our Ambition

Devolution is critical to deliver our economic objectives and growth in a post-Brexit world. It would allow us to secure more investment in desperately needed transport and digital infrastructure, increase inward investment, address the climate emergency, better address the skills shortages in our workforce, and, critically, help tackle disadvantage where it exists in our communities. It would also enable us to strengthen and level up our towns, to drive growth, open up new opportunities and improve living standards.

Sizeable parts of the City Region enjoy a great quality of life, good wages, and lower living and housing costs, and for many the region is a great place to live, work, visit and invest. Yet, despite that, the level of investment falls well short of genuinely rebalancing the UK economy.

Meaningful devolution would show Government's commitment to the City Region by addressing the historical lack of investment.

Our Actions

- Constructive negotiations have been taking place with Government to secure a devolution deal
- There is an ambition for wider devolution across Yorkshire more broadly, which remains a priority for the majority of local partners across the region
- A Leeds City Region devolution deal could be considered a stepping stone towards achieving this wider ambition, and would unlock powers and funding whilst the wider proposal is further developed

Our Challenges

The calling of a general election led to the pausing of negotiations around a Leeds City Region devolution deal which we are keen to quickly resume.

Our Ask

As the **largest City Region economy outside of London**, securing a Leeds City Region deal is a **vital part of completing the devolution map across the country.**

Our devolution priorities are to address transport and mass transit, skills, housing, business support, innovation and decarbonisation, in order to:

- Boost the region's economy and contribute more to national economy, which will be vital in a post-Brexit landscape
- Build a more inclusive economy by investing in communities and linking people to education and employment opportunities
- Strengthen and level up our towns to ensure no area is left behind
- Tackle the climate emergency

Given the **advanced progress in negotiations** prior to the election, we want to **urgently engage** with the Government to make **swift progress on securing a deal**, to have an immediate impact and unlock funding to deliver transformational benefits across the region.





Tackling the Climate Emergency



Our Ambition

We have set an ambitious target for the Leeds City Region to become net zero carbon by 2038, with significant progress made by 2030 so we can make a full contribution to tackling the climate emergency.

Our Actions

Within the powers and funding at our disposal we are already taking action. We are:

- Delivering a wide range of measures to reduce harmful carbon emissions in the region, including supporting businesses to be resource efficient, measures to improve the energy efficiency of homes and combat fuel poverty, and the introduction of electric vehicle charging points and low emission buses
- Reappraising our transport schemes and enhancing our assessment of future schemes in order to understand their potential impact on the climate emergency

Our Challenge

To deliver on our ambition, the Leeds City Region's emission levels will have to be halved every five years - 14.5% year-on-year - and that more than 80% will need to be saved by early 2030, in order to play our role in limiting global temperature rise to between 1.5 and 2°C.

We know that even with all the projects we have identified and the actions we are already taking, **we need to go further and faster in the next 10 years.** We are looking to work with Government to achieve our ambition and will require devolution of powers and funding to be able to do so.

Our Ask

- Devolved dedicated funding will allow us to create regional funds which directly address the climate emergency including:
- Low Carbon Project Fund to support and accelerate projects
- Energy Efficiency Fund to create zero emission homes
- Decarbonisation Fund to support the total decarbonisation of the large energy and carbon intensive industry and transport sector by mid-2030
- Nature Fund to enable the natural environment to play a significant role in reducing emissions and increasing our region's resilience to climate related events, including flooding

We also believe the **Government should address** regulatory and policy obstacles by:

- Allowing us to set higher energy efficient and near-zero-carbon new-build standards pre-2025
- Clarifying policy on the decarbonisation of heat and creating incentives for renewable heat
- Clarifying policy on how aviation will be decarbonised
- Working with us to co-design green finance models and create resources
- Making changes to fuel and vehicle taxation regimes



Transport



Our Ambition

We want to create an **integrated**, **flexible and sustainable transport system**, which supports a productive economy and enables all our communities to benefit from the City Region's growth. A successful network is also **critical in achieving our target of a net zero carbon City Region** by 2038 and connecting our most deprived communities to employment and opportunities.

We are looking to work with Government to make these ambitions a reality, **building on your election commitments to deliver a transport revolution**, including the £350 billion Cycling Infrastructure Fund, parity with London for regional urban transport networks, support for better bus services, the development of metro and light rail schemes and the construction of Northern Powerhouse Rail.

Our Actions

- We are delivering the West Yorkshire-plus Transport Fund pipeline of projects
- We are looking to transform public transport in order to regenerate our towns, connect communities to essential services and reduce carbon emissions
- We have a clear plan for improving walking and cycling infrastructure, and are exploring the purchase of First in West Yorkshire to take control of our bus network – but **need long term funding** to make these **public transport ambitions a reality**
- We are starting to develop a mass transit solution for the Leeds City Region to increase transport capacity and meet current and future demands, as we know we need a system which is capable of transporting larger numbers of passengers – more than bus, bikes and cars can accommodate
- We welcome the commitments that have been given to **Transport in the North**, which we **are clear must now be followed with meaningful action** in order to deliver real improvements for our passengers

Our Challenges

- The North's rail network continues to demonstrate the consequences of decades of underinvestment with punctuality and reliability inconveniencing passengers, damaging our economy and undermining confidence in public transport
- The lack of capacity is a significant contributory factor which is why we remain committed to HS2, integrated with Northern Powerhouse Rail with a city centre stop in Bradford, an upgraded Trans-Pennine route and a transformed Leeds Station
- We need to decarbonise the transport network, which will be critical in order to achieve our net zero carbon ambition

Our Ask

Alongside a clear commitment to the major rail investments outlined above, we need:

- Greater control of the regional rail network in order to have increased local accountability to ensure franchise commitments and improvements for passengers are delivered
- Additional funding to invest in clean transport modes
- We will require devolution of powers and funding to be able to achieve our ambitions. A priority for a devolution deal would be a devolved and consolidated multi-year capital and revenue transport budget, allowing a long-term strategic approach to improve connectivity across the region
- The ability to manage local highway, public and active transport, as well as funding between years as a single transport pot, provides greater certainty and therefore more effectiveness and flexibility to meet local priorities





Mass Transit



Our Ambition

With a population of over three million people, the Leeds City Region is the **largest metropolitan area in Europe without a mass transit system** and our economy is forecast to grow rapidly.

We want to deliver an innovative mass transit solution to support our clean growth and productivity ambitions by enabling our City Region to increase transport capacity, meet passenger need and create a multi-modal shift away from the private car, cutting congestion and improving air quality.

Our Actions

A significant amount of work is already being done towards our ambition, including:

- Considering the network, understanding where the need is the greatest and the communities we will need to connect
- Engaging with industry and other key partners to understand the latest mass transit technologies and key research and development, so we can plan for delivering a 21st century, mass transit system.

Our Challenges

To meet current and future demands the evidence demonstrates that we require a mass / urban transit system which is capable of transporting larger numbers of people – more than bus, bikes and cars can accommodate.

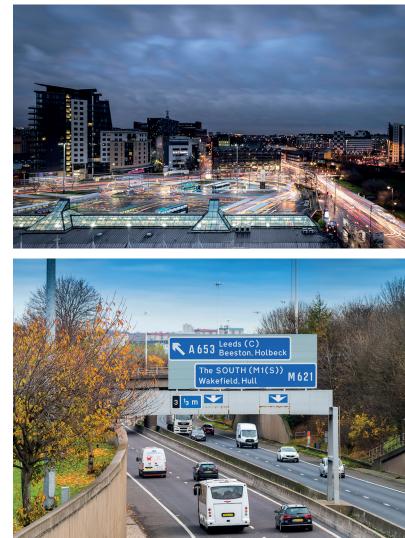
This is a key component of the emerging transport pipeline to deliver significant **improvements to local connectivity** and capacity, and help distribute the benefits of HS2 and Northern Powerhouse Rail across our communities.

Our existing programme of work provides a base for the technical work required, but what will be critical will be **ongoing central Government support** throughout the process, to ensure we are able to **once and for all deliver a mass transit solution** for our region.

Our Ask

During the general election campaign, you specifically committed to supporting the development of a new metro/light rail scheme for West Yorkshire. We are ready to work with you to deliver this critical infrastructure.

We want to develop a **joint approach with Government** to deliver a mass transit solution for the region, which in the first instance would be through the **commitment of £20 million in development funding** so that construction can start from 2023/24 on the first phase, and agreement to work with the Combined Authority to fund delivery of mass transit proposals.



Skills



Our Ambition

Giving our people the right skills is vital to transforming our economy by driving up productivity. Our vision is to design a skills system that meets the challenges of major structural shifts in the economy we will experience in the coming decades.

Our Actions

Leeds City Region has been proactive with the funding and powers we have been afforded to date. We are already delivering in the following areas:

- Working with over 180 of our most disadvantaged schools to improve the futures of their young people
- Implementing our unique delivery agreements with further education colleges, setting out how they will better respond to changing needs of the workplace
- Supporting 250,000 people this year through our all-age careers platform, FutureGoals, to become better informed about career opportunities and supporting people through our new adult retraining programme, [re]boot
- Helping businesses to transfer levy funds to SMEs in skills shortage areas, as well as supporting businesses to recruit young people to employment and apprenticeship opportunities through our Employment Hub
- Supporting a Future-Ready Skills Commission which brings together independent experts in the to create a blueprint for a devolved skills system and argues the need for system reform

Our Challenges

Low productivity and inequality still pervade. **The current skills system is centralised** and doesn't encourage responsiveness to the local context from education and training providers. National campaigns and initiatives often fail to resonate with employers, individuals and communities.

A skills system with powers and investment devolved to local areas would enable us to respond to these challenges. Our track record of delivering successful employment and skills programmes demonstrates the importance of local leadership and intervention.

Our Ask

We welcome your commitment to improving skills, including urgently needed reform of the Apprenticeship Levy, the new National Skills Fund and investment in further education to address under-funding in colleges.

We want to work with Government to devolve powers and funding in order to reshape and re-structure local skills provision so that it is more responsive to the needs of employers and enables people from all communities to access and progress in high quality employment opportunities. This would **include full devolution of AEB provision, Skills Capital and control over Apprenticeship Levy funding.**

Through formal influence over colleges and independent training providers we will ensure that provision is more reflective of current and future workforce needs and delivered flexibly to meet the needs of learners who are in work. Support will be offered to providers where there are barriers to this responsiveness (e.g. recruiting/ retaining staff, investing in capital equipment). Support will also be given to employers to engage with the education system.

We also seek:

- Greater local accountability and powers over the National Careers Service, Careers and Enterprise Company and National Retraining Scheme in order to develop a strong all-age careers support that has local relevance, tailored advice and a direct line of sight to a job in order to deliver high quality careers support and inspire adults to retrain and upskill.
- Implementation of our landmark Delivery Agreements as a national pilot with an investment fund alongside to address key challenges
- Fully embedding skills in our wider business support offer, such as apprenticeship levy transfer and delivering a joined-up skills brokerage service
- Piloting of the recommendations from the Future Ready Skills Commission, which focus on simplifying the skills system to encourage behaviour change for training providers, employers and learners, with influence to reshape the national skills system

This Council is concerned by recent and repeated examples of gridlock and heavy congestion in the City Centre, leading to significant disruption to commuters as they travel in and out of Leeds.

Council notes the investment being made through Connecting Leeds, including the £173.5m granted by Government, but believes that to get the city moving and to encourage greater growth and productivity a new approach to public transport, not wholly reliant on the bus, is required.

This Council therefore welcomes the Government commitment to spend £4.2bn on public transport projects outside of London and notes that some of this funding is planned for the Leeds district.

Council believes this offers a new opportunity to deliver a mass transit scheme for the city which will deliver obvious economic benefits as well as significantly reducing the city's carbon emissions in line with the declared Climate Emergency.

Council further believes that all areas of the city should be considered for mass transit infrastructure and is concerned that existing WYCA proposals seem to omit North Leeds, and the potential links to Harrogate, York and Wetherby, from any new transport infrastructure plans.

In light of this announcement made during the election campaign, this Council calls for a report to be brought to the March Executive Board meeting setting out detailed plans as to how a new mass transit scheme can be delivered to all communities in the city and to include analysis of the potential benefits such a scheme would deliver in terms of reducing the carbon footprint in Leeds.

Council notes the current uncertain situation with regard to First Bus and other bus operators in West Yorkshire, and believes that the way forward is for West Yorkshire Combined Authority to take over the running of these operations.

Council also believes that appropriate funding should be made available to bring back into operation disused rail infrastructure, such as unused track, and the re-opening of many of the former local railway stations closed many years ago, such as the one in Wortley and the two in Armley.

It is Council's view that only with vibrant publicly owned bus services, running in the interest of the passenger, and expanded local rail services can Leeds (or for that matter, West Yorkshire) achieve a 21st Century public transport system that delivers for its citizens, helps to reduce congestion and is consistent with the aims of the Climate Emergency.

Council also notes that Prime Minister Boris Johnson has stated that he will transform transport in the North. Bearing this in mind Council, therefore, calls on the Chief Executive to write to the Prime Minister asking for the Government to support these aspirations, both in actions and funding.
