Summary of main issues

This is an application for the grant of a premises licence, made by W M Morrison Supermarkets Plc, for Morrisons 25 - 27 Arndale Centre, Otley Road, Headingley, Leeds, LS6 2UE.

The applicant has applied for the sale of alcohol off the premises. Full details of activities and hours can be found at 3.3 of this report.

Responsible authorities and Ward Members have been notified of this application.

The application has attracted representations from other persons.

The premises are located within an area covered by a Cumulative Impact Policy.

1.0 Purpose of this Report

- 1.1 To advise Members of an application made under section 17 of the Licensing Act 2003 ("the Act") for a premises licence in respect of the above mentioned premises.
- 1.2 Members are required to consider this application due to the receipt of representations.

2.0 History of Premises

2.1 This is the first application for a premises licence for these premises.

3.0 The Application

- 3.1 The applicant is W M Morrison Supermarkets Plc,
- 3.2 The application form may be found at Appendix A to this report.
- 3.3 In summary the application is for:

Supply of alcohol off the premises 07:00 until 23:00

Non Standard Timings

No non standard timings for bank holidays or special occasions are proposed.

4.0 Other matters relevant to the application

4.1 At the time of writing this report there were no implications for equality and diversity. Any decision taken by the Licensing Sub-Committee will be in accordance with the four licensing objectives as prescribed by the Licensing Act 2003.

5.0 Steps to promote the Licensing Objectives

5.1 The applicant proposes to take specific steps to promote the licensing objectives identified in section M of the application form.

6.0 Proposed Designated Premises Supervisor

6.1 Ms Nicola Wood intends to be the Designated Premises Supervisor

7.0 Location

7.1 A map which identifies the location of this premise is attached at Appendix B.

8.0 Cumulative Impact Policy

- 8.1 The premises are located within the Cumulative Impact Area 2
- 8.2 Cumulative Impact means the potential impact on the promotion of the licensing objectives. Here there are a significant number of licensed premises concentrated in one area.
- An applicant wishing to obtain a new licence for premises falling within any of the cumulative impact areas, must identify through the risk assessment process and/or operating schedule, the steps that they intend to take so that the council and responsible authorities can be satisfied with that granting of a new licence will not add to the impact already being experienced.
- 8.4 Details of the Cumulative Impact Policy specific to Area 2 and an outline of the evidence behind the reason for setting this policy, is attached at Appendix C.

9.0 Representations

- 9.1 Under the Act representations can be received from responsible authorities or other persons. Representations must be relevant and, in the case of another person, must not be frivolous or vexatious.
- 9.2 Representations from Responsible Authorities
- 9.3 There have been no representations from responsible authorities.
- 9.4 Other representations
- 9.4.1 The application has attracted representations from other persons.
- 9.4.2 The licensing section is in receipt of one letter in support of the application and two individual letters of objection all of which are opposed to this application on the grounds of public nuisance.
- 9.4.3 Copies of the representations will be available at the hearing for Members consideration.

10.0 Options Available to Members

The licensing sub-committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:

- Grant the application as requested.
- Grant the application whilst imposing additional conditions and/or altering in any way the proposed operating schedule.
- Exclude any licensable activities to which the application relates.
- Refuse to specify the said person as the designated premises supervisor.
- Reject the whole or part of the application.
- 10.2 Members of the licensing sub committee are asked to note that they may not modify the conditions or reject the whole or part of the application merely because it considers it desirable to do so. It must actually be appropriate in order to promote the licensing objectives.
