

Leeds City Council's Environmental Action Service Proposed Controlled Measures under the Licensing Act 2003

Name of Premises: Grove Hill Club

Address: Ilkley Road, Otley, Leeds, LS21 3JN

The application premises are situated within a mixed residential and commercial part of Otley. The surrounding area is generally residential in character apart from a medium sized office block which is situated opposite the premises. The smoking shelter for the patrons is situated adjacent to the main entrance of the club premises. The nearest residential property is situated diagonally opposite the club premises (approximately 30 metres away) and have the potential to be affected by the noise from patrons using the external smoking shelter.

The proposal consists of extending the supply of alcohol on the premises by one hour with 30 minutes drinking up time. There are no changes to other licensed / regulated activities on the premises. I have discussed the proposed variation of this application with Mr. Baker, Club Secretary and the possible impact on the nearby residents particularly the noise disturbance from patrons using the smoking shelter. Mr. Baker has indicated that he is willing relocate the smoking shelter (subject to planning approval) to the rear of the building to prevent any noise issues. Should the planning permission is not granted to relocate the smoking shelter to the rear of the building, the patrons should not be allowed to use the existing smoking shelter after 23:00 hours.

Having considered the application under the Licensing Act 2003 for the above premises, we consider that the following measures are relevant and reasonable in order to meet the following aim of the licence:

Prevention of public nuisance

Noise and Vibration

- Noise from a licensable activity at the premises will not be audible at the nearest noise sensitive premises which are located on Ilkley Road.
- No speakers for amplification of music shall be placed on the outside of the premises or on the outside of any building forming a part of the premises.
- Bottles will not be placed in any external receptacle between 11 pm and 7 am the following day to minimise noise disturbance to neighbouring properties.

Beer Garden and External Smoking Shelter

The Committee or nominated person will ensure patrons use beer garden (which
is located to the rear of the premises), external areas in a manner which does not
cause disturbance to nearby residents and business in the vicinity.

- 5. The existing smoking shelter (which is located adjacent to the main entrance) shall not be used by the patrons after 23:00 hours. Should the applicant chose to relocate the smoking area / shelter to the rear of the building (subject to planning approval) and accessed via the rear doorway, the patrons shall be permitted to use this designated smoking area / shelter until the terminal hour for licensing.
- The activities of persons using the external areas shall be monitored after 11 pm and they shall be reminded to have regard to the needs of local residents and to refrain from shouting and anti social behaviour etc when necessary.
- The PLH/DPS will adopt a "cooling down" period where music volume is reduced towards the closing time of the premises.

Litter

The PLH/DPS shall ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.

Transport / Pedestrian Movement

- 9. Clear and legible notices will be displayed at exits, car parks and other circulatory areas requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour.
- 10. The committee or nominated person will monitor the activity of persons leaving the premises and remind them of their public responsibilities where necessary.
- 11. A facility will be provided for customers to order hackney taxis/private hire vehicles. Telephone numbers for taxi firms/private hire companies will be displayed in a prominent position on the premises.


