As part of the City Council's budget strategy, this equality impact assessment seeks to examine a planned revision to reduce the number of municipal golf courses that are currently managed by Leeds City Council from 5 to 3 and converting the land back into semi natural parkland thereby making a collective saving of £168k.

#### 5. Fact finding – what do we already know

In November 2012, and as part of the Council's long term financial plan, Executive Board gave an in principle agreement to the proposed closure of two of the five municipal golf courses. Namely Gotts and Middleton Park and revert the land back into semi natural parkland.

The Council continues to face serious budget pressures and between 2010/11 and 2015/16 will have experienced cash funding cuts in the region of £175m from central government with further reductions expected in 2016/17 and 2017/18.

This has also impacted on the Parks and Countryside service, with a £2.7 million budget reduction between 2010/11 and 2014/15. This equates to a reduction of 23% with further reductions expected to be required in 2015/16 and 2016/17.

Leeds City Council provides 4 golf sites with 5 courses, namely Gotts Park Golf Course in Armley (18 holes), Middleton Park Golf Course (18 holes), Roundhay Park Golf Course (9 holes) and Temple Newsam Golf Course (two 18 hole courses). It is recognised that participating in golf has many benefits – to health and wellbeing, social interaction, education and learning as well as fostering sporting talent.

Over the last 7 years, there is evidence of a decline in adult golf participation at a national level. The Sport England active people survey conducted over a number of years demonstrates that adult participation has declined from 948,300 in 2007/8 to 772,800 in 2012/13 – a reduction of nearly 19%, as shown in the following graph:




Figure 1: National golf participation 2007/8 to 2012/13

Over the years, Golf has become a more competitive market with over 24 golf courses available within or close to the Leeds boundary. This downward trend is also reflected across the Council managed courses despite attempts at introducing various golfing promotional offers. Resulting in a net operating loss at Middelton Park Golf Course of

£103k and £114k at Gotts Park Golf Course. It is acknowledged that the other two remaining golf course locations at Temple Newsam and Roundhay Park were also operating at a loss, but was considered to be insufficient to warrant further work to develop proposals on closing these courses. The details of this is set out in section 3 within the Executive Board report.

Should a decision be made to close both golf courses, it is further proposed to convert the land back into semi natural parkland by creating Leeds' first park arboretum with a 42 hectares site containing interesting and diverse tree species along with educational and interpretation information at Middleton Park and for Gotts Park to create the Benjamin Gott's Country Park that would be free and open to the public with 37 hectares of interesting and diverse habitats along with educational and interpretation information on the flora, fauna and history of the site.

From experience, knowledge and feedback from staff at the point of ticket sale, the majority of people who play golf do not tend to use public transport as a means to getting to and from their golf course. This is mainly due to the fact that golf equipment can be quite bulky and heavy to carry. Similarly not unless someone lives adjacent to a golf course golfers tend not to walk to their choice of golf course to play golf.

Season ticket holders may play at all five of the Council golf courses and green fees are available at each golf course location for those who prefer to just turn up, pay and play. A golf survey was undertaken in 2012, which demonstrated that whilst golfers may play at any of the Council golf courses, their preference is to play at the course where they are also members of the golf club.

From the 175 respondents, 159 completed the equality questionnaire section. This demonstrated that 90% of those who played golf were white British males and less than 6% were women with less than 8% from ethnic minority groups. 70% were also aged 50 years or over with less than 4% under the age of 21 years and 94% did not have a disability. The proposed closure of the two golf courses would not adversely affect those with disabilities.

From those who responded there was an equitable split across each of the four golf course locations with perhaps slightly more who played at Roundhay Park Golf Course.

In terms of age profile across all of the courses, Temple Newsam and Roundhay Park had a higher percentage of young golfers in comparison to both Gotts and Middleton. With Gotts seeing a higher proportion of those aged over 60 years.

In terms of golf course terrain Gotts Park Golf Course is perhaps the steepest of all of the Council's golf course terrains.

A wide range of consultation has been undertaken on the Council's proposals to close both Gotts and Middleton Park Golf Courses including the citizen's panel, all ward members, Middleton Park Municipal Golf Club, Gotts Park Golf Club, Wades Trust, the Leeds Parks and Green Spaces Forum and the Friends of Middleton Park. The consultation was included on the 'Talking Point' website and paper copies of consultation documents were also displayed and distributed at each golf course. Together with the draft landscape proposals to revert to the golf course back into semi natural parkland.

The results from this consultation process is clearly set out within the Executive Board report. However, a summary of the results is as follows:

The citizen's panel were consulted and based on around 1,200 who responded, 87% were in favour of closing the courses and establishing semi-natural parkland, including around 73% of those who stated that they play golf. The Leeds Parks and Green Space Forum offered no objection and welcomed the potential new use for the sites as they would benefit wildlife and allow more visitors to access. Consultation undertaken at the point of play at each course demonstrated around 95% opposed to the proposal to close each course.

### **Core Cities Comparators**

The proposed closure of both Gotts and Middleton Park Golf Courses is not based on other local authorities as each local authority will work towards different financial strategies. However, Leeds is the only Core City who manage 5 municipal courses with Liverpool, Manchester, Newcastle, Bristol, Nottingham, Sheffield and Birmingham all having different types of golf management in place. Sheffield have placed their golf provision into a trust working with SIV(Sheffield International venues); Birmingham's golf provision is run by mytime active on a long term lease; Manchester have a company called Mack Trading Amenity Management running a lease until 2018. Liverpool Council is going through a similar exercise as LCC and had hoped that a third party provider would run the golf provision however, this has fallen through due to the demands of the contractor. Bristol council operate an 18 hole par 3 course that is managed in-house with other activities using the facilities as well. Nottingham and Newcastle don't have any direct golf provisions.

Given that each of the core cities operates differently, there are no direct comparables that can be made.

#### **Financial Support**

For those who may not be able to afford to purchase golf equipment. This is available for golfers to hire at each of the municipal golf course locations, . Discounted season tickets and green fees are also available to those who are on job seekers allowance, students, pensioners etc.

During 2013,Officers from the Parks and Countryside service, have met each month with the respective golf glubs who are directly affected and with representatives from the Friends of Middleton Park, Wades Trust and Ward Members to try and establish a business case to keep both golf courses open. Unfortunately Middleton Park have been unable to make a business case whilst in comparison, Gotts Park Municipal Golf Club have submitted a business case for the Council to consider.

In addition to working closely with key stakeholders, Public Consultation has also occurred and the details of this may be found within the Executive Board Report. In summary, the citizen's panel were consulted and based on around 1,200 who responded, 87% were in favour of closing the courses and establishing semi-natural parkland, including around

73% of those who stated that they play golf. The Leeds Parks and Green Space Forum offered no objection and welcomed the potential new use for the sites as they would benefit wildlife and allow more visitors to access. Consultation undertaken at the point of play at each course demonstrated around 95% opposed to the proposal to close each course.
