The recommendation that Leeds City Council increases the minimum hourly pay rate from 1 Jan 2017 supports the ambition to be a strong economy and compassionate city.

The proposal would increase the wages of over 7000 actual employees of the council and schools, of which 80% are women.

This helps to reduce in work poverty and is part of a package of measures which the council has already signed up to in the Combined Authorities Low Pay Charter

- **Key findings**

The decision has a positive impact on our lowest paid employees by increasing the hourly rate to £8.25. It will particularly affect women who are employed in catering and cleaning roles.

The decision is a move to address in-work poverty in the city and set an example to other employers.

The proposal to introduce a minimum hourly salary rate of £8.25 also includes a commitment to annually review the position, alongside budget planning.

An undertaking to also review pay in the context of the roll out of changes in tax and family credit, announced by the Chancellor in the 7 July 2015 budget has been made.
