Purpose Of This Report

The purpose of this report is for the west Leeds VCF sector to bring the voice of their service provision to the debate and ultimately play their part in shaping better services and yet continuing to provide remarkable, valuable, creative and indispensable services.

1.0 Background Information

West Leeds has an extensive VCF sector. The sector brings a distinctive approach to service delivery, based on its specialist knowledge, experience and skills. This distinctive approach means the sector has an important role in the wider reform of service delivery.

This report will highlight the achievements of some of the groups in West Leeds.

2.0 Main Issues

It is really important the people who are working close to the ground in the affected areas and who understand the causes and the potential solutions for the complex problems and needs are fully engaged and influencing decisions as well as the people who live in those communities themselves.

There are some misconception and misinformation about the competency and professionalism of the VCF sector. A lot of the services provided is done in an imaginative, creative and flexible way in order to be more open and accessible to the community.

The VCF sector employs thousands of paid professional staff, sessional workers and volunteers who provide high quality service with ongoing support and self-development. Once activities and programmes are up and running staff, management committee members and volunteers continue to run the activities and strategic direction of the organization to a high standard.

3.0 Implications For Council Policy and Governance

It should be pointed out that providing high quality, specialist and innovative service is not always cheap. The ethos of the VCF sector as always been 'not for profit', however the ending of a number of funding streams and changes from grant funding to commissioning, procurement and income generation has resulted in the sector feeling vulnerable and at risk, this will start to impact on the sectors operations.

The coming year will most likely be difficult as the sector tackles the problems arising from lack of secure long term funding. However this situation presents an opportunity to stand back and review possibilities and even think out side the box all the time keeping at the front of our thinking the needs of our communities.

Time and understanding is an important factor in achieving the robust governance and performance management procedures you have come to expect, allow good appropriate timetabled time for reports, applications and returns as capacity in some grassroots groups can be an issue

Revenue funding and full cost recovery is seen as valuable for the sector.

It is acknowledged that strength lies in the VCF sectors ability to reach local and marginalised communities with their innovative, proactive and person centred approach to a diverse service delivery and project activity.
