

DECISION DETAILS ⁱⁱⁱ :	<p>The Director of Resources and Housing agreed to approve the transfer of 12 Grange View into the housing stock and secure its refurbishment to meet the Council's letting standard. Also, that the HRA funds the cost of the CPO including maximisation of the RTB receipts.</p> <p>Subject to a claim by the owner(s) under the provisions of Housing Act 1985 the cost of any compensation and associated costs be made available from the Housing Revenue Account to settle any claim against the Council.</p>
