The Statement of Purpose for the service is attached at Appendix B. The Statement of Purpose is required as part of the national minimum standards in order to be able to provide those services.

### 1 Purpose of this report

- 1.1 This report asks the Executive Board to consider the annual report of the One Adoption West Yorkshire (OAWY), as detailed in Appendix A of this report, as required by the National Minimum Standards 2011.
- 1.2 This report seeks elected member to approve the revised statement of purpose for OAWY. The Statement of Purpose for the service is attached at appendix B. The Statement of Purpose is required as part of the national minimum standard in order to be able to provide those services.

# 2 Background information

- 2.1 It is a requirement of the National Minimum Standards for Adoption Services, that each adoption service produces a statement of purpose, including its aims and objectives, a description of the service it provides and the facilities that are provided. This Statement of Purpose gives an outline of those requirements and also how the service is managed and its fitness to provide a comprehensive adoption service.
- 2.2 Children's service adoption service are inspected against these standards by Ofsted. The statement of purpose and any updates must be approved through the 'Executive side of the council' on an annual basis.
- 2.3 The Statement of Purpose attached give an outline of those requirements and also how the service is managed and its fitness to provide adoption service. It shows the policy and performance framework that underpins the work and shows how the welfare of children will be met. It also demonstrates the systems which we have set in place to recruit, assess, prepare and support adopters and to family find for children with a plan for adoption.
- 2.4 The Council's Executive Board is the most appropriate body to provide formal approval for the statement of Purpose and to review the work of OAWY. The background issues in relation to the adoption annual report are addressed in detail in the report itself at Appendix A.

#### 3 Main issues

3.1 The statement and annual report was last submitted to Executive Board in July 2017. The main issues are contained within the report itself at Appendix A.

OAWY is integral to these plans to provide stable and secure placements for looked after children.
