Site 1: Hyde Park & Woodhouse Ward TRO

The Issues:

Elected Ward Members, local residents/businesses, representatives of Leeds City Council's Refuse Collection and the local church have over the last 12 months requested traffic management intervention in the form of Traffic Regulation Orders to remove indiscriminate and obstructive parking at several locations within the Hyde Park & Woodhouse ward.

Proposals:

We seek authority for the expenditure of £20,000, comprising of £6,000 works, £13,000 staff and £1,000 legal costs, to promote a Traffic Regulation Order to amend and introduce waiting restrictions at the following locations within the Hyde Park & Woodhouse ward;

- Brudenell Street & surrounding area, Hyde Park: Implement restrictions to remove obstructive all day parking and improve junction visibility in residential area;
- Hyde Park Terrace/Hyde Park Road, Hyde Park: Implement restrictions to remove obstructive and indiscriminate parking over and across driveway and accesses. The church also has problems when they have funerals and weddings with access to park the hearse and wedding cars;
- Woodsley Green: Implement restrictions to remove obstructive and indiscriminate parking in off street residential parking area;
- Ebor Street, Hyde Park: Implement restrictions to improve access for refuse vehicles;
- Burley Road/Westfield Road area, Burley: Review existing waiting restrictions to optimise parking provision; and
- Meanwood Road/Cambridge Road, Meanwood: Amend existing loading restrictions around junction that are no longer suitable and extend existing no waiting restriction.

Recommendations:

- Give authority to incur expenditure of £20,000, comprising of £6,000 works, £13,000 staff and £1,000 legal costs, to promote a Traffic Regulation Order in the Hyde Park & Woodhouse ward; and

Site 2: A660 Leeds Road, Pool in Wharfedale

The Issues:

Following a recent fatality collision Elected Ward Members and local residents have requested traffic management intervention in the form of a reduction in the speed limit and the introduction of a hardstanding to enable Police enforcement action on the A660 Leeds Road approaching 'Barhouse' bends.

Proposals:

We seek authority for the expenditure of £20,000, comprising of £12,000 works, £7,000 staff and £1,000 legal costs, to promote a Speed Limit Order to amend the extents of the existing speed limits and construct a hardstanding to facilitate Police enforcement;

- Give authority to incur expenditure of £20,000, comprising of £12,000 works, £9,000 staff and £1,000 legal costs, to promote aa speed limit order n experimental Traffic Regulation Order in the Rothwell ward; and
- Request the City Solicitor to advertise a draft Speed Limit Order to remove indiscriminate and obstructive parking and if no valid objections are received, to make, seal and implement the Order as advertised.

Site 3: Wood Lane, Rothwell

The Issues:

Elected Ward Members and local residents have over the last 12 months requested traffic management intervention in the form of a Traffic Regulation Order to remove indiscriminate and obstructive parking along Wood Lane within the Rothwell ward.

Proposals:

Proposals:

We seek authority for the expenditure of £15,000, comprising of £5,000 works, £9,000 staff and £1,000 legal costs, to promote a Traffic Regulation Order to introduce waiting restrictions at the following locations within the Roundhay ward;

- Elmete Hill & Elmete Way: Implement restrictions to remove indiscriminative and obstructive parking that prevents refuse collection;
- Roman Crescent: Implement restrictions to remove indiscriminative and obstructive parking on bend;

- Street Lane/Cross Ingledew Crescent: Implement restrictions to remove indiscriminative and obstructive parking at junction;

Proposals:

We seek authority for the expenditure of £40,000 towards the overall highway improvement scheme currently being promoted for Middleton Lane in Thorpe.

Recommendations:

 Give authority to incur expenditure of £40,000 towards a highway improvement scheme currently being promoted for Middleton Lane in Thorpe.

Site 6: Chapel Allerton Ward TRO

The Issues:

Elected Ward Members and local residents have over the last 12 months requested traffic management intervention in the form of Traffic Regulation Orders to remove indiscriminate and obstructive parking at several locations within the Chapel Allerton ward.

Proposals:

We seek authority for the expenditure of £15,000, comprising of £4,000 works, £10,000 staff and £1,000 legal costs, to promote a Traffic Regulation Order to introduce waiting restrictions at the following locations within the Chapel Allerton ward;

 Albion Street/Pitfield Road, Carlton: Implement parking restrictions to remove indiscriminative and obstructive parking around junction;

- Park Lane/Styebank Lane, Rothwell: Implement parking restrictions to remove indiscriminative and obstructive parking around junction and bus stop;

We seek authority for the expenditure of £20,000, comprising of £9,000 works, £10,000 staff and £1,000 legal costs, to promote a Movement Order and a Traffic Regulation Order to introduce waiting restrictions at the following locations within the Gipton & Harehills ward;

- Amberton Terrace, Gipton: Implement parking restrictions to remove indiscriminative and obstructive parking adjacent to medical centre;

- Give authority to incur expenditure of £15,000, comprising of £5,000 works, £9,000 staff and £1,000 legal costs, to promote a Traffic Regulation Order in the Alwoodley ward; and
- Request the City Solicitor to advertise draft a Traffic Regulation Order to remove indiscriminate and obstructive parking and if no valid objections are received, to make, seal and implement the Orders as advertised.
