#### Summary of main issues

## 1. Purpose of this report

1.1 This report proposes an amendment to the Functions Reserved to Full Council as a consequence of a decision by the Director of Communities and Environment.

## 2. Background information

- 2.1 Article 15.2.3 provides that the Monitoring Officer is authorised to make any changes to any part of the Constitution which are required:
  - As a result of legislative change or decisions of the Council or Executive to enable her to maintain it up to date;
  - Or for the purposes of clarification only.
- 2.2 The Monitoring Officer has sub-delegated this function to the Head of Governance and Scrutiny Support.

## 3. Main issues

- 3.1 On 5<sup>th</sup> July 2018 The Director of Communities and Environment took an administrative decision which inter-alia renamed the Head of Elections, Licensing and Registration as Chief Officer Elections and Regulatory.
- 3.2 There is a need to reflect this change in title in the document recording Functions Reserved to Full Title as the post is appointed within that document as deputy Electoral Registration Officer.
- 3.3 An amendment to the Functions Reserved to Full Council is proposed as set out in Appendix A attached.
