The promotion of independent living contributes to the Leeds City Priority Plan theme of making Leeds the best city for health and wellbeing. The delivery of adaptation services contributes to the priority to 'Support more people to live safely in their own homes' and the headline indicator to 'Increase the proportion of people with long-term conditions to feel supported to be independent and to manage their condition'.
