# Report of Head of Catering Services Report to Director of Resources and Housing

**Date: 25 July 2018** 

Subject: To give authority to commence a procurement exercise to secure a contract for the supply of groceries and provisions.

# Summary of main issues

- 1. The purpose of the report is to approve the decision to commence a new procurement exercise for the supply of groceries and provisions.
- 2. The current arrangement using Yorkshire Purchasing Organisation (YPO) commenced on 24 July 2017. This is due to expire on 23 July 2019,
- 3 Procuring a new contract/arrangement will secure the groceries and provisions required by Leeds City Council at the best possible price. This will also ensure that suppliers are fully aware of any delivery requirements.
- If a procurement exercise is not undertaken, then either the service required by end users cannot be provided, or significant revenue spend will be incurred non-contract.
- 5 The value of the contract/arrangement is estimated to be £1,800,000 per annum

#### Recommendations

The Director of Resources and Housing is recommended to approve the authority to procure to secure a contract/arrangement for the supply of groceries and provisions. The contract/arrangement is due to commence 24 July 2019 for a period of three years.

### 1. Purpose of this report

1.1 This report details the reasons why a new contract/arrangement for the supply of groceries and provisions is required. The purpose of this report is to seek approval to commence a procurement exercise, which will see the award of a contract/arrangement for this supply. The contract/arrangement will be for three years commencing 24 July 2019.

# 2. Background information

- 2.1 The current contract is due to expire on 23 July 2019
- 2.2 A contract/arrangement for the supply of groceries and provisions is required to provide for the needs of schools, children's services and Adult Social care. Not to have a contract/arrangement in place will mean either the services required cannot be provided, or significant expenditure will be incurred non-contract.
- 2.3 The current demand is significant, and together with the expiry of the current arrangements means it is the right time to secure a new contract/arrangement for the provision of groceries and provisions. Due consideration will be given to the future demand for groceries and provisions.

#### 3. Main issues

- 3.1 The current arrangement for groceries and provisions has now operated for two years, and is used to provide groceries and provisions mainly to schools and Adult Social care sites.
- 3.2 The present arrangement has been monitored by Catering Leeds as it continues to operate. The level of customer service is deemed to be high, with few reported complaints, and has improved further due to a high level of contract management.
- 3.3 Grocery and provision prices tend to be relatively stable across the full range. Catering Leeds is looking to continue to reduce any potential impacts in adverse pricing be better working, in close partnership, with suppliers to use suitable alternatives where applicable.
- 3.4 Catering Leeds has clear product quality expectations and will not allow these standards to be compromised. However, Catering Leeds are always willing to review and consider new items that become available in the market.

#### 4. Corporate considerations

# 4.1 Consultation and engagement

- 4.1.1 It is not considered that the content of this report or the recommendation made will have a significant impact on any particular ward or community.
- 4.1.2 Consultation will take place with the end users and Children's Services.

### 4.2 Equality and diversity / cohesion and integration

- 4.2.1 An updated Equality, Diversity, Cohesion and Integration impact assessment screening has been carried out. This indicates that the provision of a full range of meals will have a positive impact within schools.
- 4.2.2 The positive effect of school meals is a Government aim to improve the standards of attainment within schools.

## 4.3 Council policies and best council plan

- 4.3.1 It is paramount within Leeds City Council is undertaken with a view to ensure openness, transparency and fairness. As such the contract/arrangement for the supply of groceries and provisions will be procured in line with Leeds City Council Procurement Commercial Services policies and procedures.
- 4.3.2 Evidence of added social value will be considered and this may be developed as part of the tender process.

# 4.4 Resources and value for money

- 4.4.1 Any contract/arrangement entered into as a result of the procurement exercise will be used for the purchase of groceries and provisions, which form an essential element of meals across Leeds City Council services.
- 4.4.2 Any contract/arrangement entered into as a result of the procurement exercise will be regularly reviewed by monitoring market conditions and trading indices to ensure continuing value for money.
- 4.4.3 Resources are available from both Civic Enterprise Leeds and Procurement Commercial Services (PCS) to meet the requirements of a tender exercise in order to award a contract / enter an arrangement.
- 4.4.4 There are no additional resource implications once a contract/arrangement is awarded/entered into.

#### 4.5 Legal implications, access to information, and call-in

- 4.5.1 The Director of Resources and Housing is authorise to make this decision to commence the procurement process.
- 4.5.2 Advice regarding any procurement exercise, including terms and conditions of contract/arrangement, will be obtained from PCS to ensure council governance is met.
- 4.5.3 The value of the contract is estimated at £1.8m per annum. This is a key decision and is subject to call in.

### 4.6 Risk management

4.6.1 There is no particular risk in approving the commencement of a procurement exercise.

#### 5. Conclusions

5.1 The current arrangement for groceries and provisions is coming to an end. To continue to provide a meals service for schools, Children services and Adult Social

- care, it is necessary to seek authority to procure with the view of awarding a contract/arrangement for the supply of groceries and provisions.
- 5.2 Not to approve the authority to procure to award a contract/arrangement for the supply of groceries and provisions, will mean either the service cannot be provided, or purchases to provide the service will be made non-contract.

#### 6. Recommendations

6.1 The Director of Resources and Housing is recommended to approve the authority to procure to secure a contract/arrangement for the supply of groceries and provisions. The contract/arrangement is due to commence 24 July 2019 for a period of three years.
