Good morning,

I am writing to object to the application by Lashkiri Nabi to license the premises of 13 - 15 Town Street, Armley, Leeds, LS12 1UG, the former Copper Lamp Café, which includes the provision for sale by retail of alcohol everyday 07:00 - 22:00 for consumption off the premises.

Since May 2016, Armley has been subject to a legally enforceable Cumulative Impact Policy, which requires new applicants to prove that a new license application will not make matters worse in Armley.

Given that street drinking and alcohol dependency are such significant concerns for local people living and working in Armley, a zero-tolerance policy must be maintained. The links between easily available alcohol and anti-social behaviour on Armley Town Street have created an atmosphere which is turning away people who would otherwise want to go there.

There is no doubt that the link between the high number of off-licenses in the Armley Town Street area selling strong alcohol at a cheap price, has been the main driving force for why problems due to street drinking has been a chronic problem for local residents. While efforts are made to ensure current licensees follow the law and police advice by not selling to under 18s and people who are clearly drunk, we must act now to ensure no more off-licenses open on Town Street in the foreseeable future.

The Cumulative Impact Policy on Armley Town Street is intended to take into consideration the high levels of street drinking and anti-social behaviour recorded by public health and the police. It must further ensure residents have a greater voice in local decisions that have a direct impact on their livelihoods, wellbeing and general experience of Town Street.

Earlier in the year, an application by Krol Mini Market, which is based at 2 - 4 Town Street, Armley, was refused a license to sell alcohol daily for consumption off the premises. The Krol Mini Market planned to sell alcohol between the hours of 09:00 and 22:00, two hours less than this application, but was refused due to the ongoing issues with alcohol-related anti-social behaviour, which continue to affect residents and shoppers on Town Street. There are already eighteen licensed sites in Town Street alone which contribute to anti-social drinking issues, and twelve of these are off-licences.

Armley Town Street must become a place where local people can enjoy their community. Therefore, I hope that the licencing committee will continue to support the efforts of the police, local community and Leeds City Council in addressing these issues by properly applying the Cumulative Impact Policy and preventing any new alcohol licences from being granted on Armley Town Street.

The alcoholics are killing themselves with drink, please don't encourage them to do this.





I am aware that there is an application for the premises at 13 - 15 Town Street to be granted a licence for the sale of alcohol.

The premises are set within the Armley Cumulative Impact area because of a number of issues we are already experiencing on Town Street.

The most obvious problem is the street drinking of alcohol which is all too readily available from 24 hour outlets on Town Street. Almost on a daily basis, about 8:00am, there are people consuming alcohol on the area by William Hills and around the junction of Hall Road and Town Street. The road to the rear of my premises, Back Esmonde Terrace, is frequently used as a public urinal and we have had people passed out on the street.

The consumption of alcohol continues through the day and is not only a public nuisance but leads to further disorder and crime, such as illegal sales of illicit alcohol, robbery and shop lifting. I have also been threatened when going for a sandwich at lunch time, however I have to be very careful as I park my car on Hall Road and I need it for work.


Some of the shops on Town Street provide a really useful service and are widely used by families, but the presence of drunks, beggars, drug suppliers and users on the street is not acceptable for children to come into contact with.

Armley does not need a further outlet for alcohol sales.




