- iv See the Executive and Decision Making Procedure Rules for eligibility. - If the decision is exempt from call-in a reason must be provided in the 'Notice / Call-In' box and in the report. The call-in period expires at 5pm on the 5<sup>th</sup> working day after publication.
