

# Equality, Diversity, Cohesion and Integration Screening

The service has admission criteria based on bereavement status. It is open to all families with a child who has lost a close relative or significant adult. One of the method statement questions will be on how the service will ensure that it is culturally sensitive as different cultures and religions have different customs and beliefs around death.

All group sessions will be accessible to eligible families regardless of their equality characteristics. They will bring people from different backgrounds together who share the experience of bereavement.

We will ensure that the service is culturally sensitive and monitor the ethnicity and religion of families entering the service. If a particular ethnic or religious group is under-represented we will pick this up through performance monitoring and encourage the provider to strengthen links within these communities to ensure it is accessible to all.

Volunteering is a key part of the service and we will encourage the service to recruit a diverse pool of peer supporters and volunteers.
