2. Please provide a brief description of what you are screening

Leeds City Council host a number of world class events throughout the city every year attended by thousands of people from a broad range of ethnic backgrounds. Events of this size require rigorous partnership planning between the council, emergency services, and the local community, and traffic management services are an important part of this process. Leeds City Council has worked with Streetwise UK Management Ltd at events for a number of years, and have found that the company is able to employ operatives who have earned the respect of the community, this being an important consideration for the management of these events which attract at times a boisterous and energetic audience with due cultural sensitivity. The decision requests such a waiver with respect to the procurement of traffic management services at relevant events in 2018 & 2019, in order to ensure that the events are managed safely in the interests of the local and wider community.

The decision is to appoint Streetwise UK Management Ltd to provide traffic management services at relevant events in 2018 & 2019 via a waiver of procurement procedures. Leeds City Council has worked with the organisation previously to provide services for these events, and have found that the company is able to employ operatives who have earned the respect of the community, this being an important consideration for the management of these events which attract at times a boisterous and energetic audience. They have been integral in the preparation of the overall event strategy and developed significant operational knowledge and local insight into previous events, which in turn has resulted in these running smoothly in previous years. The selection of the appropriate provider is essential to the successful running of these events in a manner which would maintain community cohesion and harmony. For the above reasons it is considered that it would be extremely difficult to procure an alternative provider of the same caliber, expertise and experience which command the respect of the local community, WY Police and the Safety Advisory Group. Additionally the council gains assurance by using a supplier successfully utilised in the past with a tried and tested service and expertise in maintaining robust control of events.

If the decision is not implemented then the event is at significant risk of disruption, civil disorder, or potential cancellation as it would be extremely difficult to procure effective alternative services that have the trust and confidence of the community.
