2. Please provide a brief description of what you are screening

The decision to vary the existing contract held with Humankind for the Community Drug and Alcohol Prevention, Treatment and Recovery Service to include existing services for, drug and alcohol activity and medical costs to continue ongoing delivery (£245,000 per annum); enhanced needle exchange provision to support harm reduction (£40,000 per annum); existing residential detox programme (£180,000 per annum) and the re-instatement of the personalisation budget in order to tailor treatment to vulnerable patients including supervised consumption at home (£18,720 per annum). These annual amounts will be valid for the entirety of the contract, including extension provision. This variation to the existing contract held with Humankind is the subject of this screening.

In 2014 the contract for delivery of a combined drug and alcohol prevention, treatment and recovery service for adults, children and young people in Leeds was awarded to Humankind with the new service commencing on 1 July 2015. The service (known as Forward Leeds) is delivered by Humankind in conjunction with consortium partners Barca, St Anne's, and Leeds and York Partnership Foundation Trust with the involvement of a number of GP practices across the city. Associated with the delivery of this service are a number of items of expenditure which are essential components of the service which are paid for separately by the Council. Now that the service has been operational for a period of 3 years, anticipated levels of annual expenditure have been reasonably established for inclusion within the contract for the delivery of a combined drug and alcohol prevention, treatment and recovery service for adults, children and young people in Leeds. The forecasting of budgets for these items has involved discussions with and the provision of information from Humankind and their delivery partners as appropriate.

In 2017/8 there was an increase in presentations to Forward Leeds for support with injecting drug use. The amount of people receiving treatment for injecting drug use rose to 776 during that year and this is expected to increase further in 2018/9. These are injecting users who have chosen structured treatment, but in addition to this Forward Leeds is seeing increasing numbers of people who are engaging with needle exchange programmes but who have not yet chosen to enter treatment. There is also a cohort of people who are injecting substances who are not in touch with any services. On 26 June 2018, representatives from the Cleaner Neighbourhoods Team, Waste Collection, City Centre Cleansing and Enforcement Team, Forward Leeds, Public Health and the Adults and Health Commissioning Team attended a meeting to discuss the issue, gaps in the current service, and to jointly develop a proposal for working together which would enhance the current provision, contribute to the reduction of needle waste in the city and reduce the risk of future needle stick injuries. The increase in needle exchange provision to address the issue of the amount of drug related litter being reported across the city is considered essential due to the public health risk, the reputational risk to both Leeds City Council and Forward Leeds, and the need to make sure Leeds is a safe place for all its citizens and communities.

Supervised consumption is a key part of treatment for opiate substance misuse. Any temporary break or long term cessation can result in delayed or unsuccessful completion of treatment. It also increases the risk that the client will take illicit substances which could further harm their health and result in increased GP visits or hospital admissions as many of the clients who require the service at home have chronic conditions which would

be exacerbated and require medical attention. For those with terminal conditions, being able to continue receiving supervised consumption is important in terms of the associated harm reduction benefits and ensuring they receive quality end of life care. A review of supervised consumption took place in 2018. The review highlighted that Forward Leeds have a small number of clients (circa 10-12 at any one time) who require treatment for opiate addiction at home because of disability (e.g. double leg amputees), chronic illnesses such as COPD (some are end of life) or as a short term measure while recovering from an acute condition. Re-instatement of the personalisation budget to tailor treatment to vulnerable patients will allow Forward Leeds to take responsibility for all arrangements between the pharmacist and the client for the provision of supervised consumption in the home including appropriate quality assurance and the management of risk associated with home visits. Forward Leeds has already established a good working relationship with Living Care pharmacy and would look to continue this. Checks have been made to ensure CRB checks and Standard Operating Procedures are in place. Ensuring continuity of provision will ensure that this vulnerable client group continues to have access to safe and effective drug treatment services in accordance with recommended best practice for safe and effective treatment as set out in the Department of Health's Drug Misuse and Dependence: UK guidelines on clinical management (updated 2017).

In 2017/18 Humankind assumed responsibility for managing the Residential Detoxification Treatment Service and ensuring that it was used to support those clients who most benefit from residential detox treatment. Residential detox remains an integral element of the overall Forward Leeds service.

Key findings

Drug and alcohol activity and medical costs to continue ongoing delivery are considered essential components for delivering quality drug and alcohol service provision that is safe and effective. The effectiveness of drug and alcohol services across Leeds would be adversely impacted without these aspects of service provision, especially in relation to broadening access to care through GP practices and providing effective treatment and preventative measures across the service.

Positive Impact of Enhanced Needle Exchange Provision:-

Forward Leeds:

1. Will be able to enhance the current offer of picking up disposed needle waste in the city by aiming to collect them within the hour.

2. Has the specialist knowledge to collect all waste associated with drug use and not just needles.

3. Will be able to collect waste from private land – something that would be particularly welcomed by businesses. Collection of needle waste will be done in tandem with any enforcement action that LCC is undertaking, increasing public safety while this process is taking place.

4. Will give Forward Leeds the opportunity to engage positively with local businesses

and communities affected by needle waste and provide reassurance that action is being taken.

5. Will be able to develop relationships with the needle exchange pharmacies and deliver concentrated training to upskill pharmacy staff and increase understanding around the importance of needle returns.

6. Will be able to deliver brief interventions (as well as reaffirm messages around the importance of safe needle disposal) to service users present when they are cleaning sites. This would bring opportunistic interventions which are currently missed in the city and therefore hopefully increase the number of people entering the service. It is an excellent opportunity to engage with people who would otherwise not approach Forward Leeds for support.

7. Will be able to build up a useful intelligence map (that both complements intelligence held by the Cleaner Neighbourhoods Team and draws upon it, as well as something that will be shared with them) of where equipment is being discarded, enabling the Harm Reduction Team to target certain areas for outreach work and be proactive at going out to those spots.

8. Will be able to empty the bins, and record and monitor the contents in order to determine how they are being used and if they are in the right locations (or need to be moved).

9. If sex related litter is present this will also be cleaned up. Forward Leeds has a close working relationship with both Basis and the Joanna project, so will be able to quickly share information if sex related litter in an area suggests sex work is taking place.

The service users who require supervised consumption at home are some of the most chronically ill and / or disabled service users within the Forward Leeds service who by the very nature of their illness or disability are unable to access the pharmacy based supervision consumption service. Providing supervised consumption at home will ensure this cohort of patients have equal access to clinical provision and enable those who are at the end of life to experience a more dignified death with appropriate care.

Transferring responsibility for managing the Residential Detoxification Treatment service from Leeds City Council to Humankind has made residential detox a more integral element of the overall Forward Leeds service and streamlined the process for allocating funding to clients to access detox treatment. It has enabled Forward Leeds to make more informed decisions around planning and prioritisation of placements. Forward Leeds has a detailed understanding of residential options and is able to match the client to the most appropriate establishment to suit their treatment needs and has developed strong relationships with residential treatment providers, ensuring smooth transitions from community to residential services and back again. Forward Leeds are also well placed to negotiate best prices and ensure value is added to service delivery wherever possible.

Officers in the Commissioning Team will continue to work closely with Humankind through the established contract monitoring processes to review expenditure levels and forecasts on a regular basis and will work together to identify and realise annual service efficiencies in future years. If there is any additional budget required due to increased activity, the provider and commissioner will review to ensure there is no risk to clinical

services and a seamless service is provided for service users.

Clinical advice will be sought on prescribing, testing and vaccination formularies for the service which besides demonstrating good practice and compliance with NICE guidance and the British National Formulary will help ensure Leeds City Council is only incurring legitimate costs relating to the treatment of addiction.
