This proposal is good for the people of Headingley, good for the people of Hyde Park and good for Woodhouse Moor.

It's good for the people of Headingley because the reality is that Headingley has very little green space of its own. If people recognise this, they'll realise the importance of protecting the little green space that Headingley has left. The inclusion of Woodhouse Moor inside the Headingley Neighbourhood Forum's designated area, wrongly gave the impression that Headingley has a greater area of green space than is actually the case.

It's good for the people of Hyde Park because the majority of the people who live in Hyde Park have no garden of their own. This means that it is in their interests to protect Little Moor from encroachment and inappropriate proposals. And because of their location on the doorstep of Little Moor, they are literally better placed to watch over and protect Little Moor and help make it an even better green space for all members of the local community than it is at the moment.

The members of the Hyde Park Neighbourhood Forum have always wanted Little Moor to be a part of their Neighbourhood Plan. This is evidence of their attachment and commitment to the area. This proposal, which is a result of their efforts. Is further evidence.

This proposal is good for Woodhouse Moor because having the Moor split between the Headingley Neighbourhood Plan and the Hyde Park Neighbourhood Plan makes it far harder to formulate a single vision and an integrated plan for the park's future. In addition, having the park split between two neighbourhood plans lowers the park's prestige and status as the city's oldest park. If the park could be divided between neighbourhood plans, then it could be divided up for other reasons too. Sections of a divided park could be sold to developers or neighbouring landowners.

The Friends of Woodhouse Moor see Woodhouse Moor as a unit and welcome the proposal to add the area of Little Moor to the Hyde Park Neighbourhood Plan's designated area. The aim of the Friends to improve the entire park will be facilitated by the inclusion of Little Moor in the Hyde Park Neighbourhood Plan's designated area. Having to liaise with just one neighbourhood forum will make the tasks of planning and fund raising more straightforward, and therefore more likely to achieve success.
