Leeds Children and Families Services currently commissions Northpoint to deliver an individual counselling service individual counselling service for Parents/Carers of children aged 0-5 years' in the Children's Centres located in the 30% most deprived areas of Leeds. This contract is due to expire on 30<sup>th</sup> June 2019.

The objectives of the service are to deliver an early intervention emotionally responsive service to prevent unnecessary escalation to more targeted services. The main outcomes are:

- Children able to live in safe and supportive environments.
- Parents maximise emotional health and wellbeing such that they are able to support and parent in the best possible way.

We are now in the process of re-commissioning for a new contract to start on 1<sup>st</sup> July 2019.
