Thanks for your recent application for a new premises licence in Crossgates

I take note of its contents and the measures you have offered, which will appear as conditions of the licence once it is issued

I am just a little intrigued and unclear on a couple of aspects of the application, which I hope you can answer before I sign this off-

- In section M of your application at the 'Restaurant' section (7PF046 to 7PF050), you have ticked all boxes except 7PF047, even though your submitted plan clearly shows a number of structures which resemble tables being used as 'covers' (and you have offered "the service of table meals" at 7PF048)? And
- 2 Staying with the plans, a number of similar structures which resemble tables, are shown both inside and outside the premises. You have ticked you want consumption both 'on' and 'off' the premises in your application which is fine, but then you have offered 7PF039 which in the first sentence reads "Drinks, open bottles and glasses will not be taken from the premises at any time"
 - What actually constitutes 'on' and 'off' sales and how this should be shown on plans can be confusing I attach a copy of the relevant sections of the current statutory guidance which now tries to explain this situation at paras 8 35-8 37
 - However, if as I suspect you wish the use the outside tables for consumption only, then this will be classed as an 'off' sale in accordance with the guidance, but then your offer at 7PF039 prevents this from happening strictly speaking

Please confirm exactly what you wish to do in the outside area on the plan as you have submitted it, since the plan as submitted will form an integral part of the premises licence once it is issued?

I look forward to your reply on the two points, before making any further comment at this stage
