This contract is due to expire on 30th June 2019.

The objectives of the service are to deliver an early intervention emotionally responsive service to prevent unnecessary escalation to more targeted services. The main outcomes are:

- Children able to live in safe and supportive environments.
- Parents maximise emotional health and wellbeing such that they are able to support and parent in the best possible way.

We are now in the process of re-commissioning for a new contract to start on 1st July 2019.
