 - a performance of amplified live music between 08 00 and 23 00 on any day in a church hall village hall, community hall or other similar community premises, that is not licensed by a premises licence to sell alcohol provided that (a) the audience does not exceed 500 and (b) the organiser gets consent for the performance from a person who is responsible for the premises
 - a performance of amplified live music between 08 00 and 23 00 on any day at the non-residential premises of (i) a local authority or (ii) a school, or (iii) a hospital,
