

Consultation on Local Lettings Policy for New Build in Holbeck, Leeds 11.

Report of findings - March 2019

1 Introduction

Over the next five years, the Council House Growth Programme aims to deliver over 1500 new properties. 28 properties on the Meynell site in Holbeck are due to be handed over in early 2020. The consultation to collect the views and opinions from current and prospective tenants about the local lettings policy for these properties was completed in February 2019 using a survey questionnaire.

Housing Leeds sent the survey out to 252 applicants on the Leeds Homes Register who had specified Beeston & Holbeck as their area of first choice. The questionnaire was also made available at the local area housing office during the period 8th Feb - 28th Feb 2019; a consultation day was held in the local community on the 27th Feb 2019.

2 Survey Sample

93 tenants and residents completed the consultation questionnaire (81 responded to the posted questionnaire, 12 of the responses originated from the consultation day event). 72 respondents live in the LS11 area. The full breakdown of responses is detailed below.

3 Report Findings


The results found that respondents would give preference for housing offers to: Leeds City Council tenants living in the Beeston & Holbeck ward (67%), applicants with a local connection to the Beeston & Holbeck ward area (93%), and applicants who have a good tenancy record (96%).

Respondents also felt that preference for offers of housing should be given to applicants living in a home too big for their needs (63%), followed by applicants in priority need (74%) and applicants in employment (68%).

4 Consultation Questions


The first question "Do you agree that the following groups should be given preference for offers of the new homes (tick all that apply)" was broken down into 6 sections (labelled Q1 - 6). Participants were also asked to provide any additional comments (Q7).

Q1. – Applicants with a good tenancy record





Q2. - Leeds City Council tenants living in the Beeston & Holbeck ward





Q3. – Applicants with a local connection to the Beeson & Holbeck ward area - including living, working or having close family in the area





Q4. Applicants who are in a house too big for their needs





Q7 asked for any other comments – 23 comments were made; these have been grouped as follows: (7) expressed an interest in the properties (for reasons including, overcrowding, suffering from ASB, children living at height; (1) felt these properties should be allocated to applicants who have been tenants for the longest time; (3) supported the local connection criteria and (3) supported giving preference to applicants with a good tenancy record, (2) felt that an age restriction for applicants should be applied. Other preference group suggestions included (1) homeless, (1) single Dads, (1) disabled applicants and (1) overcrowded applicants. (3) Supported giving preference to employed, local connection and giving preference to applicants in priority need.


5 Equality Monitoring Questions

The ethnicity of those responding to the survey is shown in the chart below:




Disability

The pie charts below show the proportion of people who identify themselves as disabled and the nature of their disability (applicants could tick more than one box).





Nature of disability








52% of respondents stated they actively practice their religion.


Carers

26% of respondents identified as being carers.




Respondents' housing type
