Decision to award a contract, without competition, to North Yorkshire County Council for delivery of Learning Improvement Advice consultancy. The contract will be for the provision of two Learning Improvement Advisers for an average of two days per week to work within Children and Families Learning Improvement services. This arrangement is the preferred option to ensure high quality learning improvement advice is in place rapidly. The contract will commence on 11 th March 2019 and will be for a period of 21 weeks, expiring 31 st July 2019.

This service will support the following priorities of the Children and Young People's plan:

- Increase the number of children and young people participating and engaging in learning
- Improve achievement and attainment for all
- Improve at a faster rate educational progress for children and young people vulnerable to poor learning outcomes
