2. Please provide a brief description of what you are screening

This screening document considers the potential impact of awarding a new five year contract (with the option to extend by a further two years) to St Anne's Community Services from 1 October 2019 for the provision of a combined residential alcohol detoxification and rehabilitation service.

The two existing interim contracts for the residential detox and rehab services expire on 30 September 2019. A Market Sounding Exercise (MSE) has been undertaken, which has demonstrated that there is an extremely limited market for this provision. St Anne's were found to be the only provider able to deliver the service in

accordance with the Council's requirements and within the maximum available budget.

Approval is now being sought from the Director of Adults and Health to procure the 'Residential Alcohol Detoxification and Rehabilitation Service' with St Anne's utilising the negotiated procedure without publication of a notice under regulation 32 (2) (b) (ii).
