The intention to vary the Home Plus (Leeds) contract, in response to the securing of additional investment from Leeds CCG.

It is intended to use this funding to address the longer-term strategic ambition of the CCG to focus investment on reducing health inequalities, and will be used to increase provision to those living in more deprived areas of Leeds and those from BAME backgrounds.

It will pay for a dedicated outreach post to build links with primary care (including LCPs), other health agencies, community networks and relevant voluntary sector organisations, and additional staff capacity and works budget to meet the increased demand.
