1. Purpose of this report

1.1 This report sets out changes to give effect to a decision of full Council establishing a Joint Health Overview and Scrutiny Committee (Vascular Services).

2. Background information

- 2.1 Article 15.2.3 provides that the City Solicitor, in her role as Monitoring Officer, is authorised to make any changes to any part of the Constitution which are required:-
 - As a result of legislative change or decisions of the Council or Executive to enable them to maintain it up to date; or
 - For the purposes of clarification only.
- 2.2 The City Solicitor has sub delegated this authority to the Head of Democratic Services.

3. Main issues

- 3.1 At its meeting on 11th September 2019 Full Council:-
 - Resolved to appoint a mandatory North Yorkshire and West Yorkshire Joint Health Overview and Scrutiny Committee (Vascular Services) together with the authorities set out at paragraph 3.3 of this report;
 - Approved the terms of reference for the mandatory North Yorkshire and West Yorkshire Joint Health Overview and Scrutiny Committee (Vascular Services)
 - Delegated relevant functions which shall be exercisable by the mandatory North Yorkshire and West Yorkshire Joint Health Overview and Scrutiny Committee (Vascular Services), subject to the terms and conditions specified.
 - Agreed to appoint the following members from the Council's Scrutiny Board (Adults, Health and Active Lifestyles) as the Council's representatives to serve on the mandatory North Yorkshire and West Yorkshire Joint Health Overview and Scrutiny Committee (Vascular Services):
 - o Councillor Helen Hayden; and
 - Councillor Graham Latty.
- 3.2 An amendment to the joint arrangements section of the Constitution is recommended as set out at Appendix A to reflect the appointment of this joint committee.
- 3.3 As it is appointed as a mandatory joint committee in response to a consultation of the participating authorities by NHS England in relation to vascular services, the JHOSC's terms of reference relate solely to that consultation and the JHOSC will cease to meet on completion of the review of vascular services. A further

amendment to the constitution is therefore recommended as set out at Appendix B to remove reference to the joint committee when it has fulfilled its terms of reference.
