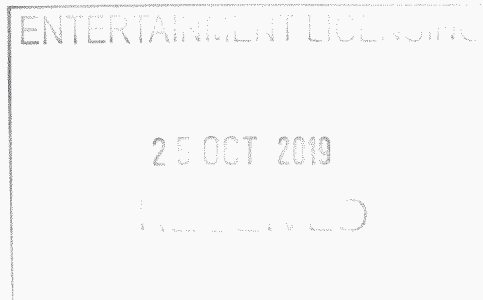
Until that point, I have no alternative but to send this representation by email.

To whom it may concern:

Thank you for your recent application for a new premises licence at the subject restaurant / address.

West Yorkshire Police have no outright objections to your application at present, however, we would like the further information outlined provided or clarification on the following points, before we write this off altogether-

- The date and place of birth of the proposed designated premises supervisor Sajid Ali,
- Working from the V8 pro-forma risk assessment you have supplied with your application (and even though page 13 of your PREM 1 application refers to codes from the V7 predecessor)-
 - (a) Code 8PF011 – Communication – given the descriptive guidance, why do you think your premises needs to have this measure as a condition?
 - (b) Code 8PF012 – age verification policy – you have not distinguished between a Challenge 21 or a Challenge 25 policy – which one is it to be?
 - (c) Code 8PF013 – this is in direct contradiction to the box you have ticked on page 10 of your PREM 1 application – consumption both on & off the premises. If you wish the V8 code to remain you must amend the box on page 10 to 'on' only? Alternatively, if you want the box on page 10 to remain the same you must delete code 8PF013?
 - (d) If you choose the latter, I assume your 'off' sales will be with food only, to tie up with your 'on' sales?
 - (e) Finally, firstly subject to your answers to (c) and (d), you should then consider if 8PF023, 8PF024 and 8PF025 are also appropriate to your circumstances, again in line with the guidance given at this point of the V8 document.

I look forward to your reply in due course.
