1. Purpose of this report

- 1.1 The purpose of this report is to present further information on the West Yorkshire and Harrogate Health and Care Partnership (the Partnership) draft five year strategy.

2. Background information

- 2.1 NHS England and NHS Improvement published the NHS Long Term Plan (LTP) in January 2019; which was then supplemented by the NHS LTP Implementation Framework at the end of June 2019.
- 2.2 The NHS LTP Implementation Framework provided further detail and specific requirements for local health and care partnerships (i.e. Sustainability and Transformation Partnerships (STP) / Integrated Care Systems (ICS)) – i.e. to agree a plan for delivery through to 2023/24 that will include:
- **A System Narrative:** to describe how we will deliver the required transformation activities to enable the necessary improvements for patients and communities as set out in the NHS LTP.
 - **A System Delivery Plan:** to set the aggregate plan for delivery of finance, workforce and activity, and setting the basis for the 2020/21 operational plans for providers and clinical commissioning groups (CCGs). The system

delivery plan will also cover the NHS LTP 'Foundational Commitments'. This relates to the NHS components of the strategy.

- 2.3 A report presenting the Partnership draft system narrative was considered by the Partnership Board at its meeting on 3 September 2019. These details were subsequently considered by the West Yorkshire Joint Health Overview and Scrutiny Committee (the Joint Committee) at its meeting on 10 September 2019.
- 2.4 As reported at the time, work to produce the accompanying System Delivery Plan was underway, being coordinated by NHS England / NHS Improvement.
- 2.5 The Planning Timetable for producing the 5-Year Strategy that was set out in the Partnership Board report and presented to the Joint Committee is set out below:

3. Main Issues

- 3.1 The draft system narrative was considered by the partnership Board at its meeting on 3rd September 2019 and subsequently considered by this Joint Committee on 10th September 2019.
- 3.2 An extract from the draft minutes of the Joint Committee meeting held 10th September 2019 that summarises the main areas of discussion and outcomes are presented at Appendix 1.
- 3.3 An update provided by the West Yorkshire Health and Care Partnership is provided at Appendix 2, along with a copy of the draft system narrative (Appendix 3) and presentation slides (Appendix 4) previously considered by this Joint Committee on 10th September 2019.
- 3.4 Appropriate representatives from the West Yorkshire and Harrogate Health and Car Partnership have been invited to attend the meeting to assist the Joint Committee in its consideration of the information presented and address any questions raised.

4. Corporate considerations

4.1 Consultation and engagement

- 4.1.1 Details on the engagement with the public and patients to develop the strategy document were included in the 10th September paper to Joint Scrutiny Committee. - 4.1.2 It is understood that since the September 2019 Joint Committee meeting, the WYH Partnership has undertaken a number of opportunities to engage with partners, relevant governing bodies on the content draft strategy.
- 4.1.3 This report provides an opportunity for the Joint Committee to provide any additional comments or questions before a revised draft of the plan is presented to the Partnership Board on 3rd December in its role of critical friend.
- 4.1.4 The Joint Committee may also wish to consider how it wishes to relay any additional comments or queries to the Partnership Board when it meets on 3rd December,

4.2 Equality and diversity / cohesion and integration

- 4.2.1 The 5 Year Strategy makes consistent and explicit reference to addressing health inequalities – the unjust and unwarranted differences in health outcomes based on age, ethnicity, gender, class or socio-economic status and includes the intention to specifically monitor our progress as a partnership

against these health inequalities and to take specific action to addressing the barriers to equitable health and care for all people who live here.

- 4.2.2 As the plan is put into action, there may be equality and diversity issues that members of the Joint Committee wish to explore in more detail.

4.3 Council policies and best council plan

- 4.3.1 There are no specific implications arising from this report; however members of the Joint Committee may wish to explore how specific programmes of work outlined in the draft five year strategy support individual, place based corporate priorities and policies.

Climate emergency

- 4.3.2 There are no specific implications arising from this report; however members of the Joint Committee may wish to explore how specific programmes of work outlined in the draft five year strategy impact on climate emergency declarations.
