Background and current status

From 12 August – 29 September 2019, a period of public consultation was undertaken to gather feedback on proposals for cycling access improvements in South Leeds (Dewsbury Road and Elland Road) and Clay Pit Lane. The feedback from this has now been collated and a high level breakdown of the data follows.

Headline findings – South Leeds (Dewsbury Road)

A total of 102 surveys were completed (23 from events, 79 online) for both Elland Road and Dewsbury Road

- The majority of journeys (81%) made were longer journeys which involved travelling along and beyond the road, and the most common reason for travelling in the area was living in the area (40%)
- The most common mode of transport is private vehicle, 64%.
- In terms of agreement with the plans, 48% of respondents selected either "agree" or "strongly agree" to the plans.
- However, nearly half (46%) selected 'I am unlikely to consider an alternative method of travel' as a result of the improvements. When asked why this would be unlikely, 40% selected 'My current mode of transport is more suitable for my journey'.
- The most common thematic comments surrounding the scheme were that it should not be delivered, that it would be detrimental to other cars/congestion and suggestions of alternative plans to consider.

Headline findings - South Leeds (Elland Road)

- The majority of journeys (73%) made were longer journeys which involved travelling along and beyond the road, and the most common reason for travelling in the area was living in the area (39%) and work/work related (33%)
- The most common mode of transport is private vehicle, 68%.
- In terms of agreement with the plans, 53% of respondents selected either "agree" or "strongly agree" to the plans.
- Considering if the plans would affect their current method of travel, 45% of respondents selected "I may now consider walking and/or cycling on Elland Road" however 39% selected "I am unlikely to consider an alternative method of travel"
- When asked why this would be unlikely, 42% selected 'My current mode of transport is more suitable for my journey'.
- The most common thematic comments surrounding the scheme were of general support, desire for an extension of the scheme and support for segregated cycle lanes.

Headline findings – Clay Pit Lane

- There were a total of 41 survey responses, however one response was submitted with no answers, so this was excluded from the analysis.
- The most common reason for travelling in the area was: "work/work related"
- The most common mode of transport is private vehicle.
- 65% of respondents selected either "agree" or "strongly agree" to the plans.
- 68% selected 'very likely' or 'likely' to the likelihood of using the planned improvements.
- The most common thematic comments surrounding the scheme were a necessity for the cycle route to be segregated, existing issues with the road and the need for improved cycling infrastructure and connections alongside these plans.

Next steps

Over the coming weeks a more detailed analysis will be undertaken to further understand the reasoning behind the headline results. This will include a thorough examination of all the qualitative responses plus a more in-depth evaluation of the quantitative data. All findings will be compiled into a detailed outcome report which will be made available shortly after completion.










