


Delegated Decision Notification (DDN)

This form is used both to give notice of an officer's intention to make a key decision and to record any delegated decision which has been taken. The decision set out on this form therefore reflects the decision that it is intended to be made, or that has been made. Although set out in the past tense a decision for which notice is being given may be subject to amendment or withdrawal.

Subjectⁱⁱ:	To seek authority from the Director of Adults and Health to enter into a contract with Touchstone- Leeds to deliver the Sikh Elders Service. The total value of the contract to be awarded for the five year contract period is £316,219.37. The total value of this decision, including any extension periods is up to a maximum of £442,725.
Decision detailsⁱⁱⁱ:	The Director of Adults and Health approved the award of the contract under Contract Procedure Rule 18.1 (Awarding Contracts) to Touchstone-Leeds for the provision of the Sikh Elders Service at a total cost of £316,219.37 for the five year contract period. The contract is to commence on 1 April 2020 and will run for 5 years with an option to extend up to a further 24 months in any combination. Approval of a 24 month extension period would take the total value up to a maximum of £442,725.

- ⁱ The leader of the council may also make executive decisions and should be specified as the lead director where appropriate.

- ^v If the decision is exempt from call-in a reason must be provided in the 'notice or call-in' box and in the report. The call-in period expires at 5pm on the 5th working day after publication. Scrutiny support will notify decision makers of matters called-in no later than 12 noon on the 6th working day.
- ^{vi} If the decision would have been a key decision but for an exception set out in article 13.4(b), please refer to the connected key decision in the decision details (either by the title or the reference number).
- ^{vii} Administrative decisions do not need to be published on the council's website but this form may be used for internal recording of the decision.
- ^{viii} All key decisions should appear on the list of forthcoming key decisions for 28 clear days before the decision can be taken. If 28 clear days' notice has not been provided, a reason must be provided here.
- ^{ix} No member having a disclosable pecuniary interest or officer having an interest in any matter (whether pecuniary or otherwise required to be declared) should take a decision in relation to that matter. Other interests of a non-disqualifying nature should be recorded here. Any dispensation in place in relation to the matter should also be recorded here.
- ^x This may include other elected members, officers, stakeholders and the local community.
- ^{xi} Please include proposed timescales for commencement and / or completion of implementation as appropriate.
- ^{xii} Please insert a complete telephone number whether land line or mobile, rather than an extension number so that you can be contacted from outside the council.
- ^{xiii} The signatory must be duly authorised by the lead director to make a decision in accordance with the relevant sub-delegation scheme. It is not acceptable for the signature to be 'pp' for the authorised signatory. For key decisions only, the date of the authorised signature signifies that, at the time, the officer was content that the decision should be taken. However, should representations be received following public availability of reports the signatory will consider the effect which such representations should have on the final decision.
