Summary

1. Main issues

- This decision relates to Key Decision D50589 to spend £200,000 of Housing Leeds capital funding along with £635,700 external grant funding on a programme to install air source heat pumps in 100 off-gas Housing Leeds properties.
- The decision was published on 20/02/2020 and due to come into effect from 07/03/2020.
- As a result of us missing a deadline to sign the grant contract with the Warm Homes Fund, their offer of external funding was withdrawn. We have since asked them to reconsider, and offered to sign the grant agreement by return of post, which will require us to exempt decision D50589 from call-in.

1. Purpose of this report

1.1 The purpose of this report is to outline the reasons for exempting decision D50589 pertaining to the installation of 100 air source heat pumps in council homes.

2. Background information

- 2.1 On 20/02/2020 key decision D50589 was submitted to the Director of Resources and Housing to spend £200,000 of Housing Leeds capital funding along with £635,700 external grant funding on a programme to install air source heat pumps in 100 off-gas Housing Leeds properties.
- 2.2 The decision was published on 20/02/2020 and due to come into effect from 07/03/2020.

3. Main issues

- 3.1 Due to various issues, the council were unable to meet the deadline provided by the Warm Homes Fund to have the funding agreement with them signed. As a result of this, the Warm homes Fund withdrew their offer of funding.
- 3.2 On 4th March 2020, the Director of Resources and Housing contacted the Warm homes Fund directly asking them to reconsider their position and offering to sign the funding agreement by return.
- 3.3 In order to do this, key decision D50589 will need to be retrospectively exempted from call-in.
