- a) I am screening a request to invoke up to a 12 month extension period to the Aspire contract which provides supported living, respite and emergency respite care and day opportunities to people with learning disabilities across Leeds. The extension will allow time for a full service review process to be undertaken for the Aspire contract which is being carried out alongside a wider review of all learning disability commissioned day opportunities and respite services. There are no proposed changes to the terms of the original contract so the extension will not cause a differential impact.
