Stoke were judged to be ‘inadequate’ by OfSTED in an inspection of children’s services in 2019. The Council are therefore subject to DfE intervention. The DfE Commissioner who is leading the intervention worked with Leeds previously in Kirklees. As such there have been negotiations to agree a partnership between the two Councils to help share Leeds’ learning and good practice.
