2. Please provide a brief description of what you are screening				

The Community Drug and Alcohol Prevention, Treatment and Recovery Service, known as Forward Leeds, includes a dedicated team of workers delivering targeted interventions in GP practices across Leeds. This work has been fully funded by the Leeds NHS Clinical Commissioning Group (CCG).

The contract with Humankind for the Forward Leeds service has been extended to 30 July 2023. Discussions have taken place with the CCG regarding ongoing funding to enable the delivery of the GP interventions to continue. Funding totalling £1.107m (£369k p.a.) for the period 1 July 2020 to 30 June 2023 has now been agreed.

The new funding envelope agreed from 1 July 2020 will enable the CCG funded

team to continue to operate from current delivery locations and therefore provide a citywide service including referrals from neighbouring GPs. The uplift in funding will enable additional detox sessions to be provided across the city and the exact locations of these will be determined prior to July. They may be within an existing GP surgery or a new location depending on the availability of practice space and the CCG target areas (e.g. areas of deprivation, areas with high hospital admissions due to alcohol etc).

The additional investment will support the ongoing targeting of services through GP surgeries which is in keeping with the ethos of the service on using community based - settings such as these to improve accessibility to drug and alcohol treatment services for a range of client groups. This particularly benefits those who wish to receive support closer to where they live or prefer a more anonymous setting and would not seek help directly from a Forward Leeds hub. Contract monitoring shows an increasing number of service users are accessing this part of the Forwards Leeds service and successfully completing their interventions with this team prior to leaving treatment or moving to other Forward Leeds services such as recovery support.

The analysis of client data show that many Forward Leeds service users have complex needs including mental health problems and homelessness and that the service works also with families, expectant mothers and people experience domestic violence. GPs often have regular contact with or are the first port of call for many of these protected / vulnerable groups making them ideally placed to engage people in support and treatment.

Key findings

Varying the contract with Humankind to include the additional CCG funding will ensure that all residents of Leeds including vulnerable client groups can continue to have access to substance misuse services through community-based settings across the city.

Work will continue by Forward Leeds, the Council and the CCG to ensure that GP practices are aware of this treatment pathway for their patients and are making referrals as appropriate to the GP based teams.
