The project is part of wider activity to undertake fire safety improvements to council owned high rise blocks in the city. Specific improvements will be the retrofitting of automatic sprinkler systems to make high rise blocks safer in the event of a fire.

The work will develop further an existing sprinkler programme with an additional sixteen blocks to have systems installed. This will make a difference to 1,515 dwellings.

One PFI block is planned to have systems installed in 2022/23 as part of the existing programme.

The total value of the planned works is approximately £9.6m; included in this total the value of the external contract for specialist works is £2.86m. Works will be delivered by Leeds Building Services, who plan to use their existing contractor Armstrong Priestley for the specialist elements of activity, procuring them via a call-off from the framework contract.

The works on the blocks will consist of:

- Sprinklers installed to communal areas
- Sprinklers installed to each dwelling
- Associated pipework, pumps, storage tanks and trunking / false ceiling in communal areas
- Installation of a webway to allow a direct link to Leedswatch and the fire service

5. Fact finding - what do we already know

The additional sixteen high rise blocks comprise of about 1,515 dwellings in total. They have been assessed as priority blocks.

Priority was recognised by using the below criteria to establish risk levels:

- Height, number of storeys
- Occupancy
- Number of flats
- Resident demographic (e.g. sheltered, vulnerable)
- Single staircase
- History of fires
- Anti-social behaviour
- Presence of gas
- Protection for fire and rescue personnel
- Refurbishment
- Underground car park / garages

Regular reviews of priority blocks are undertaken by the Corporate Fire Safety Manager.

Extensive resident consultation has taken place in all tower blocks post Grenfell and there is support from residents for the scope of work to be carried out.

Sprinklers will be installed in all dwellings, therefore this will be of benefit to all equality characteristics.

Resident profiling is ongoing for the delivery of the sprinkler programme.

Action required:

As part of normal business procedures local Ward Councillors, as well as residents, of blocks that are planned to receive sprinkler works will be consulted by housing and engaged with in advance of works being started on site. Once on site there will be a dedicated site team who will liaise with residents to ensure we achieve 100% access to flats.

By liaising with housing officers and residents we will be able to manage any access issues

e.g. respite, medical appointments and carers visiting times as well as working hours and be flexible when arranging appointments.

Consultation events are to take place on site and Ward Councillors and the Area Office are fully involved in this consultation process.

To help residents better understand planned works, and also see what the sprinklers will look like, mock-ups of the sprinkler systems will be placed in communal areas. From previous experience residents have found this beneficial as they could see first-hand the works that were to be installed and recognise the benefits of the programme. A dedicated site team will also be available to deal with resident queries and any issues that arise.

The site set-up allows for a void flat to be used as a drop in centre. Opening times will be reviewed and implemented accordingly to ensure that the needs of residents are being met as appropriate i.e. adjusting times in order to offer a range of services to residents.

The Planned Works Project Manager will effectively manage the contractor in line with the contract management plan to reduce the impact on residents during the installation phase.

By summer 2020 the council will have installed sprinklers in 37 high rise housing blocks in		
Leeds. This contract will enable the council to continue improving its housing stock, so that		
53 blocks in the city will have them fitted by March 2023.		
Leaseholder consultation processes have not been necessary as leaseholders who have		
flats in our high rise buildings are not charged for sprinkler retro-fitting works.
