SUBJECT: Proposal to Make a Prescribed Alteration at Harehills Primary School

EXECUTIVE SUMMARY

PURPOSE OF THIS REPORT

- The report informs the Executive Board of the outcome of statutory notices published on the proposal to make a prescribed alteration to permanently increase the admission number at Harehills Primary School from 60 to 90 Reception places.
- With the abolition of the Leeds School Organisation Committee on 25 May 2007, the Executive Board resolved at its meeting on 17 October 2007 that where no objections are received to school organisation proposals following statutory consultation, the executive Board would make the decision where they have a responsibility to do so.
- No objections having been received the Board are invited to determine the proposal.

BACKGROUND INFORMATION

- In response to an increase in demand for primary places in the Harehills area of Leeds, the admission number at Harehills Primary School was temporarily increased from 60 to 90 (3FE) for the academic years 2005-06 and 2006-07. The continued demand for places in this area led to a report being submitted to the Leeds Admissions Forum on 23 November 2006 outlining the need to increase primary provision at Harehills Primary School to 3 FE for a further two years, 2007 and 2008, the report and temporary increase being noted.
- On 14 March 2007 Executive Board agreed that a public consultation be undertaken on a proposal to permanently increase the admission limit at the school. On 11th September 2007 the outcome of that consultation was reported to the Board who agreed to the publication of a statutory notice.
- The shortfall of places is particularly acute within a fairly well-defined area bounded by Harehills Avenue, Harehills Lane, Ashley Road, Bayswater Road, and Sholebroke Street. This increase in demand also affects the nearby school, Bankside Primary. Bankside currently has an admission number of 70 and therefore, whilst not strictly 3 FE school, it operates as such and was identified

within the same Admissions Forum report with plans to also increase the admission number to 90.

Education Leeds believes this increase in demand in the area will continue and demand for places will be higher than the number of Reception places available in the area. Therefore it is considered that a permanent increase in provision at Harehills Primary School is necessary to meet the demand for places at the school.

MAIN ISSUES RAISED AS A RESULT OF THE STATUTORY NOTICES

A Statutory Notice was published on 18th April 2008 (copy attached) and expired on 16th May 2008. No representations were received, either supporting or objecting to the proposal. There are no new issues to report.

RESOURCE IMPLICATIONS

Additional accommodation will be required at the school. Plans are in place to provide additional temporary accommodation to meet the immediate demand for places. It will be necessary in time to provide permanent additional classrooms and infrastructure to support the increase in admission number. Investigations are also underway to explore the potential to expand the overall site area of the school.

1.0 PURPOSE OF THIS REPORT

- The report informs the Executive Board of the outcome of statutory notices

 1.1 published on the proposal to make a prescribed alteration to permanently increase the admission number at Harehills Primary School from 60 to 90 Reception places.
- 1.2 With the abolition of the Leeds School Organisation Committee on 25 May 2007, the Executive Board resolved at its meeting on 17 October 2007 that where no objections are received to school organisation proposals following statutory consultation, the executive Board would make the decision where they have a responsibility to do so.
- 1.3 No objections having been received the Board are invited to determine the proposal.

2.0 BACKGROUND INFORMATION

2.1 Harehills Primary School is situated in the Harehills / Gipton primary planning area. It is located a short distance away from Bankside Primary School (0.4 miles) which is part of the Chapel Allerton planning area. Given the close geographic proximity of these two planning areas in the inner NE wedge, linking the two provides a clearer picture of the overall area. These planning areas consist of a mix of community and voluntary aided schools, the majority of which are two form entry schools. The other schools in the two areas are Hovingham, Woodlands,

Oakwood, Wykebeck, Harehills St Augustine's and St Nicholas Catholic primary schools, and Bracken Edge, Hillcrest, Chapel Allerton, St Matthews Church of England and Holy Rosary and St Anne's Catholic primary schools. Information about their individual admission numbers and net capacities is available in Appendix 1, Table 1.

- 2.2 Pupil numbers are increasing in the area at a greater rate than other parts of the city and demand for school places is particularly high in the fairly well-defined area bounded by Harehills Avenue, Harehills Lane, Ashley Road, Bayswater Road, and Sholebroke Street. Information on the projected reception intakes and first preference data is in Appendix 1 Table 2. The four schools most likely to be affected are Hillcrest, Bankside, Harehills and Hovingham. Appendix 2 shows the projections for the four schools based on the 2008 PLASC figures. The distances between these schools are illustrated in Appendix 3. Demand for places at Harehills and Bankside Primary Schools has been particularly high.
- 2.3 The admission number for Bankside Primary School is currently 70 but the school has been operating as a 3FE school for a number of years and is already larger than two-form entry. The admission number at Harehills Primary School was temporarily increased from 60 to 90 reception places for the academic years 2005-06 and 2006-07. The continued demand for places in both schools led to a report being submitted to Admissions Forum on 23 November 2006 outlining the need to increase primary provision at Harehills and Bankside primary schools to 3 FE for a further two years, 2007 and 2008, the report and temporary increase being noted.
- 2.4 On 14 March 2007 Executive Board agreed that a public consultation be undertaken on a proposal to permanently increase the admission limit at the school. On 11th September 2007 the outcome of that consultation was reported to the Board. The responses were broadly supportive, and the main concerns noted in representations were:
 - It might increase the chances of local children being able to get into their local school
 - That class sizes should not be increased as a result
 - That staffing levels should be increased to maintain class sizes
 - The provision of additional accommodation and play space
 - The consideration of the option to create a new school
 - The potential impact on standards if class sizes were increased
 - The ability to get into the expanded school meaning children do not have to walk longer distances to the next nearest school
 - Whether further increases in capacity may be needed in future
- 2.5 Responses were provided in the report to the satisfaction of the Executive Board, who agreed to the publication of a statutory notice. A statutory notice was published on 18th April 2008 and expired on 16th May 2008. No representations were received.
- 2.6 Education Leeds believes this increase in demand in the area will continue and demand for places will be higher than the number of Reception places available in the two planning areas, and therefore a permanent increase in provision at Harehills Primary School and Bankside Primary School is needed. The addition of 20 reception places to permanently increase Bankside Primary School to a three-form entry does not require a statutory process. A formal consultation process to permanently increase provision to 90 reception places at Harehills Primary School has been conducted, and statutory notices published.

3.0 MAIN ISSUES

3.1 There were no representations received in response to the statutory notices. There are no new issues to report.

4.0 IMPLICATIONS FOR COUNCIL POLICY AND GOVERNANCE

4.1 Planning primary school places is relevant to a number of key priorities identified in the Children and Young People's Plan, the Asset Management Plan and the Corporate Plan, in terms of managing the supply and demand of school places and school improvement. It is also relevant to the Narrowing the Gap agenda, with the planning of school places taking consideration of wider socio-economic factors and regeneration.

5.0 **LEGAL AND RESOURCE IMPLICATIONS**

- 5.1 The review of primary provision fulfils the LA's statutory requirement to keep under review the supply and demand of school places.
- After full consideration of the views expressed during the consultation and now the Statutory Representation period, Education Leeds is of the view that this proposal should proceed. Since no representations have been received the proposal can be determined immediately by the Executive Board.
- Additional accommodation will be required at the school. Plans are in place to provide additional temporary accommodation to meet the immediate demand for places. However, it will be necessary to provide more permanent additional classrooms and infrastructure to support the increase in admission number. Investigations are also underway to exploring the potential to expand the overall site area of the school.

6.0 **RECOMMENDATIONS**

- 6.1 Executive Board is invited to:
 - i. Agree to proceed with the proposal to permanently increase the admission number for Harehills Primary School from 60 to 90 reception places with effect from September 2009.

Proposal to increase the Admission Number for Harehills Primary School

Notice is given in accordance with section 19(1) of the Education and Inspections Act 2006 that Leeds Local Authority intends to make a prescribed alteration to Harehills Primary School, Darfield Road Harehills Leeds LS8 5DQ from 01 September 2009.

It is proposed to increase the admission number from 60 to 90, and enlarge the premises to accommodate these numbers.

The current capacity of the school is 473 and the proposed capacity will be 630. The current number of pupils registered at the school is 500. The proposed admission number for the school at age 5 will be 90.

The school has been operating with a temporary admissions number of 90 since September 05. This proposal will make that change permanent.


