

# Equality, Diversity, Cohesion and Integration Screening

The extension for a further one year of a framework agreement (in 10 lots) for the Provision of Legal Services where by each of the WYLaw contracting authorities may call off legal services as required and subject to the budgetary position at the time of call off. This framework is not to outsource the specific categories of work in each lot, rather to make provision where there is not sufficient in house capacity.
