## 2. Please provide a brief description of what you are screening

The EV Trials scheme is a Highways England funded initiative which will allow organisations across West Yorkshire and private hire drivers licenced by Leeds City Council to trial a fully electric vehicle for either 1 or 2 months. The scheme aims to overcome any barriers organisations and drivers may have to switching to electric vehicles.

The EV Trials team need to insure a number of the electric vehicle fleet procured for the purpose of the scheme in order to make the scheme accessible for micro businesses and private hire drivers. Due to the tight timescales of the scheme and the inability for the ISP to provide the necessary insurance a waiver for the procurement of this has been completed. This screening is of this decision to waiver.
