Thank you for taking the time to send in your representations regarding the extension of the alcohol licence from 8am- 11pm to 6am-midnight for the premises,

Having given consideration to the application and listened to the representations from local residents we will revise the licensed hours applied for to 6am-11pm.

To put those who have made representations at ease, this application is not a request for extending delivery hours and I am sorry that we have had to make deliveries outside of the usual hours. However as you will appreciate, this was and is an unprecedented time and we appreciate your support to get the much needed products to our stores. Having said that, you will have found that deliveries are back to normal and have been so for a while. Also the panic buying at the start of this pandemic, which caused some of the delivery changes, has stopped.

Can I reassure you that the increase of licensed hours in the morning will not trigger an increase in the number of deliveries as alcohol is a part of the overall grocery delivery.

We want to provide the best support we can to the communities we serve. We have not come across the anti-social behaviour outside of our store, and although we share the car park with the pub, we will work with the community and local police to ensure this does not become a problem spot for anti-social behaviour. Any feedback that you are willing to give will be greatly appreciated and I would suggest that moving forward that any issues are raised with the Store Manager, or he is invited to future community meetings so that action can be taken if appropriate.
