

On the 13th November 2019, I attended an Action Plan meeting arranged by Samantha for Julie Jackson, the Designated Premises Supervisor (DPS), to attend and discuss matters in relation to both statutory nuisance and licencing objectives. In attendance were Julie Jackson.

The following points were agreed in relation to managing the noise at the premises:

- Signs will be placed at the exit remind patrons to have regard to nearby residents and neighbours
- During any busy periods (especially Wed & Sun eve) at the premises, there will
  be staff placed on the door when the bar closes to ensure patrons leave quietly
- A written noise policy will be put in place part of the policy will include making a
  note of any issues that arise (e.g. noise & ASB) including times, dates, area and
  if known by who
- An incident register shall be in place in order to report any incidents of antisocial behaviour including names, dates and times – all incidents of antisocial behaviour that shall be reported to the ASB Team

A follow up meeting was arranged for 21<sup>st</sup> November 2019 to ensure that all action points stated had been carried out. On the 21<sup>st</sup> November, I met Samantha, and Sarah Blenkhorn from West Yorkshire Police Licencing Team on site. However no-one attended from the New Middleton and the meeting had to be re-arranged. During my attendance on site at this particular time I noted there was an excessive amount of waste on the land, a large skip container was over flowing with waste. There was a car at the back that was a shell. At the side of the property there was further bits of waste, as well as lots of old cars.

On 24th November, the complainant stated 'Just a quick update on this week we have had noise and disturbance again from the New Middleton this week, there was noise beyond midnight on Thursday evening with gathering outside the front doors, Friday night was the same but not sure whether you are aware but ambulances were called, police were present and had to actually close and tape the pub off which resulted in disturbance again until 2am in the morning and again last night noise, shouting outside the doors and didn't close until 12:50am.

Things do not appear to be changing at all.'

On the 29th November 2019 I reported my findings to the Cleaner Neighbourhoods Team in relation to waste on the land of The New Middleton.

Further updates from the complainant were received on the 29th November regarding patrons staying late on Wednesday 27th November, shouting and swearing outside the front doors and not leaving until after 1am.

On the 14<sup>th</sup> December, I received an email stating that the pub was open on Thursday the 12<sup>th</sup> December until 1.30am, and on Friday the 13<sup>th</sup> December they shut the doors at 3.30am. The complainant goes on to say that there were shouting and swearing on both days and on the Friday people were hanging about outside the doors until after 3am.

Further correspondence were received regarding the 18th and 20th December 'Friday 20th it was after 2am before it shut and on Wednesday 18th there was arguing and shouting outside and they were open until after 3am'
