1. Purpose of this report

1.1 To seek approval for Elected Member appointments to be made to a new outside body – the Morley Town Deal Board.

2. Background information

- 2.1 On 18th March 2020, the <u>Executive Board</u> considered a report regarding the governance arrangements around the formation of a 'Town Deal Board' for Morley, which is required to support the development of a Town Investment Plan and a bid for up to £25 m of funding from government to support regeneration and economic development there.
- 2.2 The Executive Board report anticipated that the Morley Town Deal Board (MTD Board) will be considered a **Strategic and Key Partnership** participation contributes to the Council's strategic functions, priorities and community leadership role.
- 2.3 The local authority has received a request to commence the process of securing <u>three</u> Member appointments to the Morley Town Deal Board (MTD Board) as a matter of urgency in order to progress the funding bid. The three appointments sought are in line with the MTD Board draft Terms of Reference and are proposed to be reserved to the Executive Member for Climate Change, Transport and Sustainable Development and one ward Member from each of the Morley North and South wards, which are the two wards covered by the Town Deal programme.
- 2.4 In accordance with the Appointments to Outside Bodies Procedure Rule (4.5) the City Solicitor has delegated authority to make an appointment where an organisation requires an appointment prior to the next meeting of the Member Management Committee, subject to this appointment being agreed by all Group Whips or their nominee.
- 2.5 The City Solicitor has sub delegated that authority to the Head of Democratic Services.
- 2.6 Any instances of this delegation being used are reported to the next meeting of the Member Management Committee.

3. Main issues

- 3.1 The Group Whips have been consulted on this matter, and confirmed the following proposals:
 - a) To accept the designation of Morley Town Deal Board as a Strategic and Key partnership as set out in the Outside Body Procedure Rules
 - b) To note the proposals for the three appointments to be reserved to the Executive Member for Climate Change, Transport and Sustainable Development and one ward Member from each of the Morley North and South wards; and

- c) To note the proposals for the following Councillor appointments
 - The relevant Executive Member, which is currently the Executive Member for Climate Change, Transport and Sustainable Development
 - Councillor A Hutchison (Morley North)
 - Councillor W Kidger (Morley South)
- d) To note the designation of and appointments to the Morley Town Deal Board will be reported to the next meeting of the Member Management Committee.
- 3.2 The appointments are required prior to the next meeting of the Member Management Committee. The Head of Democratic Services is requested to authorise the appointments as set out in paragraph 3.1 c) above.

4. Corporate considerations

4.1.1 In accordance with Outside Body Procedure Rules 4.5 iii Group Whips have been consulted on the proposed arrangements and are supportive of them. The Members affected will be advised of these changes by the relevant Group Offices.
